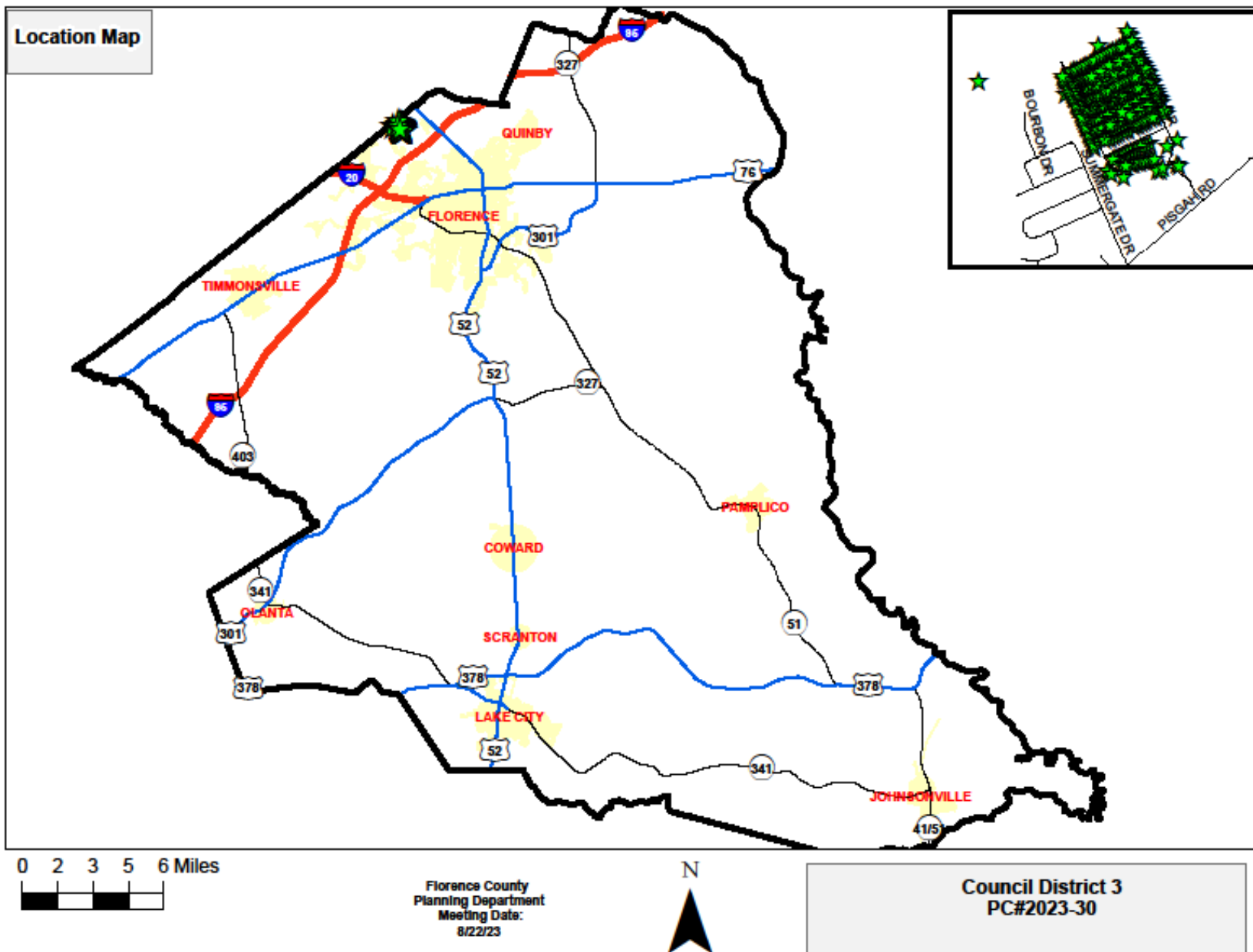

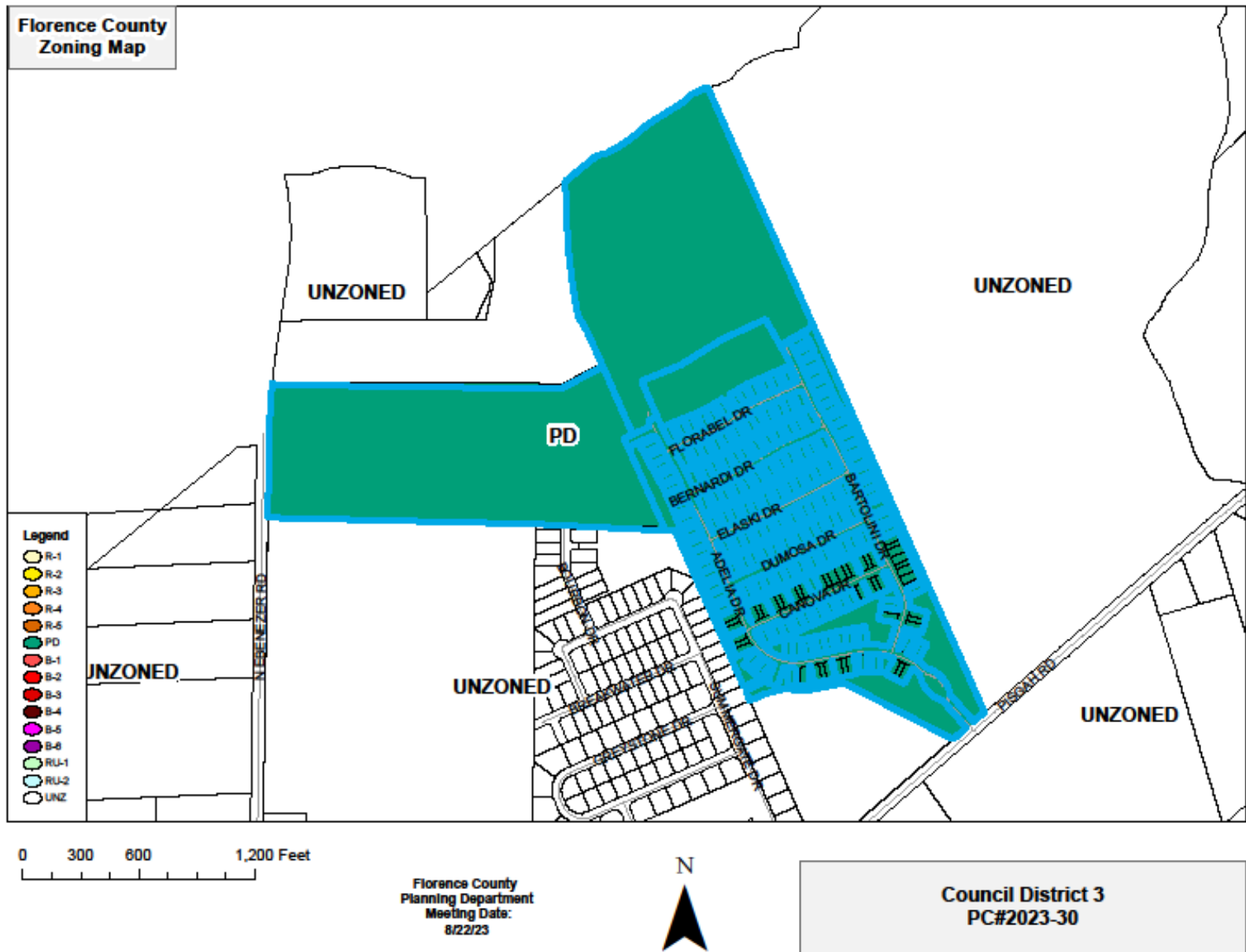

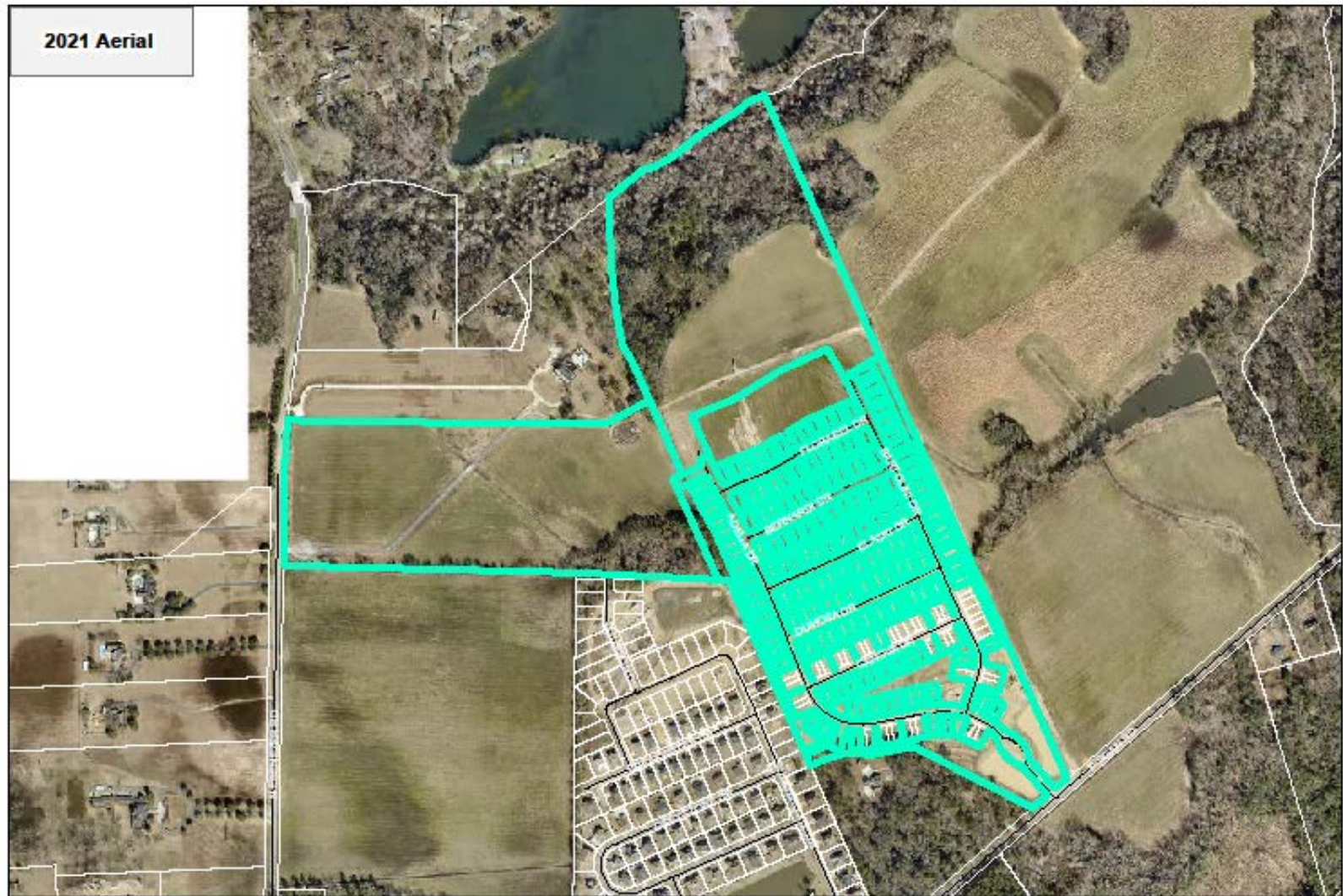
PC#2023-30 Location Map

Changes made to the Chandler Reserve PD-18-2 Plan:

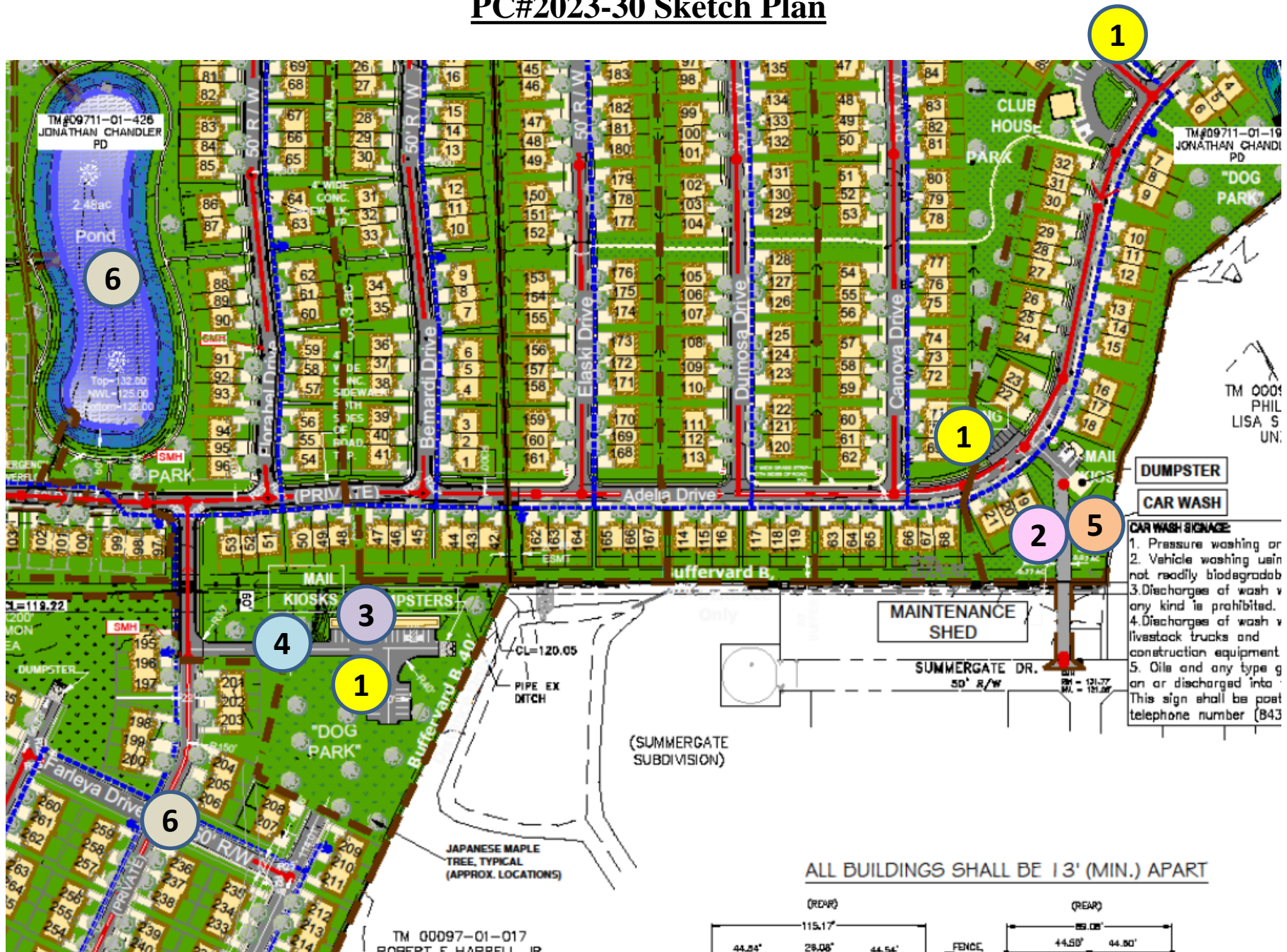
- Additional Parking: \pm 57 spaces presently shown on PD-18-2 plan dated July, 2023 with a maximum of 80 spaces
