While in the decade since the last edition of this book was published there were few substantive revisions made to federal consumer bankruptcy law, there have been significant changes to the federal procedural rules and forms as well as to certain provisions under New York law applicable to consumer bankruptcy cases. A substantial number of these revisions were likely prompted by the Great Recession and the resultant mortgage foreclosure crisis, among other factors.

In writing this edition, I want to acknowledge the assistance of the Publications Department at the New York State Bar Association. The staff there provided helpful guidance and encouragement over the course of this edition's preparation.

Susan Jensen has authored law review articles and contributed to various treatises on bankruptcy law and practice.
