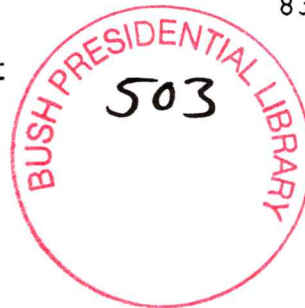

The President: Thank you. Now I will finish this job and head back to Texas on January 20. (S)
