SCHEDULE PROPOSAL

TO: JOSEPH W. HAGIN, II, Deputy Assistant to the President for Appointments and Scheduling

FROM: BRENT SCOWCROFT *BS*

REQUEST: Meeting with Shimon Peres, Israeli Deputy Prime Minister and Minister of Finance.

PURPOSE: To discuss the peace process and Israeli political issues.

BACKGROUND: Peres, who hosted the President during his last visit to Israel, is the leader of the Labor Party and the second-ranking member of Israel's coalition government. Although his Finance Ministry portfolio does not afford Peres the opportunity to play a leading role in the peace process, he has been supportive of the more flexible policy line on elections advocated by his Labor colleague Rabin. Peres would himself probably favor moving more quickly and dramatically in the peace process, but his political fortunes have waned ever since his failure in the spring of 1987 to break the coalition government over the international conference proposal. Peres will probably remain as Labor Party leader for the foreseeable future, particularly if as Finance Minister he can achieve some economic advances for Israel.

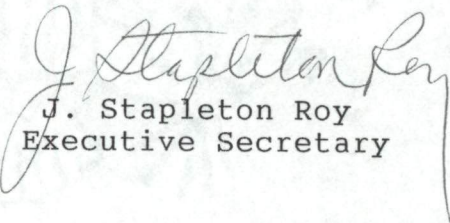
