Mr. President:

With the fledgling Middle East peace process barely begun, Israel has been continually violating the skies and the territorial integrity of Lebanon; bombing innocent civilians, destroying homes and decimating public facilities.

Lebanon is a small country with very limited military power, and is totally incapable of defending itself from Israel's bombs.

The United States needs to bring pressure to bear on Israel to stop these violations. More than ever, Lebanon needs a tranquil period to facilitate rehabilitation and reconstruction. This can only be accomplished with U. S. intervention.

Israel has to be stopped. It is widely known that the United States and you in particular, Mr. President, are the only forces Israel fears and respects enough to cease and desist. We urge you to utilize your power to bring peace once again to Lebanon and the entire Middle East.
