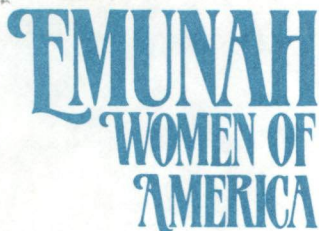

Thank you very much for your appearance before the Orthodox Coalition on behalf of EMUNAH Women of America, one of the constituent organizations. We valued your statements and your answers to specific questions.

We want to take cognizance of your position that the Administration will recognize the major imbalance that exists between the military arms weapons systems, planes and tanks of all the Arab countries and Israel.

The news that Russia has surprised America by selling Libya and Syria advanced bombers is most threatening. Israel will, of course, be affected by all that this implies.

We await the Administration's sincere endeavor to make sure that Israel retains her edge against all Arab countries and their weapons systems.
