Dear John:

I take pleasure in inviting you to participate in the White House briefing session of Agudath Israel of America's National Leadership Mission to Washington, scheduled for Thursday afternoon, September 14, 1989.

Agudath Israel of America, the broadest based Orthodox Jewish grassroots coalition movement in the country, has for the past 67 years developed an extensive record of activity in the full range of concerns affecting the Jewish people. Our performance on the domestic and international scenes is well known to officials of the Bush Administration, as well as in the halls of Congress.

Agudath Israel was the only Jewish organization to take a pro-life position in an amicus brief before the Supreme Court in the recent Webster case --- reflecting the fact that we have served at the national level as the primary Jewish advocates of the family issues and values which are such an important part of the Bush Administration's policies.

Prior Agudath Israel Washington Leadership Missions have been addressed by several members of the President's Cabinet and other top personalities of the executive and legislative branches of our government. At our most recent Mission, three years ago, the White House session featured briefings by the Vice President (a gentleman by the name of Bush, if I recall) and three prominent members of the Cabinet. The format is a brief presentation by the speaker, followed by a 20-minute question and answer period.

I respectfully urge you to accept this invitation to meet with our national leadership, some 200 men and women from across the nation who are opinion-makers in their local communities. They will enjoy such a dialogue; and you too, I am confident, will enjoy being with a group that shares your basic goals.

I look forward with anticipation to your kind reply. All good wishes.
