Dear Governor Sununu:

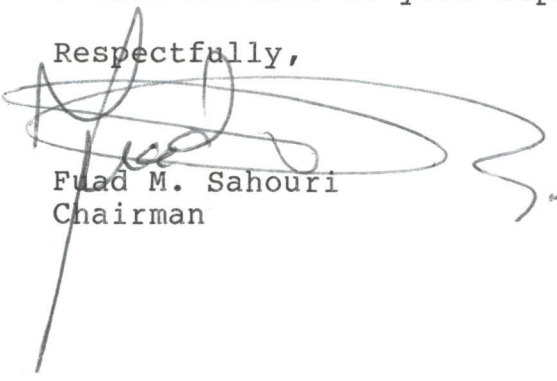
