SUBJECT: Letters to House Leadership and Appropriations
Committee on Egypt's FMS Debt

Purpose

To urge the House Leadership and Appropriations Committee members to support cancellation of Egypt's FMS debt.

Background

The Egypt FMS debt cancellation initiative will face Appropriations Committee mark-up Tuesday, September 25. A push from you could help, particularly if directed to both the full Committee membership and the House leadership. We have prepared letters (Tab A), stressing the importance of cancelling Egypt's FMS debt to Mubarak and to our Gulf policy generally. The State Department has cleared these letters.
