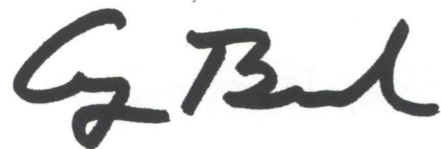

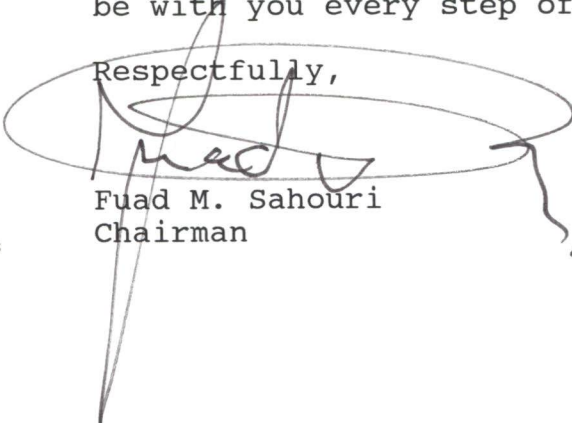
Dear President Bush:

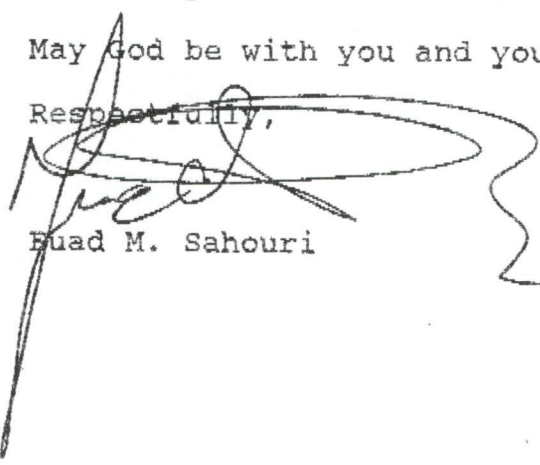
Dear President Bush:
