**Subject:** White House Young Person's Programs

---

The White House is a perfect setting to introduce American children to the performing arts. By using the prestige of the Presidency and the medium of national television, you can invite some of America's most respected performers to introduce their art forms to children in an informal, informational, and entertaining manner.

While the White House has been used frequently over the years for prestigious concerts, it has never been used to familiarize children about the rich tradition and diversity of this country's performing arts. For this administration to have the first televised White House event to focus on children and the arts would send an important symbolic message. To invite a wonderfully diverse group of children from Washington neighborhoods into the East Room to hear an artist like Maya Angelou, Isaac Stern, Yo Yo Ma, Van Cliburn, Kathleen Battle, or Wynton Marsalis talk informally about his or her art could be fascinating and highly educational. Not since Leonard Bernstein introduced a generation of children, and also many adults, to music, has there been anything that might equal the potential of this White House series of programs.

I would suggest that one pilot program be produced with three more programs anticipated, but not announced. If the first event is highly successful, the others could quite easily be produced along the same format.

If this idea makes sense, I would be willing to research the pros and cons of the various ways these White House Young Person's Programs could be produced. You can be in touch with me at either (303) 295-8882, office, or (303)355-9053, home.

These events and their television distribution would not require the expenditure of federal funds. Programs would be underwritten by corporations and distributed through public television.
