1. ON JANUARY 14, THE PRESIDENT SIGNED A PRESIDENTIAL DETERMINATION WAIVING THE RESTRICTIONS ON AID TO JORDAN CONTAINED IN THE FY 94 FOREIGN OPERATIONS EXPORT FINANCING AND RELATED PROGRAMS APPROPRIATIONS ACT. (SIGNED COPY WILL BE FAXED TO POST.) THIS WAIVER PERMITS IMMINENT RELEASE OF ALL FY 94 SECURITY ASSISTANCE FOR JORDAN, SPECIFICALLY:

- USD 9 MILLION IN ECONOMIC SUPPORT FUNDS,
- USD 9 MILLION IN FOREIGN MILITARY FINANCING
- USD 800,000 IN INTERNATIONAL MILITARY EDUCATION AND TRAINING FUNDS,
- UP TO 7.2 MILLION IN OTHER CENTRALLY FUNDED PROGRAMS.

SUCH AS THE MIDDLE EAST REGIONAL COOPERATION PROGRAM AND THE MULTILATERAL PEACE PROCESS. WHILE THE WAIVER PERMITS THE USG TO SPEND A MAXIMUM OF USD 26 MILLION, ONLY THE BILATERAL ASSISTANCE (USD 18.8 MILLION) IS LIKELY TO BE FUNDED IMMEDIATELY.

2. FORMAL RELEASE OF THE ESF, FMF AND IMET CANNOT OCCUR UNTIL EXPIRATION OF THE ROUTINE (15-DAY) CONGRESSIONAL NOTIFICATION (CN), WHICH AID AND DOD WILL INITIATE AS SOON AS POSSIBLE. (ALTHOUGH NOT REQUIRED IN PREVIOUS YEARS, FY 94'S FOAA MANDATES 15 DAY NOTIFICATIONS FOR FMF AND IMET.) THIS WILL COMPLETE THE PROCESS FOR RELEASE OF FY 94 FUNDS WHICH PRESIDENT CLINTON INITIATED WITH HIS DECEMBER LETTER TO KING HUSSEIN. CHARGE MAY INFORM THE GOJ AS APPROPRIATE. CHRISTOPHER

- b(8) Release would disclose information concerning the regulation of financial institutions [(b)(8) of the FOIA]
- b(9) Release would disclose geological or geophysical information concerning wells [(b)(9) of the FOIA]
