SUBJECT: CONCERNS OF AMERICAN REGIONAL OFFICES
OPERATING IN JORDAN
1. SUMMARY. AMERICAN COMPANIES WITH REGIONAL
OFFICES IN JORDAN FACE PROBLEMS WITH TAXES, CUSTOMS
CLEARANCE, TELEPHONE AND FAX SERVICES. THESE
PROBLEMS STEM FROM A GENERAL MISTRUST BETWEEN
GOVERNMENT AGENCIES, AND BETWEEN THE GOVERNMENT AND
PRIVATE BUSINESS. WE HAVE DISCUSSED THE POSSIBILITY
OF FORMING AN AMERICAN CHAMBER OF COMMERCE IN AMMAN
TO GIVE THE COMPANIES A UNITED VOICE FOR THEIR
CONCERNS. END SUMMARY.
2. ON MARCH 7, THE EMBASSY COMMERCIAL SECTION
HOSTED A MEETING FOR THE REPRESENTATIVES OF AMERICAN
COMPANIES WITH REGIONAL OFFICES IN AMMAN. TWENTY-
FIVE TO THIRTY REPRESENTATIVES FROM SUCH DIVERSE
FIRMS AS PEPSICO, WESTINGHOUSE, AND UNITED AIRLINES
ATTENDED. THE PURPOSE OF THE MEETING WAS TO LEARN
THE PROBLEMS AND CONCERNS OF THOSE OPERATING
REGIONAL OFFICES IN JORDAN, AND TO SEEK WAYS OF
HELPING THEM OVERCOME THESE PROBLEMS. THE FIRMS
LEARNED THAT THEY HAVE MANY COMMON PROBLEMS
REGARDLESS OF THE INDUSTRIES THEY REPRESENT.
3. JORDAN'S CENTRAL GEOGRAPHIC LOCATION AND
RELATIVELY STABLE POLITICAL ENVIRONMENT MAKE JORDAN
ATTRACTIVE TO U.S. FIRMS. JORDANIAN LAWS AND
REGULATIONS ALSO OFFER INCENTIVES TO ATTRACT

REGIONAL OFFICES. REGIONAL OFFICES ARE PROHIBITED FROM CONDUCTING DIRECT BUSINESS IN JORDAN, BUT THEY ARE EXEMPT FROM PAYING CORPORATE TAXES. THEY ARE PERMITTED TO IMPORT OFFICE EQUIPMENT FOR THEIR OWN USE, AND AUTOMOBILES FOR THE USE OF THEIR FOREIGN REPRESENTATIVES DUTY FREE. THESE ARE NO SMALL INCENTIVES, AS THE DUTIES ON THESE ITEMS CAN REACH OVER 300 PERCENT.

4. THE REGIONAL REPRESENTATIVES INFORMED US THAT, ALTHOUGH THE LAWS ARE GENERALLY FAVORABLE TO THEIR BUSINESS, THE PROBLEMS THEY HAVE ENCOUNTERED IN JORDAN COME FROM THE IMPLEMENTATION OF THOSE LAWS. VIRTUALLY EVERY REPRESENTATIVE PRESENT HAD A HORROR STORY TO TELL ABOUT CLEARING CUSTOMS FOR OFFICE EQUIPMENT OR AUTOMOBILES THAT WERE ALREADY APPROVED FOR DUTY FREE IMPORTATION. THE PROBLEM STEMS FROM THE FACT THAT THE MINISTRY OF INDUSTRY AND TRADE (MIT) GRANTS THE APPROVALS, BUT THE CUSTOMS DEPARTMENT IN THE FINANCE MINISTRY ACTUALLY CLEARS THE ITEMS. THE CUSTOMS INSPECTORS REGULARLY DISREGARD THE MIT APPROVALS AND IMPOSE DUTIES ON THE GOODS. FIGHTING THE CUSTOMS DECISION CAN BE AN EXERCISE IN FRUSTRATION. THE PEPSICO REPRESENTATIVE STATED THAT IT ONCE TOOK NINE MONTHS TO GET A DUTY FREE AUTOMOBILE CLEARED THROUGH CUSTOMS. ANOTHER REPRESENTATIVE STATED THAT THEY USUALLY PAY THE CUSTOMS DUTY ON THEIR "DUTY-FREE" ITEMS BECAUSE IT IS CHEAPER IN THE LONG RUN THAN FIGHTING THE CUSTOMS INSPECTOR'S DECISION.

5. MORE THAN ONE REPRESENTATIVE STATED THAT, ALTHOUGH THE REGIONALS ARE EXEMPTED FROM THE CORPORATE INCOME TAX, THE TAX DEPARTMENT OFTEN SCRUTINIZES EACH TRANSACTION OF THE OFFICES, AND SEEKS TO IMPOSE TAXES ON AN AD HOC BASIS.

6. ANOTHER COMMON PROBLEM CAME IN SECURING TELEPHONE AND FAX LINES FOR THE REGIONAL OFFICES. THE PEPSICO REPRESENTATIVE STATED THAT THEY HAD REQUESTED SIX TELEPHONE LINES, BUT ONLY RECEIVED ONE. ALTHOUGH THERE IS NO LAW LIMITING THE NUMBER OF PHONE LINES, THE TELECOMMUNICATIONS CORPORATION (TCC) SIMPLY TOLD THEM THEY ONLY NEEDED ONE LINE. THERE IS AN ACKNOWLEDGED SHORTAGE OF TELEPHONE LINES IN WEST AMMAN, BUT MANY OTHER REPRESENTATIVES ECHOED THAT THE IMPERIOUS ATTITUDE OF THE TCC WAS COMMON AMONG GOVERNMENT BUREAUCRATS.

7. WE SUGGESTED THAT SINCE THE REPRESENTATIVES HAD COMMON CONCERNS AND PROBLEMS, THEY SHOULD CONSIDER FORMING A CHAMBER OF COMMERCE OR SIMILAR GROUP TO UNITE THEIR SEPARATE VOICES AND INCREASE THEIR

INFLUENCE WITH THE GOVERNMENT. WE OFFERED TO HELP FACILITATE THE FORMING OF THE GROUP. THE REGIONALS ENTHUSIASTICALLY RESPONDED TO THE SUGGESTION AND PLEDGED TO GET THE WORD OUT TO OTHER REGIONAL REPRESENTATIVES WHO WERE NOT PRESENT. WE WILL BE
