SUMMARY

1. THE SIGNING OF THE DECLARATION OF PRINCIPLES (DOP) BETWEEN THE PLO AND THE ISRAELI GOVERNMENT ON SEPTEMBER 13, 1993 LED MANY OF JORDAN'S PALESTINIAN REFUGEES TO THE OVERLY OPTIMISTIC CONCLUSION THAT THEIR REFUGEE STATUS MIGHT SOON BE RESOLVED. THE SLOW PACE OF NEGOTIATIONS AND THE GRADUAL REALIZATION THAT 1948 REFUGEE ISSUES WILL NOT BE DEALT WITH FOR FIVE YEARS UNDER THE TERMS OF THE DOP HAS ERODED THAT OPTIMISM. JORDAN CONTINUES TO STRUGGLE TO INTEGRATE THE WAVE OF MOSTLY PALESTINIAN RETURNEES FROM THE GULF STATES THE MAJORITY OF WHOM ARRIVED BETWEEN 1990 AND 1992. THE ESTIMATED INCREASE OF 200,000 TO 300,000 PEOPLE HAS STRAINED JORDAN'S INFRASTRUCTURE, ESPECIALLY IN AND AROUND THE CAPITAL OF AMMAN. TENSIONS HAVE INCREASED BETWEEN THE NATIVE EAST BANK AND PALESTINIAN POPULATIONS AS BOTH GROUPS STRUGGLE TO COPE WITH THE NEW PROBLEMS CONFRONTING THEM AS A RESULT OF WORSENING ECONOMIC CONDITIONS AND UNCERTAINTIES CREATED BY THE DOP.

2. IRAQIS COMPRISE THE ONLY OTHER SIGNIFICANT REFUGEE POPULATION IN JORDAN. OVER THE PAST YEAR, THE JORDANIAN GOVERNMENT HAS BEGUN TO ENFORCE ITS RESIDENCE LAW MORE STRICTLY, DEPORTING THOSE WHO CANNOT PROVE THAT THEY HAVE WORK AND THREATENING LEGAL ACTION AGAINST LANDLORDS WHO HOUSE ILLEGAL ALIENS. THE GOVERNMENT'S ACTIONS HAVE REDUCED THE NUMBER OF IRAQIS LEGALLY RESIDENT IN JORDAN TO

BETWEEN 2,000 AND 3,000, ALTHOUGH THE TRANSIENT POPULATION WOULD PROBABLY DOUBLE THE FIGURE. ACCORDING TO AMNESTY INTERNATIONAL, THERE WERE THREE CASES OF FORCED REPATRIATION IN 1993, ALL INVOLVING PERSONS OF SUDANESE ORIGIN. END SUMMARY.

SIGNIFICANT INCIDENTS INVOLVING JORDAN'S
REFUGEE POPULATION

3. THE SIGNING OF THE DECLARATION OF PRINCIPLES (DOP) BETWEEN THE PLO AND THE ISRAELI GOVERNMENT ON SEPTEMBER 13, 1993 LED MANY OF JORDAN'S PALESTINIAN REFUGEES TO THE OVERLY OPTIMISTIC CONCLUSION THAT THEIR REFUGEE STATUS MIGHT SOON BE RESOLVED. UNITED NATIONS RELIEF WORKS AGENCY (UNRWA) OFFICIALS NOTED A DRAMATIC INCREASE IN THE NUMBER OF PREVIOUSLY UNREGISTERED REFUGEES APPLYING FOR UNRWA IDENTITY CARDS IN THE MISTAKEN BELIEF THAT SUCH CARDS WOULD BE USED AS PROOF OF ONE'S ELIGIBILITY TO RETURN TO THE OCCUPIED TERRITORIES OR TO MONETARY COMPENSATION UNDER UN GENERAL ASSEMBLY RESOLUTION 194. THE NUMBER OF REFUGEES REGISTERED WITH UNRWA REACHED CONSEQUENTLY 1.2 MILLION. SUCH OPTIMISM HAS BEEN ERODED BY THE SLOW PACE OF NEGOTIATIONS BETWEEN THE PLO AND ISRAEL AND THE GRADUAL REALIZATION THAT, ACCORDING TO THE TERMS OF THE DOP, THE STATUS OF 1948 REFUGEES WOULD NOT BE ADDRESSED FOR FIVE YEARS.

4. JORDAN CONTINUES TO STRUGGLE TO INTEGRATE THE 1990-92 WAVE OF RETURNEES FROM THE GULF STATES INTO THE JORDANIAN ECONOMY AND SOCIETY. ALTHOUGH NO AUTHORITATIVE FIGURES EXIST ON THE RETURNEE POPULATION, IT IS FREQUENTLY ESTIMATED BY THE GOVERNMENT AND UNRWA OFFICIALS TO BE AROUND 300,000. THE RAPID INCREASE IN POPULATION HAS STRAINED JORDAN'S INFRASTRUCTURE, ESPECIALLY IN AND AROUND THE CAPITAL. REAL ESTATE AND RENTAL COSTS IN AMMAN HAVE RISEN WHILE THE CITY'S TRANSPORTATION, TELECOMMUNICATIONS, EDUCATION, HEALTH CARE, SEWAGE, AND WATER SERVICES HAVE BEEN SEVERELY OVERBURDENED. THE INFUSION OF INVESTMENT CAPITAL FROM THE RETURNEES WAS INSTRUMENTAL UNTIL 1993 IN JORDAN'S IMPROVED ECONOMIC PERFORMANCE, DESPITE THE SUDDEN INFUX. BY LATE 1993, THE ECONOMIC BENEFIT THAT ACCOMPANIED RETURNEES HAD LARGELY RUN ITS COURSE AND JORDAN REVERTED TO STAGNANT GROWTH. RETURNEES, PREDOMINANTLY WELL-EDUCATED PALESTINIANS, OFTEN COMPLAIN OF UNEMPLOYMENT OR UNDEREMPLOYMENT.

5. TENSIONS HAVE INCREASED BETWEEN THE NATIVE EAST BANK AND PALESTINIAN POPULATIONS AS BOTH GROUPS STRUGGLE TO COPE WITH THE NEW PROBLEMS CONFRONTING THEM IN THE WAKE OF ECONOMIC DOWNTURN AND THE UNCERTAINTIES CREATED BY THE DOP. WHO WILL ULTIMATELY RETAIN JORDANIAN CITIZENSHIP, WHETHER UNCLAS SECTION 02 OF 03 AMMAN 003891

JORDAN'S IRAQI REFUGEE POPULATION

6. IRAQIS COMPRISE THE OTHER SIGNIFICANT REFUGEE
POPULATION IN JORDAN. IRAQIS NEED NO SPECIAL
PERMISSION TO ENTER JORDAN AND ARE PERMITTED TO STAY
AS TOURISTS FOR UP TO ONE MONTH AND TO EXTEND THEIR
STAY FOR AN ADDITIONAL MONTH. MOST IRAQIS CURRENTLY
ENTERING JORDAN ARE FLEEING POOR ECONOMIC CONDITIONS
IN IRAQ AND ARE NOT ENTITLED TO STAY IN JORDAN. THE
UNHCR RECOGNIZES ONLY SIX PERCENT OF IRAQI
APPLICANTS AS LEGITIMATE ASYLEES. IN 1993, ONLY 62
IRAQIS WERE GRANTED REFUGEE STATUS OF THE 968 WHO
APPLIED.

7. OVER THE PAST YEAR, THE JORDANIAN GOVERNMENT HAS
BEGUN TO ENFORCE ITS RESIDENCE LAW MORE STRICTLY,
DEPORTING THOSE WHO CANNOT PROVE THAT THEY ARE
WORKING AND THREATENING LEGAL ACTION AGAINST
LANDLORDS WHO HOUSE ILLEGAL ALIENS. AUTHORITIES
HAVE ALSO MADE AT LEAST ONE "SWEEP" OF THE DOWNTOWN
AREA LOOKING FOR ILLEGAL IRAQIS WORKING AS SIDEWALK
VENDORS. THUS, THE NUMBER OF IRAQI NATIONALS LIVING
IN JORDAN HAS DROPPED SIGNIFICANTLY IN THE PAST
YEAR. ACCORDING TO JORDANIAN GOVERNMENT OFFICIALS,
AT THE BEGINNING OF 1993, 17,000 IRAQI NATIONALS
LIVED IN AMMAN. THE GOVERNMENT'S STRICT ENFORCEMENT
OF RESIDENCE LAWS HAS REDUCED THE NUMBER TO BETWEEN
2,000 AND 3,000, ALTHOUGH THE TRANSIENT POPULATION
WOULD PROBABLY DOUBLE THE FIGURE. THOSE WHO HAVE
RESETTLED ELSEWHERE HAVE MOSTLY GONE TO SCANDINAVIAN
COUNTRIES.

8. IN THE SUMMER OF 1993, 400 BOSNIANS WHO HAD BEEN
HELD IN CROATIAN DETENTION CAMPS APPLIED FOR REFUGEE
STATUS IN JORDAN. THE HASHEMITE CHARITY
ORGANIZATION, A GROUP WITH LINKS TO THE ROYAL FAMILY
BUT ADMINISTERED BY THE MINISTRY OF AQAWF AND
RELIGIOUS AFFAIRS, SPONSORED THE BOSNIANS AND
EVENTUALLY 388 WERE GIVEN REFUGEE STATUS IN JORDAN.
ABOUT 100 OF THESE VOLUNTARILY LEFT FOR TURKEY LATER
IN 1993.

9. BECAUSE OF VIOLENCE IN THE REGION OR ELSEWHERE
IN THE WORLD, JORDAN ALSO ACCEPTED A STATISTICALLY
INSIGNIFICANT NUMBER OF REFUGEES FROM THE FOLLOWING
COUNTRIES: SYRIA (1), SUDAN (5), KUWAIT (9), SRI
LANKA (1), ETHIOPIA (5), ZAIRE (1), SAUDI ARABIA
(1), SOMALIA (9), AND IRAN (6).

10. ACCORDING TO AMNESTY INTERNATIONAL, THERE WERE
THREE REPORTED CASES OF FORCED REPATRIATION IN 1993.
THREE SUDANESE NATIONALS LIVING IN JORDAN WERE

FORCIBLY RETURNED TO SUDAN AFTER TWO OF THEM ILLEGALLY CROSSED OVER TO THE WEST BANK. IN ADDITION, ONE PALESTINIAN WITH A JORDANIAN PASSPORT WAS TURNED OVER TO ISRAELI AUTHORITIES AFTER BEING ARRESTED IN JORDAN. HE IS CURRENTLY BEING TRIED IN ISRAEL FOR ALLEGEDLY PARTICIPATING IN BOMB ATTACKS THERE.

11. IN A SENSE, A NATION OF REFUGEES (FROM THE 1948 AND 1967 ARAB ISRAELI WARS), JORDAN BALANCES A TRADITIONAL COMMITMENT TO HUMANITARIAN EFFORTS WITH A SENSE OF POLITICAL PRAGMATISM. WHILE NOT OFFICIALLY ENCOURAGED, THE PRESENCE OF RECOGNIZED REFUGEES AND ILLEGAL ALIENS IS GENERALLY TOLERATED BY THE GOVERNMENT AND BY THE PUBLIC AT LARGE WITHIN LIMITS CONSISTENT WITH SECURITY CONCERNS. SUCH CONCERNS WILL ALLOW SELECTIVE ADMISSION OF REFUGEES AND ASYLUM SEEKERS ON A CASE-BY-CASE BASIS, BUT NOT WHOLESALE MIGRATIONS SIMILAR TO THOSE OF 1948, 1967, AND 1990.
