1. AMEMBASSY AMMAN IS WAITING FOR THE FINAL SUBMISSION OF DETAILS BY THE JORDAN SOCIETY FOR THE PROTECTION OF NATURE REGARDING ITS PROPOSED OES PROJECT. THE PROJECT WOULD DELINEATE THE BOUNDARIES OF THE AQABA MARINE PARK, A CONCEPT THAT HAS BEEN STUDIED AND SUPPORTED IN THE PAST BY USG FUNDS, AMONG OTHERS. THIS PROJECT WOULD BE A ONE-TIME REQUEST, AS IT WOULD ENTAIL PURCHASING AND INSTALLING BUOYS MARKING THE BOUNDARIES OF THE MARINE PARK.
2. THE EMBASSY WILL NOT BE ABLE TO SEND THE PROJECT PROPOSAL TO THE DEPARTMENT BY THE DUE DATE OF APRIL 30 DUE TO SEVERAL FACTORS, INCLUDING THE DEATHS OF FORMER PRESIDENT NIXON AND THE MOTHER OF KING HUSSEIN - WHICH WILL SHUT DOWN THE EMBASSY, AND A DELAY IN OBTAINING DETAILS REGARDING COSTS INVOLVED IN THE PROPOSED PROJECT.
3. EMBASSY AMMAN REQUESTS THAT OES RESERVE A SLOT FOR THIS PROJECT PROPOSAL, BELIEVING IT TO FULFILL SEVERAL OF THE CRITERIA FOR CONSIDERATION IN REFTEL, INCLUDING ENVIRONMENTAL, BIODIVERSITY, SUSTAINABLE ECONOMIC DEVELOPMENT, REGIONAL PEACE EFFORTS, AND OCEANS. THIS PROPOSAL WILL HAVE A POSITIVE ENVIRONMENTAL IMPACT ON BIODIVERSITY THROUGH PROTECTION OF THE CORAL REEF AND FISH IN THE GULF OF AQABA, AND WILL ENCOURAGE SUSTAINABLE ECONOMIC DEVELOPMENT OF TOURISM IN THE AQABA GULF REGION, A FACTOR WHICH WILL ALSO PREPARE THE AREA FOR A SURGE IN TOURISM FOLLOWING A POSSIBLE REGIONAL MIDDLE EAST PEACE SETTLEMENT. THE AQABA GULF HAS BEEN THE FOCUS OF EFFORTS TO PROMOTE COOPERATION IN THE REGION.
