1. THE PROPOSAL FOR THE OES SPECIAL FUND PROJECT FROM JORDAN HAS BEEN SUBMITTED BY THE ROYAL SOCIETY FOR THE PROTECTION OF NATURE TO ESTABLISH A NATIONAL MARINE PARK IN AQABA.

2. BEGIN TEXT.

APPLICATION FOR FINANCIAL SUPPORT FOR THE ESTABLISHMENT OF A MARINE PARK IN THE GULF OF AQABA

I. BACKGROUND

THE GULF OF AQABA IS A UNIQUE ECOSYSTEM, SUPPORTING EXTENSIVE CORAL REEFS WITH A VERY HIGH DIVERSITY OF SPECIES. THE ECOLOGICAL VALUE OF THE REEF SYSTEM IS CONSIDERED TO BE OF INTERNATIONAL SIGNIFICANCE.

THE GULF IS ALSO JORDAN'S ONLY OUTLET TO THE SEA AND IT IS THEREFORE OF VITAL STRATEGIC IMPORTANCE FOR THE COUNTRY'S ECONOMY. COMMERCIAL AND TOURISM DEVELOPMENTS ALONG THE COAST ARE INCREASING RAPIDLY AND ARE CAUSING DAMAGE AND DISTURBANCE TO THE FRAGILE REEF ECOSYSTEMS. PARTICULAR PROBLEMS ARE POLLUTION FROM LAND-BASED INDUSTRIES AND DISTURBANCE FROM RECREATIONAL AND FISHING USES. THE DRAGGING OF BOAT ANCHORS ACROSS THE REEF IS CITED AS A VERY DAMAGING CONSEQUENCE OF UNCONTROLLED USE.

SEVERAL REPORTS ON THE ENVIRONMENTAL PROBLEMS OF THE GULF HAVE BEEN PRODUCED (SEE BELOW) AND A COMMON RECOMMENDATION IS FOR THE AREA TO BE ZONED FOR DIFFERENT USES, INCLUDING A PROPOSED MARINE PARK TO PROTECT THE BEST REMAINING AREA OF INSHORE CORAL REEF. IN OCTOBER 1992, THE WORLD CONSERVATION UNION (IUCN) PREPARED AN ACTION PLAN FOR THE ESTABLISHMENT OF A MARINE PARK AS A PART OF AN OVERALL ZONING STRATEGY FOR THE JORDANIAN SECTION OF THE GULF. THE PRINCIPAL OBJECTIVE OF THIS ACTION PLAN WAS: "TO DEVELOP A PARK CONCEPT, BASED ON THE MASTER PLAN FOR THE SOUTH TOURIST COAST AREA OF AQABA, WHICH WILL ALLOW FOR SELECTED SUSTAINABLE USES OF THE MARINE ENVIRONMENT, WHILE ENSURING THAT THE INTEGRITY OF THIS ENVIRONMENT IS MAINTAINED."

THE IUCN ACTION PLAN HAS BEEN ACCEPTED IN PRINCIPLE BY THE AQABA

REGIONAL AUTHORITY, WHICH IS RESPONSIBLE FOR PLANNING MATTERS IN THE AQABA MUNICIPALITY. A COPY OF THE FULL IUCN REPORT IS INCLUDED WITH THIS APPLICATION.

II. ROLE OF RSCN

THE IUCN REPORT RECOMMENDS THAT THE ROYAL SOCIETY FOR THE CONSERVATION OF NATURE SHOULD BE THE PRINCIPAL MANAGEMENT AGENCY FOR THE PROPOSED MARINE PARK. THE SOCIETY HAS BEEN ACTIVE IN THE GULF FOR SEVERAL YEARS AND CURRENTLY HAS AN OFFICE IN AQABA AND ONE PERMANENT MEMBER OF STAFF WHO IS RESPONSIBLE FOR MONITORING POLLUTION INCIDENTS AND EXCESSIVE DISTURBANCE TO THE REEF AND BEACH ECOSYSTEMS. THIS PERSON IS EQUIPPED WITH A SMALL POWER BOAT TO PATROL THE GULF WATERS. WHILE HE HAS UNDOUBTEDLY BEEN A SIGNIFICANT INFLUENCE IN TERMS OF CONTROLLING ENVIRONMENTAL DEGRADATION, HIS EFFECTIVENESS IS LIMITED BY THE LACK OF DEMARCATED ZONES, APPROPRIATE MONITORING EQUIPMENT AND PUBLICITY MATERIAL. THIS APPLICATION TO OES IS INTENDED TO ADDRESS THESE PARTICULAR PROBLEMS.

III. ESTABLISHMENT OF A MARINE PARK

THE LOCATION AND AREA OF THE PROPOSED MARINE PARK HAS BEEN DEFINED IN THREE LOCATIONS. THE PRIMARY LOCATION IS APPROXIMATELY EIGHT KILOMETERS LONG, IN AN AREA BETWEEN THE MARINE SCIENCE STATION TO THE COAST GUARD STATION TO THE SOUTH OF AQABA. TWO SMALLER SECTIONS, EACH APPROXIMATELY ONE KILOMETER IN LENGTH, ARE LOCATED BETWEEN THE MARINE SCIENCE STATION AND THE MAIN PORT OF AQABA. PRIORITIES FOR THE PARK'S ESTABLISHMENT ARE AS FOLLOWS:

(A) BOUNDARY MARKERS

THE BOUNDARIES OF THE PARK NEED TO BE DEFINED BY MARKER BUOYS SO THAT ALL USERS OF THE COASTAL AND OPEN WATERS OF THE GULF WILL BE AWARE OF ITS EXISTENCE AND TO ENABLE APPROPRIATE CONTROL MEASURES TO BE IMPLEMENTED TO PROTECT THE REEF WITHIN THE BOUNDARIES.

(B) MOORING BUOYS

ONE OF THE MOST SIGNIFICANT CAUSES OF DEGRADATION OF THE REEF IS THE DRAGGING OF BOAT ANCHORS OVER THE FRAGILE CORAL COMMUNITIES. MOORING BUOYS ARE REQUIRED TO ENABLE LEGITIMATE BOAT USERS WITHIN AND AROUND THE PARK BOUNDARIES TO TIE-UP WITHOUT THE NEED FOR ANCHORS.

(C) INFORMATION FOR THE PUBLIC

USERS OF THE COASTAL WATERS, AND PARTICULARLY DIVERS, FISHERMAN AND BOATERS, NEED TO BE INFORMED OF THE IMPORTANCE OF THE REEFS

A MINIMUM OF FOUR SETS OF DIVING GEAR ARE REQUIRED, TOGETHER WITH UNDERWATER CAMERAS AND SURVEYING EQUIPMENT.

(E) VEHICLE

RSCN HAS NOT HAD THE RESOURCES TO PROVIDE THE EXISTING GULF

OFFICER WITH A VEHICLE. THIS HAS CREATED MANY DIFFICULTIES IN TERMS OF MOBILITY AND THE TRANSPORT OF MATERIALS AND EQUIPMENT. IT HAS ALSO SEVERELY RESTRICTED HIS ABILITY TO MONITOR AND CONTROL DAMAGING ACTIVITIES ON THE BEACHES. A VEHICLE IS THEREFORE URGENTLY REQUIRED TO IMPROVE THE EFFECTIVENESS OF HIS WORK.
