1. JORDAN PHOSPHATE MINES COMPANY (JPMC) POSTED A LOSS OF USD 28 MILLION FOR 1993. ACCORDING TO THE 1993 JPMC ANNUAL REPORT, THE COMPANY HAS SUFFERED FROM DECLINING PROFITS FOR THE PAST THREE YEARS, BUT THIS IS THE FIRST LOSS IN RECENT YEARS.
2. IN 1992, THE JPMC POSTED A USD 23 MILLION PROFIT, STEADILY DECLINING FROM A PROFIT HIGH OF USD 151 MILLION IN 1989. THE LOSS IN 1993 OCCURRED DUE TO AN OVERALL DEPRESSION IN THE GLOBAL PHOSPHATE MARKET RESULTING FROM MARKET LIBERALIZATION IN INDIA, LOW CONSUMPTION IN THE U.S. AND DUMPING OF PHOSPHATES BY STATES OF THE FORMER SOVIET UNION. KEY EASTERN EUROPEAN MARKETS, TRYING TO DEAL WITH A LACK FOREIGN EXCHANGE, HAVE CUT BACK ON PHOSPHATE PURCHASES AND WESTERN EUROPEAN COUNTRIES HAVE REDUCED THEIR USE OF CHEMICAL FERTILIZERS. THE JPMC SAID IT WAS ALSO BURDENED DOMESTICALLY BY OVER-EMPLOYMENT FOR SOCIAL WELFARE PURPOSES ENCOURAGED BY THE GOVERNMENT, HIGHER TRANSPORTATION COSTS, INCLUDING FINES FOR EXCESS AXLE-WEIGHT LOADS, AND HIGHER CHARGES FOR WATER AND FUEL.
3. ACCORDING TO THE ANNUAL REPORT, ECONOMIC LIBERALIZATION IN INDIA, ONE OF JORDAN'S MAIN MARKETS, HAS LED TO A LIFTING OF THE INDIAN FERTILIZER SUBSIDY AND DECENTRALIZATION OF THE STATE'S FERTILIZER PURCHASING MONOPOLY. THIS HAS

RESULTED IN REDUCED FERTILIZER AND PHOSPHATE PURCHASES. ADDITIONALLY, POLITICAL CHANGES IN THE MIDDLE EAST CAUSED INDIA TO ALLOW ISRAEL TO ENTER THE INDIAN MARKET AS A NEW COMPETITOR.

4. FOUR YEARS OF DEPRESSION IN THE GLOBAL PHOSPHATE MARKET LED TO STIFF COMPETITION AND LOW PRICES FROM MOROCCO, ISRAEL, ALGERIA, EGYPT AND SYRIA. AS A RESULT, JPMC'S EXPORTS DROPPED BY 16 PERCENT TO 3.6 MILLION TONS, ITS LOWEST LEVEL SINCE 1982. GLOBAL EXPORTS OF PHOSPHATES FELL TO 24.4 MILLION TONS IN 1993 FROM 29.5 MILLION TONS IN 1992, DOWN FROM 40 MILLION TONS IN 1989. THIS REPRESENTS A 46.5 PERCENT DROP IN WORLD EXPORTS BETWEEN 1989 AND 1993.

5. IN 1993, JPMC EARNED USD 134 MILLION IN PHOSPHATE SALES AND USD 81 MILLION FROM FERTILIZER SALES, TOTALLING USD 215 MILLION. THE FIGURE REPRESENTS A DROP OF 27.5 PERCENT FROM THE USD 291 MILLION EARNED IN 1992. AFTER DEDUCTING OPERATIONAL COSTS, JPMC ENDED UP WITH A USD 4.7 MILLION LOSS IN 1993 COMPARED TO A USD 43 MILLION GROSS PROFIT IN 1992. AFTER ADDING OTHER INCOME AND EXPENSES, JPMC HAD A NET LOSS OF USD 28 MILLION.

6. COMMENT. AS JORDAN'S MAIN FOREIGN EXCHANGE EARNER, JPMC'S LOSS WILL INCREASE THE GOJ'S ECONOMIC DIFFICULTIES. MOST OF THE LOSS IS DUE TO CIRCUMSTANCES BEYOND THE COMPANY'S CONTROL. COMPANY OFFICIALS HAVE SAID IN THE PAST THAT THEY EXPECT THE MARKET TO GET OUT OF ITS SLUMP BY THE END OF 1995 (SEE REFTTEL). DUE TO GOJ EMPLOYMENT POLICIES, THE JPMC WILL NOT BE ABLE TO SHED EMPLOYEES. IT WILL ALSO BE STUCK WITH THE HIGHER TRANSPORTATION, FUEL AND WATER COSTS. THE ONLY THING JPMC CAN DO IS TO WAIT OUT THE DEPRESSION AND TRY TO MAINTAIN THEIR MARKET SHARE, SOMETHING IT HAS MANAGED QUITE WELL.
