SUBJECT: ABERCROMBIE AND KENT TO OPEN IN JORDAN
1. SUMMARY. ECONOFF AND USAID OFFICER MET WITH REPRESENTATIVES OF ILLINOIS-HEADQUARTERED TOURISM COMPANY ABERCROMBIE AND KENT ON TUESDAY, JUNE 21 TO DISCUSS THE OPENING OF AN ABERCROMBIE AND KENT OFFICE IN JORDAN. END SUMMARY.
2. TIM WEBB, PRESIDENT OF ABERCROMBIE AND KENT OVERSEAS AND JAMES BERKELEY, MANAGING DIRECTOR OF ABERCROMBIE AND KENT EGYPT, MET ECONOFF AND USAID OFFICER ON JUNE 21 FOLLOWING MEETINGS WITH THE MINISTRY OF TOURISM, USAID AND POTENTIAL PARTNERS IN JORDAN. ABERCROMBIE AND KENT (AK) IS EXCITED ABOUT THE PROSPECTS OF OPENING OPERATIONS IN JORDAN TO TIE TOGETHER ITS EXISTING OPERATIONS IN EGYPT AND ISRAEL. AK HAS ITS MAIN OFFICES IN OAK BROOK, ILLINOIS AND IN LONDON, WITH OFFICES AROUND THE WORLD. IT BEGAN OPERATIONS IN KENYA, OFFERING SAFARI TRIPS, AND HAS EXPANDED ITS OPERATIONS INTERNATIONALLY.
3. AK MET WITH THE SECRETARY GENERAL OF THE MINISTRY OF TOURISM TO EXPLORE OPPORTUNITIES IN JORDAN. THE MINISTRY IS EXCITED ABOUT A FIRST-RATE AMERICAN TRAVEL FIRM WHICH TARGETS THE UPPER-END OF THE MARKET MOVING INTO JORDAN. AK EXPECTS TO TAKE OVER A MINISTRY OF TOURISM PROJECT TO DEVELOP NEW TOURIST BROCHURES.
4. AK ALSO EXPLORED PARTNERSHIP OPTIONS WITH A NUMBER OF BUSINESSMEN, FINALLY SETTLING ON FADI GHANDOUR, THE CHAIRMAN OF ARAMEX INTERNATIONAL, A JORDAN-BASED EXPRESS DELIVERY COMPANY. GHANDOUR IS A YOUNG, WESTERN-EDUCATED BUSINESSMAN, OF WHOM AK

SAID HAD THE RIGHT MINDSET FOR THIS BUSINESS. THEIR CHOICE IS EXPECTED TO BE ANNOUNCED WITHIN A MONTH.

5. AK INTENDS TO BEGIN BY PUBLISHING GLOSSY BROCHURES TOUTING JORDAN TO ATTRACT CLIENTS FROM ITS ALREADY LARGE GLOBAL CUSTOMER BASE. IT WILL IMPORT FOUR-WHEEL VEHICLES AND PASSENGER VANS TO CARRY THEIR CLIENTS, HAVING RECEIVED ASSURANCES THAT THEIR IMPORTS OF APPROXIMATELY USD TWO MILLION WORTH OF VEHICLES WOULD NOT/NOT BE SUBJECT TO JORDAN'S HIGH CUSTOMS TARIFFS. AK WILL BEGIN TRAINING MANAGERS AND STAFF IN CAIRO AND KENYA. SHOULD THEIR BUSINESS MEET WITH SUCCESS, AK WILL EXPLORE INTRODUCING ITS WINDSOR HOTEL CHAIN INTO JORDAN.

6. COMMENT. GIVEN THE POTENTIAL FOR A PEACE AGREEMENT, AK WOULD LIKE TO POSITION THEMSELVES FOR AN ANTICIPATED BOOM FOLLOWING SUCH AN AGREEMENT, BUT IS PREPARED TO OPERATE IN ADVANCE OF ONE. THE COMING OF A HIGH-END WESTERN TRAVEL OPERATOR TO JORDAN IS A POSITIVE SIGN. IF AK MEETS WITH SUCCESS, IT MAY DRAW OTHER LARGE TRAVEL OPERATORS, WHICH WILL UPGRADE JORDAN'S TRAVEL MARKET CLIENTELE AND THEIR FOREIGN EXCHANGE RECEIPTS FROM TOURISM.

AND 1 FN CIVILIAN DRIVER/EXPEDITER.
2. MISSION CONCURS WITH THE CREATION OF A MILITARY
COORDINATION SECTION UNDER MAP. THE STEADY FLOW OF
EXERCISES AND OTHER NON-SECURITY ASSISTANCE
ACTIVITIES, AS WAS PREVIOUSLY NOTED IN THE CENTCOM
MANPOWER SURVEY OF APR 93, CLEARLY JUSTIFIES THE
ESTABLISHMENT OF THIS SECTION. INDEED, THE PACE OF
THESE ACTIVITIES HAS INCREASED SINCE THE CONDUCT OF
THE SURVEY. HOWEVER, WE HAVE THE FOLLOWING
COMMENTS ON THE CENTCOM PROPOSAL:
A. THE ARMY 0-4 JOINT ACTIONS OFFICER SHOULD BE
CODED 48G (MIDDLE EAST FRO) AS PRIMARY MOS WITH A
SECONDARY MOS OF GENERIC COMBAT ARMS. ATTENDANCE

AT DISAM, CURRENTLY REQUIRED FOR OUR JAO, SHOULD BE DELETED FROM PRE-DEPLOYMENT TRAINING. HOWEVER, SOME FAMILIARIZATION TWINING ON RESOURCE MANAGEMENT AND FISCAL ACCOUNTABILITY SHOULD BE ADDED. THIS IS REQUIRED IN ORDER TO PROPERLY MANAGE THE O&M BUDGET OF THE SECTION, AS WELL AS THE SEVERAL MILLION DOLLARS WORTH OF MIPR'S ASSOCIATED WITH EXERCISES AND OTHER ACTIVITIES.

B. WE PREFER THAT THE AIR FORCE BILLET PROPOSED BY CENTCOM (O-4 OPERATIONS STAFF OFFICER) INSTEAD BE FOR AN E-7 NCO WITH EXPERTISE IN AIRFIELD MANAGEMENT OPERATIONS (AFSC 271XX). IN REF A MESSAGE, MISSION STATED ITS BELIEF NEARLY A YEAR AGO THAT AN AIR FORCE NCO WAS ESSENTIAL FOR HANDLING OF THE STEADY FLOW OF BOTH USAF AMC CHANNEL FLIGHTS AND EXERCISE TRAFFIC. WE ENVISION THE NCO WILL BE THE PRIMARY PERSON RESPONSIBLE FOR GROUND SUPPORT OF AMC CHANNEL, EXERCISE, AND OTHER AIR TRAFFIC IN COUNTRY, DIPLOMATIC CLEARANCE REQUESTS FOR AIRCRAFT, SUPPORT OF AIR CREWS, MANIFEST VERIFICATION, TERMINAL PREPARATION, WAREHOUSING, CONTRACTING, ETC. POST NOTES THAT CENTCOM HAS PREVIOUSLY ENDORSED THE NEED FOR THIS NCO AT REF B MSG. FINALLY, UTILIZATION OF AN NCO WILL SOLVE THE OBVIOUS PROBLEM OF WHO IS IN CHARGE OF A SECTION WITH TWO MAJORS.

C. THE FN DRIVER/EXPEDITER SHOULD BE RETITLED TRANSPORTATION COORDINATOR. HIS DUTIES ARE EXTENSIVE, RANGING FROM FORKLIFT LOADING/UNLOADING OF AIRCRAFT AND PREPARATION OF CARGO MANIFESTS TO VEHICLE MAINTENANCE AND PROTOCOL/LIAISON FUNCTIONS. A COMPLETE JOB DESCRIPTION WILL BE FORWARDED TO CCJL IF REQUIRED.

3. REQUEST CENTCOM INITIATE APPROPRIATE NSDD-38 ACTION THROUGH DOD CHANNELS WITH DOS/FMP AND NEA.
