1. SUMMARY/INTRODUCTION. THE EU COMMISSION ON JULY 22 ANNOUNCED A SERIES OF GRANTS TOTALING 51.4 MILLION ECU (ABOUT THE EQUIVALENT OF 63.2 USD AT TODAY'S RATE) TO SUPPORT PROJECTS IN JORDAN (SUPPORT FOR STRUCTURAL ADJUSTMENT), SYRIA (ELECTRICITY SECTOR SUPPORT PROGRAM) AND MOROCCO (TWO PROJECTS: PROMOTION AND DEVELOPMENT OF REMOTE SENSING, SUPPORT FOR FARM CREDIT INSTITUTIONS).
