1. SUMMARY AND ACTION REQUEST. THIS CABLE CONTAINS A SUMMARY OF PROCEDURES FOR USG IMPLEMENTATION OF JORDAN'S PARIS CLUB DEBT RESCHEDULING AGREEMENT. DEPARTMENT HAS COMPLETED A FIRST DRAFT OF THE BILATERAL DEBT RESCHEDULING AGREEMENT AND A CLEARED INTERAGENCY TEXT SHOULD BE READY FOR TRANSMITTAL TO POST WITHIN SEVERAL WEEKS (WE ARE EXPEDITING THESE PROCEDURES AS REQUESTED IN REF A). WE ARE PRESENTLY CONSIDERING THE FORM OF ANY BILATERAL DEBT FORGIVENESS AGREEMENT; SUCH AN AGREEMENT WOULD AFFECT PRIMARILY THE LOANS AND AMOUNTS RESCHEDULED, NOT THE FORM OR OTHER CONTENT OF THE RESCHEDULING AGREEMENT. DEPARTMENT REQUESTS EMBASSY TO REPORT: GOJ'S PREFERRED VENUE FOR DISCUSSIONS ON THE AGREEMENT; GOJ REQUIREMENTS FOR ENTRY INTO FORCE OF THE AGREEMENT; AND PREFERRED MEANS OF TRANSMITTAL OF BILATERAL TO POST. END SUMMARY AND ACTION REQUEST.

STATUS OF BILATERAL AGREEMENT

2. DEPARTMENT HAS COMPLETED A FIRST DRAFT OF THE BILATERAL DEBT RESCHEDULING AGREEMENT FOR JORDAN BASED ON THE PARIS CLUB AGREED MINUTE OF JUNE 28, 1994 (SEE REF B). THE DEPARTMENT IS PRESENTLY CLEARING THE BILATERAL THROUGH ATTORNEYS, ACCOUNTANTS, AND POLICYMAKERS AT EACH USG CREDITOR AGENCY INVOLVED. A FULLY CLEARED DRAFT SHOULD BE READY TO SEND TO POST IN MID-AUGUST. DUE TO BUDGET CONSTRAINTS, DEPARTMENT MAY ONLY POUCH THE AGREEMENT TO POST, BUT IF EMBASSY FUNDS ARE AVAILABLE, DEPARTMENT COULD ARRANGE A DHL. EMBASSY IS REQUESTED TO NOTIFY DEPARTMENT OF THE PREFERRED MEANS OF TRANSMITTAL.

RELATIONSHIP BETWEEN THE AGREED MINUTE AND THE BILATERAL
AGREEMENT

3. IN PARIS, THE GOJ NEGOTIATED WITH ITS PARIS CLUB CREDITORS ALL THE TERMS OF THE REDUCTION AND RESCHEDULING EXCEPT FOR INTEREST RATES, WHICH ARE DETERMINED BILATERALLY. THE BILATERAL AGREEMENT WILL REFINER THE TERMS ALREADY AGREED TO IN PARIS AND WILL CONTAIN THE INTEREST RATES FOR DEBT OWED TO THE EXPORT-IMPORT BANK OF THE UNITED STATES (EXIMBANK), DOD, USAID, AND USDA.

4. IN ORDER TO BE FAIR AND IMPARTIAL TO ALL DEBTORS, EACH USG CREDITOR AGENCY APPLIES THE SAME GENERAL INTEREST-RATE FORMULA FOR ALL RESCHEDULINGS. CONSEQUENTLY, INTEREST RATES CONTAINED IN THE BILATERAL AGREEMENT ARE NOT NEGOTIABLE.

5. SINCE THE GOJ HAS ALREADY AGREED TO ALL RESCHEDULING TERMS IN PARIS, (EXCEPT FOR TERMS ON INTEREST RATES, WHICH FOR THE USG ARE NOT NEGOTIABLE) THE BILATERAL DEBT RESCHEDULING DOCUMENT IS OPEN TO DISCUSSION RATHER THAN ACTUAL NEGOTIATION.

RELATIONSHIP BETWEEN DEBT RESCHEDULING AGREEMENT AND ANY
USG FORGIVENESS OF JORDANIAN DEBT

6. CONGRESSIONAL AUTHORIZATION AND APPROPRIATIONS ARE NECESSARY BEFORE WE CAN GO FORWARD WITH EVEN PARTIAL DEBT FORGIVENESS FOR JORDAN. WE ARE SEEKING TO OBTAIN THESE AUTHORITIES AS PART OF THE FOREIGN OPERATIONS, EXPORT FINANCING AND RELATED PROGRAMS APPROPRIATIONS FOR FY 1995 BILL. UNTIL THE BILL IS PASSED BY BOTH HOUSES OF CONGRESS AND THE PRESIDENT SIGNS IT INTO LAW, NO ACTION CAN BE TAKEN WITH RESPECT TO FORGIVENESS.

7. IN ANTICIPATION OF THE NECESSARY LEGISLATION BEING ENACTED, WE ARE PRESENTLY CONSIDERING THE FORM OF ANY DEBT FORGIVENESS AGREEMENT AND WILL ADVISE FURTHER ON DEBT FORGIVENESS DETAILS AND MODALITIES SEPTEL, AS MORE INFORMATION BECOMES AVAILABLE. IN ANY EVENT, THE DEBT FORGIVENESS AGREEMENT WOULD AFFECT PRIMARILY THE LOANS AND AMOUNTS RESCHEDULED, NOT THE FORM OR OTHER CONTENT OF THE RESCHEDULING AGREEMENT.

IMPLEMENTING AGREEMENTS TO THE BILATERAL

8. AFTER THE BILATERAL AGREEMENT IS SIGNED, USDA AND USAID WILL PREPARE IMPLEMENTING AGREEMENTS WITH A FURTHER REFINEMENT OF INFORMATION CONTAINED IN THE BILATERAL AGREEMENT (E.G., A LIST OF CREDITS INCLUDED IN THE RESCHEDULING, PAYMENT INSTRUCTIONS, ETC.). EXIMBANK AND DOD HAVE IMPLEMENTED THE AGREEMENT WITH AN ANNEX TO THE BILATERAL AGREEMENT. EXIM AND DOD WILL SEND A COMPLETE DEBT LIST AND PAYMENT SCHEDULE TO THE GOJ AFTER SIGNATURE

OF THE BILATERAL.

VENUE FOR DISCUSSIONS

9. DEPARTMENT WOULD BE PLEASED TO ACCOMMODATE THE GOJ'S PREFERENCE FOR THE LOCATION OF DISCUSSIONS. THE MEETINGS ARE USUALLY HELD IN THE DEBTOR CAPITAL, WITH THE EMBASSY REPRESENTING THE USG. HOWEVER, DEPARTMENT WOULD BE WILLING TO HOST MEETINGS IN WASHINGTON IF THE GOJ PREFERS. EMBASSY IS REQUESTED TO DETERMINE THE GOJ'S PREFERENCE ON THIS MATTER.

SIGNATURE AND ENTRY INTO FORCE OF THE BILATERAL
RESCHEDULING AGREEMENT

10. IF THE AGREEMENT IS CONCLUDED IN THE DEBTOR CAPITAL, THE AMBASSADOR, OR ANOTHER APPROPRIATE EMBASSY OFFICIAL, SIGNS FOR THE USG; THE FINANCE MINISTER, OR ANOTHER OFFICIAL APPOINTED BY THE DEBTOR GOVERNMENT, SIGNS FOR THE DEBTOR. IF THE AGREEMENT IS SIGNED IN WASHINGTON, THE DAS FOR INTERNATIONAL FINANCE AND DEVELOPMENT IN THE ECONOMIC AND BUSINESS BUREAU, OR ANOTHER APPROPRIATE DEPARTMENT OFFICIAL, SIGNS FOR THE USG.

11. FOLLOWING SIGNATURE OF THE AGREEMENT, THE AGREEMENT MUST BE TRANSMITTED TO CONGRESS NO LESS THAN 30 DAYS PRIOR TO ITS ENTRY INTO FORCE. THE DEPARTMENT REQUIRES SEVERAL DAYS TO PREPARE THE CONGRESSIONAL NOTIFICATION. THE BILATERAL AGREEMENT IS CONSIDERED TO HAVE ENTERED INTO FORCE AS A LEGAL DOCUMENT UNDER U.S. LAW AFTER 30 CALENDAR DAYS, COUNTING FROM THE DAY AFTER THE DEPARTMENT TRANSMITS THE NOTIFICATION TO CONGRESS. (THIS STAGE OF THE PROCESS IS FAIRLY ROUTINE. THE DEPARTMENT DOES NOT ANTICIPATE ANY DIFFICULTY DURING THE CONGRESSIONAL REVIEW PERIOD THAT WOULD PREVENT OR DELAY THE AGREEMENT'S ENTRY INTO FORCE.)

12. DEPARTMENT ASSUMES THE GOJ MUST SIMPLY SIGN THE BILATERAL DEBT RESCHEDULING AGREEMENT FOR THE AGREEMENT TO ENTER INTO FORCE UNDER JORDANIAN LAW. EMBASSY IS REQUESTED TO CONFIRM THIS ASSUMPTION.

1. THE AMBASSADOR MET WITH MINISTER OF JUSTICE HISHAM AL-TALL AUGUST 3 TO DISCUSS THE ABEQUA/DOKUR CHILD CUSTODY AND EXTRADITION CASES. THE MINISTER WAS FULLY INFORMED ON THE TIMING AND DETAILS OF OUR REQUEST FOR ABEQUA'S EXTRADITION TO THE UNITED STATES AND THE LATEST DEVELOPMENTS IN THE CHILD CUSTODY CASE INCLUDING THE RECENT ARRIVAL OF NESIME DOKUR AND ER PARTY. THE AMBASSADOR PRESSED ON HOW SOON A CUSTODY HEARING MIGHT TAKE PLACE EMPHASIZING THE IMPORTANCE ATTACHED TO THE SPEEDY RETURN OF THE TWO CHILDREN TO THE CUSTODY OF THEIR LEGAL GUARDIANS IN THE UNITED STATES. THE MINISTER RESPONDED THAT:
--IN PRINCIPLE THE GOVERNMENT SUPPORTS CUSTODY CLAIMS OF THE MATERNAL AUNT AND MATERNAL GRANDMOTHER IN SUCH CASES GIVEN THE AGE OF THE CHILDREN;
--HE WILL MEET WITH THE MINISTER OF INTERIOR, THE MINISTER OF FOREIGN AFFAIRS, AND THE SENIOR JUDGE OF THE HAJIA COURT WITHIN THE NEXT SEVERAL DAYS TO DETERMINE IF CUSTODY COULD BE GRANTED TO NESIME DOKUR AND HER MOTHER BASED ON AN ADMINISTRATIVE RULING, THUS AVOIDING A CUSTODY HEARING ALTOGETHER;
--THE ATTORNEY GENERAL HAS NOW FORMALLY CHARGED ABEQUA WITH KIDNAPPING IN ADDITION TO FIRST DEGREE MURDER;
--THE MINISTRIES OF JUSTICE AND INTERIOR HAVE ALREADY BEEN IN TOUCH WITH ABEQUA'S BROTHER AND FAMILY WITH RESPECT TO THE SAFETY AND SECURITY OF THE CHILDREN AND TO ENCOURAGE THEM TO COOPERATE WITH JORDANIAN AUTHORITIES IN CUSTODY PROCEEDINGS;

--HE WAS MORE THAN WILLING TO MEET WITH MS. DOKUR, HER ATTORNEY, AND PARTY SHOULD THEY SO REQUEST.

2. FOR THE RECORD, THE MINISTER CONFIRMED THAT ABEQUA HAD BEEN CHARGED WITH FIRST DEGREE MURDER ON JULY 23 AND WITH KIDNAPPING ON JULY 27. ACCORDING TO THE MINISTER, DEFENDANTS FOUND GUILTY OF MURDER UNDER SIMILAR CIRCUMSTANCES ARE NORMALLY SENTENCED TO EITHER LIFE IMPRISONMENT OR DEATH. AS REPORTED PREVIOUSLY, THE KING HAS ALREADY EMPHASIZED TO THE AMBASSADOR THAT HE HAD RECENTLY CONFIRMED A DEATH SENTENCE IN A SIMILAR CASE. THE MINISTER FURTHER EXPLAINED THAT ONCE THE NECESSARY DOCUMENTATION IS RECEIVED FROM NEW JERSEY AUTHORITIES IN SUPPORT OF THE MURDER CHARGE, TRIAL COULD BEGIN WITHIN A WEEK OR TWO AND SENTENCING COULD BE EXPECTED WITHIN TWO OR THREE MONTHS.

COMMENT:

3. THE MINISTER ACKNOWLEDGED THAT THE GOJ HAD YET TO RESPOND FORMALLY TO THE REQUEST FOR ABEQUA'S EXTRADITION, EXPULSION, OR DEPORTATION TO THE U.S. AND THAT A "FINAL" DECISION ON THAT REQUEST WAS STILL PENDING. NEVERTHELESS, EVERY INDICATION WAS THAT THE ATTORNEY GENERAL INTENDS TO PROSECUTE ABEQUA IN JORDAN FOR FIRST DEGREE MURDER.

ACTION REQUESTED:

4. ON THE LIKELY ASSUMPTION THAT THE GOVERNMENT WILL PROSECUTE ABEQUA LOCALLY, EMBASSY REQUESTS EVERY POSSIBLE STEP BE TAKEN WITH THE DOJ AND THE NEW JERSEY COURTS TO PROVIDE FULL DOCUMENTATION AND OTHER EVIDENCE WITH RESPECT TO THE MURDER CHARGE AGAINST ABEQUA INCLUDING ANY FURTHER DETAILS OF HIS FLIGHT FROM THE U.S. TO AVOID ARREST.
