1. SUMMARY. DEPARTMENT SENT THE TEXT OF THE PROPOSED U.S.-JORDAN BILATERAL DEBT RESCHEDULING AGREEMENT TO POST ON WEDNESDAY, AUGUST 10, 1994 VIA AIRBORNE EXPRESS AIRBILL NO. 5234227692. ETA IS SUNDAY, AUGUST 13, 1994. EMBASSY IS REQUESTED TO GIVE THE TEXT TO THE APPROPRIATE GOJ OFFICIALS FOR THEIR REVIEW. EMBASSY HAS THE CIRCULAR 175 AUTHORITY TO SIGN THE BILATERAL DEBT RESCHEDULING AGREEMENT ON BEHALF OF THE USG. THIS CABLE PROVIDES ADDITIONAL INFORMATION FOR POST'S (SE IN DISCUSSIONS WITH THE GOJ. END SUMMARY.

2. PLEASE NOTE IN ANY EMBASSY DISCUSSIONS WITH GOJ OFFICIALS THAT THE DRAFT BILATERAL AGREEMENT CONFORMS WITH THE TERMS OF THE PARIS CLUB AGREED MINUTE OF JUNE 28, 1994, WHICH WAS SIGNED BY THE GOJ AND ITS OFFICIAL CREDITORS. THE INTEREST RATES INCLUDED IN THE DRAFT AGREEMENT ARE THE LOWEST INTEREST RATES CONSISTENT WITH U.S. LAW AND POLICY WITH RESPECT TO THE RESCHEDULING OF THE VARIOUS CREDITS INCLUDED IN THE AGREEMENT AND ARE NOT SUBJECT TO NEGOTIATION.

3. THE DEPARTMENT HAS OBTAINED CIRCULAR 175 AUTHORITY FOR THE EMBASSY TO SIGN THE BILATERAL ON BEHALF OF THE USG. GENERALLY, THE AMBASSADOR SIGNS FOR THE U.S. AND THE FINANCE MINISTER FOR THE DEBTOR COUNTRY. AFTER SIGNING HAS TAKEN PLACE, PLEASE REPORT BY CABLE THE DATE, NAMES AND TITLES OF SIGNATORIES, AND POUCH ONE EXECUTED ORIGINAL IN EACH LANGUAGE TO DEPARTMENT FOR EB/IFD/OMA, ATTENTION KIM VALUS. (EMBASSY MAY WISH TO KEEP A COPY OF THE AGREEMENT FOR ITS RECORDS.) THE REMAINING EXECUTED AGREEMENTS ARE FOR THE GOJ.

4. ENTRY INTO FORCE OF THE AGREEMENT WILL OCCUR FOLLOWING SIGNATURE OF THE AGREEMENT AND NOTIFICATION TO CONGRESS. CONGRESS HAS THIRTY CALENDAR DAYS (INCLUDING WEEKENDS AND FEDERAL HOLIDAYS AND CONGRESSIONAL RECESSES) IN WHICH TO REVIEW THE SIGNED BILATERAL. IF CONGRESS DOES NOT OBJECT, WE WILL NOTIFY THE GOJ THAT THE AGREEMENT HAS ENTERED INTO FORCE. UPON SIGNATURE OF THE AGREEMENT, DOD WILL CONSIDER ARREARS AS HAVING BEEN RESCHEDULED AND IMMEDIATELY LIFT BROOKE SANCTIONS FOR THE PURPOSES OF RESUMING ASSISTANCE.

SUBJECT: BUSINESS PROPOSAL: SHIPPING U.S. GRAIN TO JORDAN VIA
ISRAELI PORT
1. ON AUGUST 16, AMERICAN GRAIN EXPORTER BURTON JOSEPH, ANTI-
DEFAMATION LEAGUE ISRAEL DIRECTOR HARRY WALL, AND JORDANIAN
BUSINESSMEN NADER DAJANI AND JAMAL KAWASMI OF AMMAN RESOURCES
COMPANY, BRIEFED CHARGE AND ECONOFF ON A COOPERATIVE BUSINESS
PROPOSAL TO SHIP U.S. GRAIN TO AMMAN THROUGH THE ISRAELI PORT OF
ASHDOD. IN LIGHT OF THE PEACE PROCESS, THEY ARE HOPEFUL THAT
THIS PROJECT CAN BE RAISED AT THE UPCOMING 28-29 AUGUST
TRILATERAL EXPERTS MEETING. MR. JOSEPH SAID THAT HE HAS
PREVIOUSLY BRIEFED UNDERSECRETARY JOAN SPERO ON THIS PROPOSAL AND
WOULD LIKE TO MOVE ON IT AS QUICKLY AS POSSIBLE. HE SAID HE WILL
BE CALLING THE DEPARTMENT SOMETIME SOON. ECONOFF SUBSEQUENTLY
PAID A VISIT TO ASHDOD'S PORT FACILITIES.

THE US-ISRAELI-JORDANIAN PROPOSAL

2. THIS US-ISRAELI-JORDANIAN VENTURE PLANS TO SHIP GRAIN FROM
THE UNITED STATES TO THE PORT OF ASHDOD, ISRAEL, AND THEN TRUCK
IT THE NINETY-ODD MILES TO AMMAN VIA TRANS-ISRAELI HIGHWAYS AND
THE ABDULLAH BRIDGE. ACCORDING TO JOSEPH, THE UNITED STATES
ANNUALLY SHIPS ABOUT TWO MILLION TONS OF WHEAT, BARLEY, CORN, AND
RICE TO JORDAN. CURRENTLY, THIS GRAIN PASSES THROUGH THE SUEZ
CANAL AND UP THE GULF OF AQABA TO AQABA PORT. IT IS THEN
TRANSPORTED OVERLAND IN AN AGING FLEET OF TRUCKS FOR SEVERAL
HUNDRED MILES TO AMMAN. JOSEPH ESTIMATES THAT THIS CIRCUITOUS
ROUTE ADDS ABOUT USD 9-10 PER TON TO THE COST OF SHIPPING THE
GRAIN.
3. THE POTENTIAL COMMERCIAL BENEFITS OF THE PROPOSAL INCLUDE

MORE BUSINESS FOR THE ISRAELI PORT OF ASHDOD AND REDUCED SHIPPING TIME AND COST FOR THE JORDANIAN IMPORTERS. MOREOVER, ACCORDING TO JOSEPH, THE UNITED STATES IS CURRENTLY PAYING A BONUS OF USD 45 PER TON TO SHIP GRAIN TO JORDAN UNDER THE EXPORT ENHANCEMENT PROGRAM (EEP), SO HE BELIEVES REDUCED TRANSPORT COSTS COULD BENEFIT U.S. GOVERNMENT COFFERS AS WELL. FINALLY, AS A NOD TOWARD THE PEACE PROCESS AND TO PLAY UP THE POTENTIAL POLITICAL BENEFITS OF THE VENTURE, MR. DAJANI ALSO INDICATED A DESIRE TO INVOLVE PALESTINIANS (NAMELY AS TRUCK DRIVERS AND MECHANICS) IN THE DEAL. REGARDING THE LOSS OF BUSINESS THE PORT OF AQABA WOULD SUFFER UNDER THEIR SCHEME, JOSEPH AND DAJANI EXPRESSED THE HOPE THAT GROWING TIES BETWEEN AQABA AND EILAT WOULD HELP OFFSET THIS LOSS FOR THE PORT OF AQABA, AND THAT, AT ANY RATE, IN LIGHT OF THE PEACE PROCESS, AQABA WAS LIKELY TO INCREASE IN IMPORTANCE AS A POINT OF ENTRY FOR OTHER GOODS.

THE ASHDOD PORT BULK FACILITIES AND SILOS

5. ECONOFF TOURED ASHDOD'S PORT FACILITIES AND THE DAGON GRAIN SILOS WITH DAGON MANAGER NATAN MARX. BUSINESS AT THE PORT IS GROWING RAPIDLY AND, ACCORDING TO MARX, THE PORT AUTHORITY IS CONSIDERING A USD 400 MILLION PROJECT THAT WILL EXPAND THE HARBOR AND ADD TWO ADDITIONAL QUAYS. FOR BULK GRAIN OPERATIONS, ASHDOD PORT'S CRANES ARE EQUIPPED WITH 12-TON GRABBERS THAT CAN UNLOAD SHIP HOLDS AT A RATE OF ABOUT 15,000 TONS PER DAY (THREE SHIFTS) INTO QUAYSIDE HOPPERS. THERE IS NO GRAIN CONVEYOR BELT SYSTEM. INSTEAD, TRUCKS WITH SPECIALLY-DESIGNED TRAILERS (CONVERTED 40-TON CARGO CONTAINERS) MOVE THE GRAIN THE 2.2 KM TO DAGON'S SILOS.

6. DAGON'S GRAIN FACILITY IS ONLY OPERATING AT ABOUT 25-30 PERCENT OF THEIR 64,000 TON CAPACITY, ACCORDING TO MARX. HE SAID DAGON COULD EASILY HANDLE AN ADDITIONAL 500,000 TONS OF GRAIN PER YEAR WITH NO CHANGE IN OPERATIONS, AND "WITH SOME TINKERING," COULD "PROBABLY" HANDLE AN ADDITIONAL ONE MILLION TONS ANNUALLY. THE FACILITY APPEARS TO BE QUITE EFFICIENT; WITH ONLY SEVEN EMPLOYEES, DAGON CONDUCTS 24-HOUR GRAIN LOADING AND UNLOADING OPERATIONS FROM AN ELEVATED CONTROL CENTER. RADIO-CONTROLLED TRACTORS SHUTTLE RAILCARS TO AND FROM LOADING CHUTES, WHILE TRUCK'S GAIN ACCESS BY INSERTING AUTOTELLER-STYLE CARDS - COLOR CODED BY COMMODITY - INTO THE FACILITY'S COMPUTERIZED ENTRANCE AND EXIT SCALES.
