1. THE FOLLOWING INFORMATION IS PROVIDED IN RESPONSE TO A NUMBER OF POSTS' REQUESTS (E.G., REFTEL) FOR DETAILS OF U.S. PLANS TO FORGIVE JORDAN'S DEBTS. EMBASSIES ARE FREE TO SHARE THIS BACKGROUND WITH HOST GOVERNMENTS.

2. THE ADMINISTRATION'S DECISION TO SEEK DEBT FORGIVENESS FOR JORDAN FOLLOWED THE HISTORIC SIGNING OF THE WASHINGTON DECLARATION BY KING HUSSEIN AND PRIME MINISTER RABIN ON JULY 25 AT THE WHITE HOUSE.

3. PRESIDENT CLINTON SIGNED INTO LAW THIS WEEK THE FOREIGN APPROPRIATIONS ACT FOR FY95. THE ACT INCLUDES INDEFINITE AUTHORIZATION FOR THE PRESIDENT TO FORGIVE JORDANIAN DEBTS TO THE UNITED STATES. THE ACT ALSO INCLUDES A FY94 SUPPLEMENTAL APPROPRIATION OF 99 MILLION TO COVER THE BUDGETARY COST OF FORGIVING NO MORE THAN 220 MILLION (IN FACE VALUE) OF OUTSTANDING USAID LOANS.

4. JORDAN'S TOTAL OUTSTANDING DIRECT LOANS AND CREDITS CURRENTLY TOTAL APPROXIMATELY 700 MILLION. THIS INCLUDES OBLIGATIONS OWED TO USAID, THE DEPARTMENT OF DEFENSE, USDA, AND THE EXPORT-IMPORT BANK. THE 700 MILLION DOES NOT INCLUDE USG GUARANTEES OF PRIVATE CONTRACTS WITH THE JORDANIAN GOVERNMENT (SUCH AS EXIMBANK GUARANTEES), WHICH REPRESENT A CONTINGENT LIABILITY TOTALING ABOUT 300 MILLION.

5. TO MINIMIZE THE BUDGETARY IMPACT OF FORGIVENESS, THE ADMINISTRATION CURRENTLY INTENDS TO USE THE AUTHORIZATION TO FORGIVE THE DIRECT LOANS AND CREDITS OVER A PERIOD OF YEARS. THE 20 MILLION REDUCTION IN FY94 REPRESENTS JUST THE FIRST STAGE OF FORGIVENESS. THE ADMINISTRATION WILL SEEK BUDGETARY APPROPRIATIONS FOR ADDITIONAL STAGES -- INCLUDING FOR MILITARY AND CONCESSIONAL AND NONCONCESSIONAL DEBT -- IN UPCOMING FISCAL YEARS.

6. IT IS OUR UNDERSTANDING THAT THE JORDANIAN GOVERNMENT WILL REMAIN CURRENT ON USG-GUARANTEED OBLIGATIONS TO THE PRIVATE SECTOR AND ON LOANS, INCLUDING RESCHEDULED LOANS, FOR WHICH FORGIVENESS IS PENDING CONGRESSIONAL APPROPRIATION.

7. THIS BILATERAL DEBT FORGIVENESS IS IN ADDITION TO THE MULTILATERAL RESCHEDULING ON EXCEPTIONALLY GENEROUS TERMS AGREED TO BY THE PARIS CLUB ON JUNE 25. JORDAN AND THE UNITED STATES SIGNED THE BILATERAL IMPLEMENTING AGREEMENT FOR THE PARIS CLUB RESCHEDULING ON AUGUST 18.

8. WASHINGTON AGENCIES ARE PREPARING A DRAFT AGREEMENT WITH JORDAN THAT WOULD IMPLEMENT THE FIRST STAGE OF DEBT FORGIVENESS DURING THE MONTH OF SEPTEMBER.

9. WE UNDERSTAND THAT OTHER CREDITORS HAVE JOINED US IN BILATERAL DEBT FORGIVENESS: THE UK RECENTLY ANNOUNCED THAT IT WILL CONVERT 90 MILLION OF JORDAN'S BILATERAL DEBT TO GRANTS, AND GERMANY AND SWITZERLAND FORGAVE A PORTION OF JORDAN'S DEBTS IN 1993. WE HOPE THAT OTHER CREDITORS WILL JOIN THESE EFFORTS TO REDUCE JORDAN'S DEBT BURDEN AND HELP BRING THE TANGIBLE BENEFITS OF PEACE TO THE MIDDLE EAST.
