FEDERAL MINISTER OF FINANCE

DEAR EXCELLENCY,
WE SHARE YOUR HOPES FOR A COMPREHENSIVE PEACE IN THE MIDDLE EAST AND THE ROLE THE HASHEMITE KINGDOM OF JORDAN AND ISRAEL HAVE TO PLAY IN THIS HISTORIC SITUATION. IT WAS IN THIS UNDERSTANDING THAT I GAVE THE INSTRUCTION TO THE AUSTRIAN DELEGATION IN THE PARIS CLUB RESCHEDULING NEGOTIATIONS ON JORDAN'S DEBT TO ACT POSITIVELY TOWARDS A MUTUALLY ACCEPTABLE REPAYMENT SCHEME. THE FINAL SOLUTION REACHED IN PARIS ON JUNE 28, 1994 ON A RESCHEDULING COVERING USD 1,147 MILLION SHOWED THAT YOUR APPROACH TO ENCOURAGE ALL CREDITOR COUNTRIES TO WORK OUT A SATISFACTORY RESCHEDULING WAS SUCCESSFUL. PRESENTLY PREPARATIONS ARE GOING ON IN VIEW OF THE BILATERAL IMPLEMENTATION OF THE AGREED MINUTE REACHED IN PARIS THUS SUPPORTING JORDAN'S EFFORTS TO RESTORE ITS ECONOMY AND FULL ACCESS TO CAPITAL MARKETS.
