2. ECONCOUNS PRESENTED THE TEXT OF THE DEBT RELIEF AGREEMENT TO MINISTRY OF FINANCE SECRETARY GENERAL SULIEMAN HAFEZ AND DIRECTOR OF THE EXTERNAL PAYMENTS DEPARTMENT SODQI ABDEL HADI ON SEPTEMBER 19. ABDEL HADI QUESTIONED THE LOAN AMOUNTS GIVEN IN ANNEX A AND REQUESTED CLARIFICATION AS TO HOW INTEREST INCURRED AFTER JUNE 30 IS TO BE TREATED. 1. SINCE REFTTEL, THE SUBJECT OF KUWAIT'S RESUMPTION OF TIES WITH JORDAN SPECIFICALLY, AND WITH OTHER PRO-IRAQI ARAB COUNTRIES BY INFERENCE, HAS RECEIVED EXTENSIVE EDITORIAL COVERAGE. KUWAITI EDITORIAL WRITERS HAVE REACTED IN PART TO COMMENTS COMING OUT OF JORDAN REGARDING THE KUWAITI-JORDANIAN RELATIONSHIP. OVERALL, THERE APPEARS TO BE AN EMERGING CONSENSUS THAT UPGRADING OF FORMAL TIES MAY BE INEVITABLE, BUT THAT THE RELATIONSHIP CAN NEVER ASSUME ITS PRE-IRAQI INVASION WARMTH. EXAMPLES FOLLOW OF EDITORIAL COMMENT.

2. 9/10 IN AL-WATAN: "I BELIEVE THAT KEEPING THE KUWAITI PUBLIC OPINION BRIEFED ON DEVELOPMENTS IN THE RELATIONS BETWEEN KUWAIT AND THE COUNTRIES THAT SUPPORTED THE IRAQI OCCUPATION OF THE COUNTRY IS A MUST. . .KUWAITI PUBLIC OPINION MUST BE INVOLVED IN THE STATE'S POLITICAL MOVES SO THAT IT WOULD BE PSYCHOLOGICALLY PREPARED FOR ANY "FUTURE STEPS" AND TO CEMENT RELATIONS BETWEEN THE GOVERNMENTAL DECISIONS AND THE POPULAR VISIONS."
