1. ISRAELIS HAVE REACTED WITH DELIGHT TO THE OCTOBER 17 INITIALING OF A PEACE TREATY BETWEEN ISRAEL AND JORDAN. THE AGREEMENT SHOULD GET PROMPT, OVERWHELMING SUPPORT IN THE KNESSET EVEN BEFORE THE FORMAL SIGNING CEREMONY NEXT WEEK. HOWEVER, BECAUSE PROGRESS ON THE JORDANIAN TRACK HAS ALMOST BECOME COMMONPLACE IN RECENT MONTHS -- AND BECAUSE ISRAEL HAS BEEN IN A DE FACTO PEACE WITH JORDAN FOR A QUARTER CENTURY --THERE HAS BEEN NO PUBLIC OUTPOURING. THAT MAY COME NEXT WEEK WITH THE SIGNING CEREMONY AND ATTENDANT EVENTS, WHICH WILL ALSO HIGHLIGHT SYRIA AS THE PEACE PROCESS HOLDOUT.

QUICK APPROVAL

2. UNLIKE LAST YEAR'S DECLARATION OF PRINCIPLES WITH THE PALESTINIANS OR A FUTURE AGREEMENT WITH SYRIA, PEACE WITH JORDAN HAD BEEN EXPECTED TO COST LITTLE AND TO GAIN MUCH. WHILE THE FULL TEXT OF THE AGREEMENT HAS NOT EMERGED, THE BROAD OUTLINES SEEM TO CONFIRM THIS:

- ISRAEL RETURNED SOME LAND, BUT EVEN IN THIS CASE MANAGED TO PROTECT ISRAELI FARMERS BY NEGOTIATING A LEASING ARRANGEMENT FOR AT LEAST 25 YEARS.
- ISRAEL WILL SHARE WATER RESOURCES WITH JORDAN, BUT THE AGREEMENT EVIDENTLY EMPHASIZES DEVELOPMENT OF NEW RESOURCES AS WELL AS

REDISTRIBUTING CURRENT SUPPLIES.

- THE TWO SIDES AGREED ON SECURITY PRINCIPLES THAT WILL RULE OUT JORDAN'S USE AS A BASE FOR MILITARY OPERATIONS AGAINST ISRAEL --
FULFILLING ISRAEL'S LONGSTANDING DESIRE FOR A GLACIS AGAINST ATTACK FROM THE EAST.

3. "THE MAIN REASON FOR THE FAVORABLE ISRAELI RESPONSE TO THE DEAL," COMMENTED THE JERUSALEM POST, "IS THAT ITS COSTS ARE RELATIVELY REASONABLE."

4. THE AGREEMENT WON QUICK APPROVAL FROM THE CABINET THE EVENING OF OCTOBER 17. BASED ON CONTACTS WITH OPPOSITION LEADERS IN THE KNESSET, A SENIOR LABOR MK PREDICTED TO US THAT THE KNESSET WOULD "AFFIRM" THE TREATY ON OCTOBER 24 OR 25 BY MORE THAN 100 VOTES (A KNESSET VOTE REGARDING JORDAN EARLIER THIS YEAR WON MORE THAN 90 VOTES IN THE 120-MEMBER KNESSET).

AN EYE TOWARD SYRIA

5. ASKED WHETHER THE AGREEMENT WITH EGYPT (IN WHICH ISRAEL EVACUATED AND RETURNED ALL OF THE SINAI) OR JORDAN (WITH ITS LAND SWAPS AND LEASING ARRANGEMENTS) WOULD SERVE AS THE MODEL FOR AN ISRAEL-SYRIA AGREEMENT, FOREIGN MINISTER PERES DESCRIBED THE JORDAN AGREEMENT AS "MORE REASONABLE...JORDAN HAS NOT BEEN DEPRIVED OF ONE INCH OF ITS LAND. USING AN ASSAD PHRASE WHICH HE HAS BEGUN TO PLAY BACK TO THE SYRIAN PRESIDENT ASAD, RABIN SPOKE DURING THE JOINT PRESS CONFERENCE IN AMMAN OCTOBER 17 OF "PEACE WITH DIGNITY, DIGNITY TO BOTH SIDES." RABIN ALSO STRESSED THAT THE AGREEMENT FEATURED "RECTIFICATIONS" OF THE BORDER WHICH DID NOT DISADVANTAGE JORDAN -- "NOBODY LOST, EVERYBODY WON."

IN THIS REGARD, ISRAELI WATER COMMISSIONER GID'ON TZUR AND FORMER AGRICULTURE MINISTER AVRAHAM KATZ-OR (WHO HEADS ISRAEL'S DELEGATION TO THE MULTILATERAL WATER RESOURCES

WORKING GROUP) HAVE DEPAR
TED FOR EUROPE TO SECURE
FUNDING FOR THE TWO DAMS, AND RABIN IS LIKELY TO
PRESS FOR EUROPEAN UNION ASSISTANCE IN HIS MEETINGS

1. ISSUE: TRANSLATING A POLITICAL PEACE WITH ISRAEL
INTO NORMALIZED RELATIONS WITH ISRAELIS

DISCUSSION: JORDANIANS BY AND LARGE ACCEPT KING
HUSSEIN'S LEADERSHIP IN CONCLUDING A PEACE TREATY

THE RISE IN LIVING STANDARD -- THE POPULARLY DESIRED
"PEACE DIVIDEND" -- WILL BE DELIVERED THROUGH
ECONOMIC CONTACT AND TRADE, NOT THROUGH AID.

-- OTHER QUALITY OF LIFE ISSUES LIKE POLLUTION,
COPING WITH NATURAL DISASTERS AND STRENGTHENING OF
CULTURAL LIFE CAN ONLY BE ENHANCED BY PEOPLE TO
PEOPLE CONTACT AMONG ARABS, ISRAELIS AND OTHERS IN

THE EASTERN MEDITERRANEAN REGION.

2. ISSUE: PERSUADING JORDANIANS THAT THEY CAN ACHIEVE ECONOMIC GROWTH WITHOUT BEING OVERWHELMED BY WHAT THEY PERCEIVE AS THE ISRAELI ECONOMIC JUGGERNAUT.

DISCUSSION: JORDANIANS CITE THE DISPARITY IN SIZE BETWEEN THEIR ECONOMY AND THE ISRAELI ECONOMY AND FEAR THAT JORDAN WILL BE SWALLOWED BY ISRAEL ECONOMICALLY AS WELL AS IN OTHER SPHERES.

HOW TO ADDRESS:

-- PRESIDENT'S COMMENTARY SHOULD STRESS THAT A RISING TIDE CARRIES ALL SHIPS ECONOMICALLY. THE PEACE PROCESS BRINGS GREAT POTENTIAL FOR ECONOMIC GROWTH TO THE REGION.

-- JORDAN STAUNCHLY DEFENDED AND SUCCESSFULLY UPHELD ITS INTERESTS IN THE POLITICAL NEGOTIATIONS LEADING TO THE PEACE TREATY THEREBY GAINING THE TERRITORIAL AND WATER RIGHTS IT BELIEVED WERE ITS DUE. THERE IS NO REASON THE SAME ABILITY TO DEFINE JORDANIAN INTERESTS AND NEGOTIATE SUCCESSFULLY WILL NOT OBTAIN IN OTHER SPHERES SUCH AS ECONOMY AND CULTURE.

--CURRENTLY THERE IS A BROAD BASED INTERNATIONAL EFFORT TO PROMOTE ECONOMIC COOPERATION IN THE REGION AND THE INTERNATIONAL COMMUNITY IS WELL AWARE OF THE EXISTING ECONOMIC DISPARITIES.

3. ISSUE: CHALLENGING PERCEPTION THAT AMERICANS VILIFY ALL MOSLEMS DUE TO THE VIOLENT ACTS AND RHETORIC OF A FEW EXTREMISTS.

DISCUSSION: JORDANIANS LED BY CROWN PRINCE HASSAN, HAVE BEEN AT THE FOREFRONT OF EFFORTS IN THE MUSLIM WORLD TO PRESENT THE MODERATION THAT PREVAILS AMONG THE VAST MAJORITY OF MUSLIMS. THE CROWN PRINCE HAS ALSO RAISED A CRY FOR MORE PROFOUND MOSLEM UNDERSTANDING OF CHRISTIANITY AND JUDAISM.

HOW TO ADDRESS:

-- DURING HIS SPEECH TO THE JORDANIAN PARLIAMENT, THE PRESIDENT SHOULD STRESS THE VITALITY OF INTERFAITH ENCOUNTER IN THE UNITED STATES INCLUDING OUR GROWING MUSLIM POPULATION.

-- HE SHOULD REITERATE THAT OUR FIGHT IS AGAINST RELIGIOUSLY MOTIVATED OR OTHER VIOLENT EXTREMISM -- NOT AGAINST ISLAM WHICH IS ONE OF THE WORLD'S LARGEST AND MOST RESPECTED CREEDS.

4. ISSUE: REFUTING JORDANIAN ACCUSATIONS THAT THE U.S. IS ENGAGED IN SYSTEMATIC STARVATION OF THE IRAQI PEOPLE THROUGH ENFORCEMENT OF U.N. SANCTIONS.

DISCUSSION: WHILE JORDANIANS INCREASINGLY VILIFY

SADDAM HUSSEIN, THEY BLAME THE PERCEIVED PLIGHT OF THE IRAQI PEOPLE ON THE U.S. THEY BELIEVE THAT WE ARE SINGLE HANDEDLY BLOCKING RELAXATION OF THE UNSC SANCTIONS REGIME.
