A. EMBASSY SECURITY IS AN ISSUE OF PARAMOUNT CONCERN IN JORDAN AND ELSEWHERE. IT IS AN ISSUE WE DISCUSS REGULARLY WITH JORDANIAN GOVERNMENT AUTHORITIES, WHO TAKE THEIR OBLIGATIONS UNDER INTERNATIONAL AGREEMENTS SERIOUSLY.
