SUMMARY

1. AS REFTTEL NOTES, TRADE RELATIONS BETWEEN THE U.S. AND JORDAN HAVE BEEN HIGHLIGHTED BY THE SIGNING OF THE JORDAN-ISRAEL PEACE TREATY, PRESIDENT CLINTON'S SUGGESTION BEFORE THE JORDANIAN PARLIAMENT TO CONSIDER NEGOTIATING A U.S.-JORDAN BILATERAL INVESTMENT TREATY (BIT), AND REP. GEPHARDT'S LETTER TO PRESIDENT CLINTON ON THE EXPANSION OF THE U.S.-ISRAEL FREE TRADE AREA AGREEMENT (FTAA) TO THOSE COUNTRIES REACHING A COMPREHENSIVE PEACE WITH ISRAEL. MEANWHILE, PURSUANT TO ARTICLE 7(2)(B) OF THEIR PEACE TREATY, JORDAN AND ISRAEL ARE WORKING TO CONCLUDE WITHIN SIX MONTHS A BILATERAL ECONOMIC COOPERATION AGREEMENT WHICH WILL ADDRESS TRADE AND THE ESTABLISHMENT OF A FREE TRADE AREA, INVESTMENT, BANKING, INDUSTRIAL COOPERATION, AND LABOR ISSUES. THESE INITIATIVES ARE ALL MOVING

FORWARD AS JORDAN IS NEGOTIATING ITS ACCESSION TO WTO/GATT. THIS MESSAGE WILL LAY OUT THE INITIAL STEPS IN DEVELOPING A COHERENT STRATEGY AND PRIORITIES FOR OUR TRADE RELATIONS WITH JORDAN IN THE CONTEXT OF THESE DEVELOPMENTS. END SUMMARY.

JORDAN'S ACCESSION TO WTO/GATT

2. AMONG OUR TOP PRIORITIES IN ENGAGING THE GOJ ON TRADE SHOULD BE ITS ACCESSION TO WTO/GATT. JORDAN'S ACCESSION TO WTO/GATT WOULD ENABLE IT TO BOTH BROADEN AND DEEPEN ITS TRADE RELATIONS WITH OTHER WTO/GATT MEMBERS, INCLUDING THE U.S. AND ISRAEL. IT WOULD FACILITATE POTENTIAL NEGOTIATIONS ON A BILATERAL IPR AGREEMENT WITH THE U.S. AND HELP WITH THE DISCUSSION OF PROPOSALS LIKE AN EXPANDED U.S.-ISRAEL FTAA OR A BILATERAL OR REGIONAL FTA WITH THE U.S. CURRENTLY, A MEMORANDUM ON THE GOJ'S FOREIGN TRADE REGIME IS CIRCULATING FOR COMMENT AND QUESTIONS AMONG WTO/GATT MEMBERS.

BILATERAL INVESTMENT TREATY (BIT) AND INTELLECTUAL
PROPERTY RIGHTS (IPR) AGREEMENT

3. IN TANDEM WITH EFFORTS TO ENCOURAGE GOJ ACCESSION TO WTO/GATT, WE ARE PROVIDING THE GOJ WITH INFORMATION ON A BILATERAL INVESTMENT TREATY (BIT) WITH THE U.S. IN HIS SPEECH BEFORE THE JORDANIAN PARLIAMENT, PRESIDENT CLINTON OFFERED TO CONSIDER A U.S.-JORDAN BILATERAL INVESTMENT TREATY (BIT). A BIT PUTS INVESTORS OF THE COUNTRIES INVOLVED ON AN EQUAL FOOTING AND PROVIDES THEM WITH GREATER PROTECTION, DISPUTE RESOLUTION MEASURES, AND ENFORCEMENT. ITS PROVISIONS ARE STRONGER THAN THOSE AVAILABLE UNDER WTO/GATT.

U.S. BITS PROVIDE SIX BASIC GUARANTEES FOR INVESTORS:

-- THE BETTER OF NATIONAL OR MOST FAVORED TREATMENT ON ESTABLISHMENT AND THEREAFTER, SUBJECT TO CERTAIN LIMITED AND SPECIFICALLY DESCRIBED EXCEPTIONS IN ANNEXES OR PROTOCOLS OF TREATIES;

-- EXPROPRIATION ONLY IN ACCORDANCE WITH INTERNATIONAL LAW STANDARDS AND UPON PAYMENT OF PROMPT, ADEQUATE AND EFFECTIVE COMPENSATION;

-- THE RIGHT TO TRANSFER ALL FUNDS RELATED TO AN INVESTMENT WITHOUT DELAY USING A MARKET RATE OF EXCHANGE;

-- PROHIBITION OF PERFORMANCE REQUIREMENTS, SUCH AS LOCAL CONTENT REQUIREMENTS OR EXPORT QUOTAS;

-- THE RIGHT TO SUBMIT AN INVESTMENT DISPUTE WITH THE TREATY PARTNER'S GOVERNMENT TO INTERNATIONAL ARBITRATION. THERE IS NO REQUIREMENT TO USE THAT COUNTRY'S DOMESTIC COURTS; AND

-- THE RIGHT TO ENGAGE TOP MANAGERIAL PERSONNEL OF THEIR CHOICE, REGARDLESS OF NATIONALITY.

4. THE U.S. NORMALLY NEGOTIATES AN INTELLECTUAL PROPERTY RIGHTS (IPR) AGREEMENT IN PARALLEL WITH NEGOTIATIONS ON A

BIT. IPR AGREEMENTS ARE GENERALLY EASIER TO CONCLUDE WITH WTO/GATT MEMBERS, AS THEY HAVE ALREADY AGREED TO ADHERE TO CERTAIN STANDARDS. SEE PARAS 8-12 FOR ADDITIONAL BACKGROUND AND TALKING POINTS WHICH POST MAY USE IN ORDER TO ENGAGE THE GOJ IN A DISCUSSION OF THE BIT AND IPR PROPOSALS.

FREE TRADE AGREEMENT

5. USTR IS CHAIRING AN INTERAGENCY REVIEW OF TRADE ALTERNATIVES IN THE REGION. AT THIS POINT, THE EXPANSION OF THE U.S.-ISRAEL FTAA OR THE CREATION OF NEW BILATERAL OR REGIONAL FTAS ARE PROPOSALS WHICH WOULD BEST BE SEQUENCED LATER, PERHAPS ONCE JORDAN HAS ACCEDED TO WTO/GATT AND/OR UNDERTAKEN NEGOTIATIONS ON A BIT OR IPR AGREEMENT.

6. MEANWHILE, JORDAN'S NEGOTIATIONS ON ECONOMIC COOPERATION WITH ISRAEL WILL BE OF MAJOR INTEREST TO US. WE UNDERSTAND THAT THE GOI AND GOJ HAVE A COOPERATIVE TRADE ZONE PROPOSAL ON THE TABLE. AS THIS PROPOSAL IS DISCUSSED, IT SHOULD BE NOTED THAT, UNDER THE U.S.-ISRAEL FTAA RULES OF ORIGIN, ONLY PRODUCTS OF ISRAEL WILL RECEIVE DUTY FREE TREATMENT BY THE U.S.

WHERE WE GO FROM HERE

7. USTR IS SENDING SEPARATELY BACKGROUND, TALKING POINTS, AND PROTOTYPE TEXTS FOR THE PROPOSED BIT AND IPR AGREEMENTS FOR THE POST TO SHARE AND DISCUSS WITH THE GOJ OFFICIALS. EMBASSY SHOULD RELAY TO US QUESTIONS OR COMMENTS AND REPORT ON GOJ INTEREST AND READINESS TO ENGAGE IN BIT AND IPR NEGOTIATIONS. POST WILL ALSO BE REQUESTED TO PROVIDE ITS OWN ASSESSMENT OF THE GOJ'S READINESS AND ABILITY TO TAKE ON THE OBLIGATIONS CONTAINED IN THE TWO AGREEMENTS.
