1. EXCEPT FOR A TINY ATTIC CPU AREA, EMBASSY BRATISLAVA OFFICE SPACE IS ENTIRELY UNCLASSIFIED. PROCESSING OF INCOMING AND OUTGOING UNCLASSIFIED TRAFFIC IS RELIABLE. PROCESSING OF CLASSIFIED TRAFFIC IS EXTREMELY LABOR-INTENSIVE FOR PREPARATION, TRANSMISSION AND RECEIPT OF TELEGRAMS. SUPPLIES AND VEHICLES ARE LIMITED. EMBASSY WILL PROVIDE THE BEST POSSIBLE ADMINISTRATIVE ACCOMMODATIONS, WITHIN OUR CAPABILITIES.
2. PER REF (B), GIVEN THE VERY BRIEF TIME THE DELEGATION WILL BE IN BRATISLAVA AND OUR LIMITED FACILITIES, EMBASSY RECOMMENDS THAT AFTER CHECKING CABLE TRAFFIC ON ARRIVAL DELEGATION STAFF MEMBERS USE THEIR TIME HERE FOR THREE HOURS OF RECREATION, BRINGING ONLY A MINIMUM OF OFFICE MATERIALS IN TO THE EMBASSY, WITH NO CLASSIFIED IF AT ALL POSSIBLE.
