[FBIS Transcribed Text] PRAGUE, 15 Sep (CTK) -- Strengthening political and economic relations and presenting the Czech Republic is the primary goal of Czech President Vaclav Havel's official visit to South America, on which he left this morning.

Havel is accompanied by Vladimir Dlouhy, Industry and Trade Minister, and Deputy Foreign Minister Alexandr Vondra. Josef Tosovsky, Czech National Bank Governor, who also was to accompany Havel, did not leave with the president due to a situation surrounding the Kreditni banka Plzen's bankruptcy.

Finance Minister Ivan Kocarnik will join the delegation on the way.

Havel is the first head of the Czech state to visit Brazil, Chile, Uruguay and Argentina. "It is the first visit by the head of our state to this continent," Havel told journalists before the departure.

He said the visit was part of his long-term plan to visit all continents during his term of office.

Havel said the Czech Republic and South American countries had many things to discuss as all of them are returning to liberal economy and democracy.

"The primary goal of the visit is to strengthen political relations and present the Czech Republic, which will be a basis for economic cooperation," Havel said.

He said this visit, like many of his previous ones, also had a "global, planetary and spiritual" sense as he wanted to pay homage

to the spiritual roots of South American civilisation.

"I consider it very important as I have said many times that I do not only feel to be a representative of the Czech Republic but also an inhabitant of this planet who thinks about its situation, prospects, hopes and dangers," Havel said.

"Civilization is globally interconnected and it is necessary to find mutual understanding and to look into the spiritual life of other continents," Havel said.

In all the four countries Havel is to meet their presidents, on whose invitations his visit takes place, and leading representatives of local governments and parliaments. In Brazil he will also meet representatives of two federal states -- Sao Paulo and Rio de Janeiro, and leaders of the city of Manaus.

As the first statesman from outside Latin America, Havel will deliver a speech in the Latin American Parliament's seat in Sao Paulo. The speech is to center on the global situation and its outlook after the year 2000, and on the role of continents in global developments.

Havel will also attend business forums which are to begin in Sao Paulo, Santiago de Chile, Montevideo and Buenos Aires. In Chile Havel will be joined by Kocarnik and Dlouhy.

Three economic documents are to be signed during the visit: a Czech-Argentinian and Czech-Uruguayan agreement on the protection of investments, and a Czech-Uruguayan trade agreement.

Havel is also expected to meet Brazilian Indians living in the tropical rain forest of the Amazon basin. Another of Havel's meeting with aborigines will take place on Easter Island, where he makes a stop over at the request of the Chilean president.

Havel will meet ethnic Czechs in Brazil, Chile and Argentina.

[FBIS Transcribed Text] Brasilia, Sept 16 (CTK) -- President Vaclav Havel arrived here last night to start his state visit to Brazil.

Brazil is the first country on his week-long tour of South America during which Havel will also visit Chile, Uruguay and Argentina.

Havel is accompanied by Industry and Trade Minister Vladimir Dlouhy and First Deputy Foreign Minister Alexandr Vondra. Deputy Premier and Finance Minister Ivan Kocarnik will join the delegation in Chile.

Czech National Bank Governor Josef Tosovsky, who was also to accompany Havel, has cancelled his visit so far due to the investigation of the Kreditni banka Plzen's (Krb) collapse.

Havel will start an official part of his visit to Brazil this morning. After meeting President Fernando Henrique Cardoso to discuss strengthening Czech-Brazilian relations Havel is expected to give a press-conference.

In the afternoon Havel will visit a monument to former Brazilian president of Czech origin Juscelin Kubitschek, who served between 1956-1961.

In the evening Havel will be presented by the Rio Branco Order and will hand in to his Brazilian counterpart a document on awarding of the T.G.Masaryk Order to Kubitschek in memoriam.

During his stay in Brazil (September 15-21) Havel also plans to meet representatives of Sao Paulo and Rio de Janeiro states, and leaders of the city of Manaus.

As the first statesman from outside Latin America, Havel will deliver a speech in the Latin American Parliament's seat in Sao Paulo. The speech is to centre on the global situation and its outlook after the year 2000, and on the role of continents in global developments.

Havel is also expected to visit an Indian reserve in the Amazon

and a Brazilian city named after the Czech Republic town of Lidice that was destroyed by the Nazis in the Second World War.

[FBIS Translated Text] President Fernando Henrique Cardoso on 16 September received Czech President Vaclav Havel in Planalto Palace. They did not sign any bilateral agreement between the two countries during their meeting. Trade between Brazil and the Czech Republic reached \$92.5 million during the first half of the year, with a \$48 million surplus for Brazil. The main Brazilian products exported to the Czech Republic are food, like soy bean, coffee, chicken, and orange juice. In turn, Brazil imports industrial and agricultural machinery from the Czech Republic.

This country was born in December 1992 following the split of Czechoslovakia. Since then, the Czech Republic has registered the smallest unemployment rate in the world and it is currently undergoing an intense privatization process.

During the meeting, Vaclav Havel gave President Fernando Henrique Cardoso a book he wrote entitled: "Letters to Olga." President Cardoso also gave him a book he wrote entitled: "Independence and Economic Development in Latin America."

The president of the Czech Republic later pointed out the need for a broad reform of the United Nations. Soon after the meeting with President Cardoso, President Havel gave a news conference in Itamaraty Palace. He said that he shares the same ideas of President Cardoso and he pointed out the need for a broad reform in the United Nations, the Security Council of which no longer corresponds to international reality.

In the economic field, Czech Industry and Commerce Minister Vladimir Dlouhy reported that a consortium between the two countries will be created to open a Czech truck factory in Brazil. According to him, eight Brazilian states, including Rio de Janeiro and Sao Paulo, are participating in the agreement. Today at 2030, President Cardoso and Mrs. Ruth Cardoso will offer a dinner to President Havel in Itamaraty Palace.

Tomorrow morning, President Havel will visit Senate President Jose Sarney and Chamber of Deputies President Luis Eduardo Magalhaes. Soon after, he will depart for Manaus. On 21 September, the Czech president will visit Lidice, a city located 25 km away from Angra dos Reis Bay in Rio de Janeiro State. Lidice owes its name to a Czech town that was destroyed by the Germans during the Second World War.

- b(4) Release would disclose trade secrets or confidential or financial information [(b)(4) of the FOIA]
- b(6) Release would constitute a clearly unwarranted invasion of personal privacy [(b)(6) of the FOIA]
- b(7) Release would disclose information compiled for law enforcement purposes [(b)(7) of the FOIA]
- b(8) Release would disclose information concerning the regulation of financial institutions [(b)(8) of the FOIA]
- b(9) Release would disclose geological or geophysical information concerning wells [(b)(9) of the FOIA]
