3. THE ATTORNEY GENERAL HAS AUTHORIZED WAIVERS OF
INELEGIBILITIES FOR SUBJECTS. EMBASSY IS AUTHORIZED TO
ISSUE EACH SUBJECT A ONE-ENTRY B-2 VISA, VALID UNTIL
SEPTEMBER 4.

4. PRIOR TO ISSUANCE OF VISAS, EMBASSY SHOULD OBTAIN
ITINERARY FOR PLANNED TRIP, MAKE KNOWN THE FOLLOWING
CONDITIONS TO SUBJECTS, AND OBTAIN THEIR AGREEMENT TO
THEM: WE WOULD REQUIRE THE IMMEDIATE DEPARTURE OF
SUBJECTS IF (1) THEY ENGAGE IN FUNDRAISING ACTIVITIES
(2) THEY DEVIATE FROM THE ITINERARY WHICH THEY SUPPLIED
TO THE EMBASSY, OR (3) THE ANTICIPATED ANNOUNCEMENT BY
THE IRA DOES NOT REFLECT A COMMITMENT TO THE TOTAL
CESSATION OF VIOLENCE. IN ANY EVENT, THEIR DEPARTURE

2. PRIOR TO ISSUANCE OF VISAS, EMBASSY OBTAINED FOLLOWING ITINERARY FOR THE PLANNED TRIP: NEW YORK AREA, INCLUDING LONG ISLAND, CONNECTICUT, HARTFORD, ALBANY AND NEW JERSEY; BOSTON; PHILADELPHIA; AND CHICAGO. 1. CAHILL, JOSEPH (2/19/20, NORTHERN IRELAND, UK) 212
(A) (2) (3) (6); AND TRAINOR, PATRICK 212 (A) (2) (3).
2. PURSUANT TO THE TERMS OF SECTION 212 (A) (2) (3) (6),
WAIVER ISSUED TO SUBJECTS ON AUGUST 30, 1994, SUBJECTS
WERE ADMITTED TO THE UNITED STATES FOR A PERIOD OF FIVE
DAYS. NOW THAT THE IRA HAVE COMPLETED CEASED ALL
MILITARY ACTIVITIES AND THE CAHILL/TRAINOR VISIT HAS
REPORTEDLY BEEN EXTREMELY SUCCESSFUL IN CONVINCING IRA
SUPPORTERS IN THE U.S. TO BACK THE PERMANENT CESSATION OF
VIOLENCE, THE IRISH GOVERNMENT HAS ASKED THAT SUBJECTS BE
ALLOWED TO REMAIN IN THE UNITED STATES AN ADDITIONAL TEN
DAYS. THEY WOULD ONLY ADD SAN FRANCISCO, LOS ANGELES AND
SAN DIEGO TO THEIR ITINERARY ALREADY REPORTED REF A.
3. AS THE PRESIDENT HAS STATED HIS FIRM COMMITMENT TO
ASSIST THE GOVERNMENTS OF IRELAND AND GREAT BRITAIN TO
BRING PEACE TO NORTHERN IRELAND, DUBLIN REQUESTS THAT
STATE TAKE NECESSARY ACTION TO EXTEND THE SUBJECTS'
AUTHORIZED STAY IN THE UNITED STATES THRU SEPTEMBER 19.
IT IS ALSO REQUESTED THAT THE DEPARTMENT LIAISE WITH INS
IN ORDER THAT APPROPRIATE ADMINISTRATIVE ACTIONS (I.E.,
FILING OF I-539 APPLICATION, EXTENSION OF STAY
ENDORSEMENT ON I-94) ARE TAKEN IMMEDIATELY.
4. PLEASE ADVISE BY NIACT IMMEDIATE TELEGRAM OR
TELEPHONICALLY WHETHER THE EMBASSY OR THE IRISH
GOVERNMENT NEED TO PROVIDE ANY ADDITIONAL INFORMATION TO

212(A)(2)(B), 212(A)(3)(B), AND 212(A)(6)(C) FOR JOSEPH
CAHILL, DPOB: MAY 19, 1920, IRELAND.

2. THE DEPARTMENT HAS NO OBJECTION TO ISSUANCE OF A B-2
VISA VALID FOR ONE ENTRY WITHIN THREE MONTHS FOR THE
PURPOSES STATED IN REFTEL B). THE VISA SHOULD BE
ANNOTATED TO REFLECT THE 212(D)(3)(A) WAIVERS GRANTED BY
INS/CO. IT SHOULD ALSO BE ANNOTATED TO REFLECT THE
PROPOSED PURPOSE OF TRAVEL AND THE REQUESTED LENGTH OF
STAY, AND INDICATE THAT NO DEVIATION FROM THE PROPOSED
ITINERARY WILL BE POSSIBLE WITHOUT APPROVAL FROM
INS/HQ - INSPECTIONS. FURTHERMORE, THE VISA SHOULD BE
ANNOTATED TO INDICATE THAT APPLICANT IS NOT TO ENGAGE IN
DIRECT OR INDIRECT FUND-RAISING.

3. POST SHOULD REFER TO REFTEL C) FOR GUIDANCE ON THE

DEFINITION OF FUND-RAISING. THE PROHIBITION ON DIRECT
OR INDIRECT FUND-RAISING SHOULD BE UNDERSTOOD AS FOLLOWS:

- THE ALIEN IS NOT TO SOLICIT OR ACCEPT FUNDS.
- THE ALIEN IS NOT TO ATTEND OR PARTICIPATE IN ANY
