Gore-AIDS Award,330

Gore seeks improved access to Medicaid for AIDS patients

WASHINGTON (AP) Hoping to improve access to AIDS-fighting
drugs, the Clinton administration is exploring the possibility of
expanding Medicaid coverage for people afflicted with HIV, the
virus that causes AIDS.

Vice President Al Gore has asked the Health Care Financing Administration ``to look into the possibility" of making Medicaid available earlier to people with HIV to get them the cutting-edge drugs needed to help them.

``If it works out, as I hope and expect it will, it can ease suffering, renew hope and help ensure that good people are not priced out of lifesaving medicine," Gore said Wednesday.

He said the move was necessary because people diagnosed with HIV can develop full-blown AIDS before becoming eligible for Medicaid, ``and that makes some of these new drugs prohibitively expensive for people who need them."

Gore made the announcement after receiving the 1997 National Leadership Award for Public Service from AIDS Action, an AIDS advocacy group. He said he has asked the HCFA to report back to him in 30 days after exploring the possibility.

``Our view is that getting these drugs to people earlier will not cost more in the long run," he said. ``It may even save money, and it will certainly save lives."

Gore, who accepted the award jointly with his wife, Tipper, said there is good reason for optimism in the war on AIDS because of ``remarkable progress" in finding effective drugs to combat the deadly disease.

``The cumulative understanding of the virus in all its different aspects has now reached the point where, for the first time, we know more about it than it knows about us, and that's an important turning point," he said.

But, he cautioned, ``We've got a long way to go before we beat

this monster. We're just now beginning to see the way to do it."

VICE PRESIDENT ANNOUNCES NEW STEPS TO PROVIDE EXPANDED MEDICAID DRUG COVERAGE FOR PEOPLE WITH HIV/AIDS

WASHINGTON-- The Vice President tonight directed the Health Care Financing Administration (HCFA) and Office of National Aids Policy to determine the feasibility of establishing a demonstration to permit earlier Medicaid coverage of patients with HIV/AIDS. This demonstration would enable people with HIV/AIDS to access coverage of new drug interventions including protease inhibitors, which often delays the onset of symptoms that are much more expensive and difficult to treat. The demonstration is being designed to determine if earlier access to Medicaid coverage not only improves the health and well being of people with AIDS, but also reduces long-term health care costs.

Today, HIV/AIDS patients have to wait until they become sick enough to qualify for Medicaid through a disability determination. As a result, they often cannot afford the protease inhibitors that appear to have great potential to extend healthy working careers, thus delaying costly health care services that become necessary to treat HIV/AIDS in the later stages of the disease. The action by the Vice President today clears the way to a more compassionate and potentially cost-effective Medicaid program for people with HIV/AIDS. The Vice President has asked HCFA to report back to him within the next 30 days.

"This can be a very important step. The expanded coverage can ease suffering, renew hope, and ensure that good people are not priced out of

life saving medicine," said Vice President Gore.

The Vice President's announcement came at the AIDS Action dinner where he and Mrs. Gore received the National Leadership Award for Public Service.

Under the Clinton Administration, the FDA has speeded up the approval process which has led to the approval of 8 new AIDS drugs and 19 drugs for AIDS related conditions. Investments in AIDS research, prevention, and services increased by 60 percent and Ryan White care funding increased by 158 percent.

A year ago, the Vice President brought together representatives of the major pharmaceutical companies and leading government researchers to begin mapping a strategy for finding and developing more AIDS therapeutics, microbicides, and ultimately, a vaccine. These meetings led to the establishment of the Forum for Collaborative HIV Research -- an unprecedented partnership between drug companies, the government, advocates and insurance companies -- to optimize the use of the new drug therapies. Because of this successful collaboration, the Vice President will continue to build these partnerships to strengthen our fight against AIDS.
