Dear Mr. President:

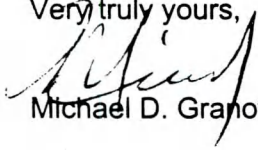
Several years after serving on your Transition Team in 1992, I founded a private equity investment firm called Pomona Capital. Pomona Capital is now five years old and has grown from \$45 million in capital to over \$475 million. We run the business out of New York and recently began operations in London and Tokyo.

On May 19th, 1999 we are having an event to celebrate our fifth anniversary at Carnegie Hall in New York. While I know how difficult your schedule is, I would be honored to have you attend and speak. The attendees will be several hundred business people active in all facets of the global private equity industry.

On another matter, I have some familiarity with the situation in Kosovo serving as your appointee on the Board of Directors of the Albanian American Enterprise Fund. I have been to Albania many times and have seen first hand the situation on the ground. I can tell you that your approach is vitally necessary, and will likely require a considerable and extended effort. As you well know, the issues are deep and deep seated.
