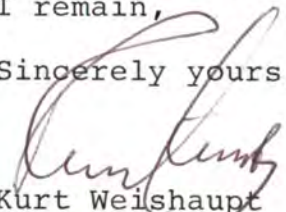
I'm also adding two journals of the Gift of Life and one from the Rotary, for your information.
