Latvian Foreign Minister Andreev will be in Washington on April 8 to meet with Secretary Christopher (10:30am). We request that you hold a separate 30 minute meeting with him on April 8. Andreev will want to discuss the results of the President's summit with Yeltsin and the implications of U.S. relations with Russia for Latvia and the other Baltic states. Andreev in particular will be seeking assurances that Latvia's stability and security is important to us. While reassuring Andreev will be the centerpiece of the meeting agenda, it also is an opportunity to talk tough about the rights of the Russian population in Latvia -- a very sore subject with the Russians.
