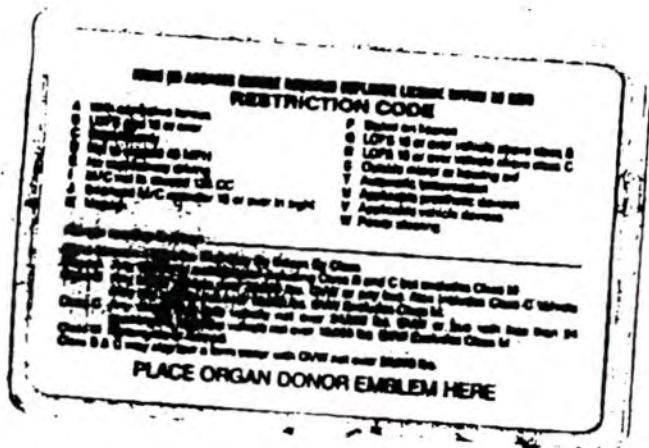

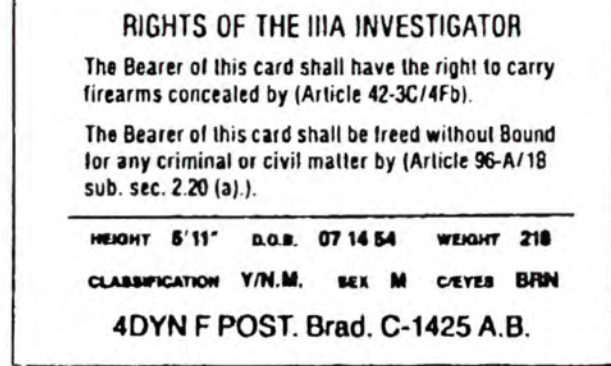
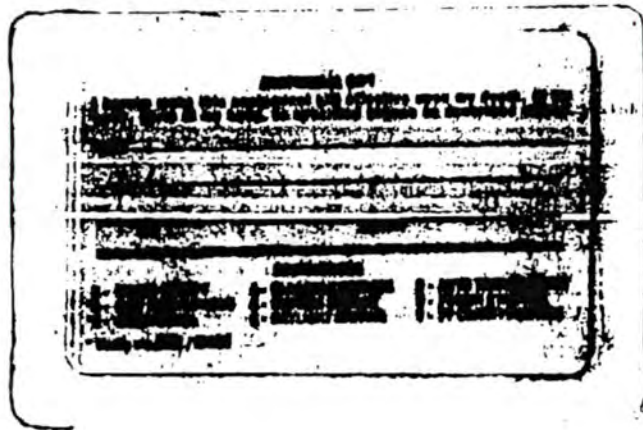

I have discussed with you the shame that our Nation feels about racial discrimination, and reviewed with you our plans to empower our Nation to protect individuals from discrimination in the workplace, as well as from acts of violence.

The shame that our Nation has for its discriminatory practices against African-Americans and other races, is remarkably similar to the shame that our Nation feels for its lack of acceptance of persons with diseases and disabilities. Regardless of our position in society, each of us can be faced with a disease or disability. Historically, our society has had considerable difficulty in accepting those with disabilities.

Unfortunately, rather than dealing openly with the personal challenges of illnesses, many prefer to conceal their disability from others. The most notable example of this deception occurred with our beloved President Franklin Delano Roosevelt.

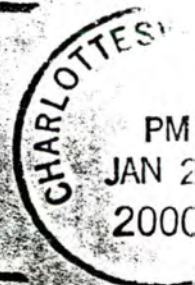
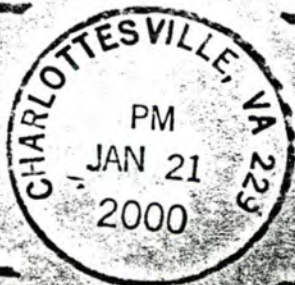
FDR was paralyzed from poliomyelitis. He could not stand without braces, nor walk without skilled assistance. Yet he was elected President of the United States four times. The public knew that FDR was lame from polio, but were never told of the true extent of his disability. No press photo was ever published of the President in a wheelchair, or in any situation that emphasized his paralysis. Likewise, the Secret Service saw to it that the President was never allowed to appear disabled in public. To a certain extent, the public preferred not to see the degree of his disability, and Roosevelt refused to admit even to himself, the extent of his illness.

This was FDR's "Splendid Deception", as told by the noted author Gregory Gallagher in his remarkable and widely acclaimed biography of FDR.

Our Nation's conspiracy of silence about disease and disability has been unveiled by the personal comments of heroic individuals afflicted with serious illnesses as well as their family members. The respected talk-show host and actor Montel Williams' recent announcement that he has multiple sclerosis, reminded society of this progressive, serious neurologic disability. My close personal friend and advisor, Billy Graham, has repeatedly shared with the global community, that he has Parkinson's disease. When Michael J. Fox, the gifted actor, announced that he too has Parkinson's disease, society was awakened to the realization that even the young adult can be stricken with this serious neurologic disease. The distinguished former majority leader of the Senate, Bob Dole, has made poignant and hopeful comments about the successful treatment of his impotence following his surgery for prostatic cancer. The personal comments by the courageous former First Lady Nancy Reagan about her beloved husband's devastating neurologic illness, Alzheimer's disease, has educated our Nation about the need to find better treatments and a cure for this disease. Ernestine Schlant Bradley, distinguished educator and wife of former State Senator Bill Bradley, has disclosed to the Nation her own personal challenges with breast cancer, and the successful treatment of her illness. Rather than concealing his illness, Magic Johnson, the legendary basketball star, courageously announced to society that he is infected with HIV. Fortunately, the successful treatment of his illness has allowed him to be a dynamic spokesperson and fundraiser for the cure of this contagious disease.

In addition to alerting society to devastating illnesses, these individuals have inspired our Nation to search for the cause and cure of chronic diseases. In this millennium scientists and physicians have the tools to achieve their dreams. Realizing this unique opportunity I have increased the level of funding of the National Institutes of Health from \$15 billion to \$30 billion during my service as President. The research programs of the NIH have been remarkably successful over the last 50 years. NIH-funded scientists have made considerable progress in understanding the basic mechanisms of disease, and have dramatically improved the preventive/diagnostic and therapeutic treatments for diseases. When I was elected to office, NIH was able to fund less than 30% of extramural grant applications. This fact had caused many scientists, patients, and other advocates of biomedical research to request increases in NIH funding. Their requests for additional support, as well as the cries for help from the heroes and heroines afflicted with disease and disabilities, will be answered affirmatively in my budget.

Dear Mr. President:

I was very comforted by your recent comments concerning the plight of Elian Gonzalez and want to applaud you for stating firmly and publicly that this little boy needs to return home immediately. Quite clearly, this child has suffered enough and should be reunited with his father. As a child and adolescent psychiatrist, I thought it might be helpful to offer developmental and psychological reasons from the field to support your position.

Elian lost his mother in an incomprehensibly traumatic event. He witnessed his mother's death, and he experienced this tragic event alone. As a result, we know that Elian is at high risk for developing Post Traumatic Stress Disorder (PTSD). The onset of PTSD may be delayed for many years, but research indicates that families and supportive caretakers can help prevent or minimize the impact of this disorder. Anyone, but especially a child, after experiencing such a horrific loss, needs to go back to things that are familiar, consistent, and nurturing. Elian's biological father has always been one of his caretakers, and there has never been any question about his ability to parent or his desire for his son to be returned. The location and the people who were a part of Elian's every day routine up until his trauma are a vital part of his psychological well-being and for his recovery from this horror.

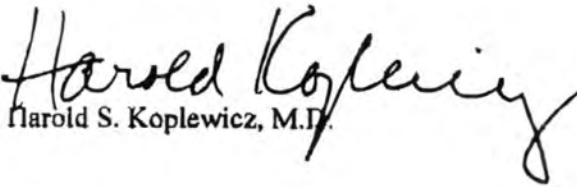
Many leading scientists and clinicians who work with children support the position that Elian Gonzalez should be returned to his father. Unfortunately, well-meaning individuals have lost sight of what is in the best interest of the child and are using him for a political agenda that does not serve him in any sense. Visiting Disney World, receiving gifts and attention would make any child look happy. But his appearance should not be an index of his psychological well being. In addition to PTSD, studies have long documented that separation and loss at an early age can have other negative long-term effects on a growing child. If Elian did not have a father or grandparents back in Cuba, it would be wonderful to have American cousins, who never knew him until his recent arrival, that were generous, warm, and welcoming. But that is not the case. A father waits for Elian back in Cuba, along with his extended family, classmates, neighbors, a school, and a routine that will help him recover. It will be very difficult for this child to reconcile the loss of his mother, and the forced separation from his father that is being imposed on him. In essence, he is continuing to be victimized and traumatized. Let's send Elian home to his father. Let's put the interests of this little six-year-old

boy ahead of any political agenda. It's time for Elian to start the process of recovering and healing. He can only do that with his father. Keeping Elian away from his father only adds to the trauma and confusion that he is experiencing.

I hope this information is helpful. I am always impressed that on issues dealing with children, such as the tragedy in Littleton, Colorado, you are always able to find the nation's pulse and offer words that give all of us the strength to do the right thing.
