SUBJECT: Attached letter from Representative Goodling

You may recall that earlier this year someone in the Administration fired a Schedule C employee who is the brother of Representative Bill Goodling (R-PA) and jeopardized the brother's health insurance even though he was under treatment for cancer.

On your authority I insisted that Representative Goodling's brother be reinstated. Now we have the attached letter from the Congressman with a fax he received from his brother in support of NAFTA. Please note the last paragraph -- and especially the last sentence -- of the Congressman's letter to you.
