Photographs

The White House photographers cover all official events in which the President or First Lady participates. Requests for photographers to cover other White House Office or Executive Office of the President events must be sent to the White House Photo Office (Ground Floor, West Wing, x54050) .

Requests for limited numbers of photographs of certain events, in which the requesting staff member is depicted, will be filled, if possible, by the Photo Editing Office (Room 475, OEOB, x66709). To request a photo, please complete the Personal Photo Request Form (See Tab C) and return it to the Photo Editing Office. You should receive your photo in four to eight weeks.

As a reminder, most event pictures, receiving lines, and one-on-one photos with the President are automatically ordered by the White House photographers. The editing, lab time, and distribution of the photos requires approximately two to four weeks. The photos are distributed to the staff contact for each event.

Staff members should remind their guests not to use cameras in the White House; cameras are only permitted at public events. Public events are those that appear on the President's public schedule and are open to the public to attend. To verify whether an event is closed or open to the public, contact the Presidential Scheduling office (Room 184, OEOB, x67560).

Requests for the President's or First Lady's autograph on official photographs should be submitted to the Presidential Correspondence Office (Room 94, OEOB, x67610) using a Photo Inscription Staff Request Form (See Tab C).

Photographs from the White House Photographer's Office are available for use in offices and public spaces within the complex only and, like any other government property, may not be removed from the complex. When you no longer need a photo, please return it to the White House Photo Office (Room 475, OEOB, x66709 or Ground Floor, West Wing, x54050), so that the photo can be archived and the frame recycled.

Good speaking with you again.

As we discussed, *Vanity Fair* is interested in doing a picture story for our January or February issue on the Clinton Years in Pictures. Our January issue appears on newsstands December 12; our February issue is out January 9.

Our notion would be to utilize images taken by White House staff photographers over the past 8 years as a way of getting an intimate view of the First Family and the Administration—from the inside. Our desire is to use exclusive, previously unpublished photos that show the private side of the First Family, the gravity and intensity of the Administration behind-closed-doors, the most candid moments of the Clinton years.

As you may know, I was the Director of Photography of LIFE for many years—and was the first to publish Barbara Kinney's historic shot of the President and the Mideast leaders together. These are the sort of human moments *Vanity Fair* is after.

My plan would be to talk with some of the White House photographers and photo editors to canvass their favorites, then go through their "greatest hits" in the archives during September. Then, I would respectfully request a session with the President to have him "speak to" the pictures in order to caption them.

I'd ideally, I would hope to make a first edit of images by September 30, then meet with the President shortly thereafter. All editorial work would need to be completed by October 10.

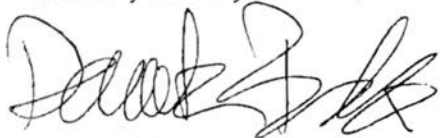

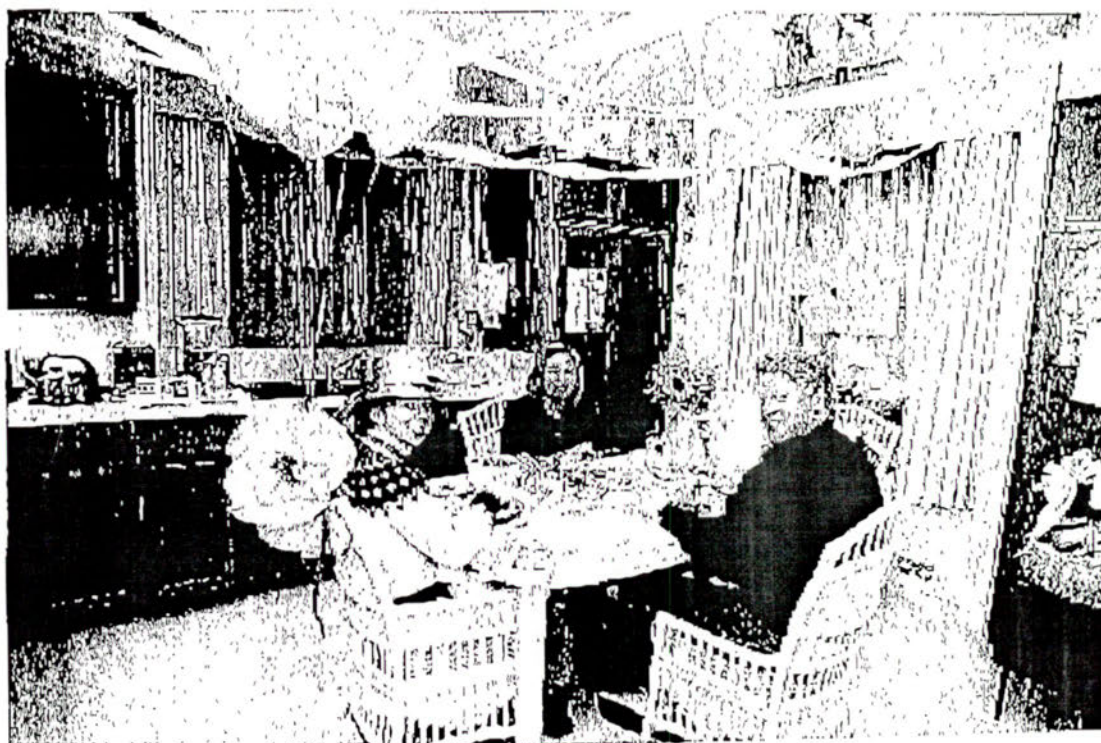
