I AM TRAVELING TO RICHMOND, VIRGINIA ON ASSIGNMENT THE FIRST WEEK OF DECEMBER AND WOULD LOVE TO CREATE AN IMAGE OF THE WHITE HOUSE TREE AS I TRAVEL THROUGH WASHINGTON, D.C. BY VEHICLE.
