Dear Marsha:

As I mentioned, I am now completing a book on the First Families for the bicentennial of White House family life. It is to be published by Simon and Schuster in November 2000. There will be some 400 illustrations in it of family life, and I have been conducting research and ordering pictures from all the presidential libraries and other institutions. At all costs, I am avoiding the more posed pictures in the state rooms or at public events. Rather I am hoping for the more snapshot-like pictures; in fact, if they are slightly haphazard or off center--but not blurry--all the better. The wish list I have for the Clinton White House--government, public domain pictures--is as follows:

-family portrait: The President and Mrs. Clinton, Chelsea, Mrs. Rodham, Hugh and Tony Rodham and their families, Roger Clinton and his family, Dick Kelley (does such a group picture exist?)

-family celebrating holidays or ceremonies in private quarters, Camp David, etc.: Christmas, Thanksgiving, Easter, Labor Day, birthdays, costume parties, Chelsea's graduation, Halloween, New Year's Day (in South Carolina); Tony Rodham wedding; any christenings <sup>5/28/94</sup> ~~5/97~~ 6/6/97

-everyday life: cooking, eating family meals together, playing cards, watching movies or television, reading; listening to music, working in family rooms; little nephews playing with Pres. <sup>8/22-27/99</sup> <sup>8/17-9/7/97</sup> <sup>8/28-9/6/94</sup> <sup>8/18-8/29/93</sup> (sailing w/ Kennedy's 8/24/93)

-summer vacation on Martha's Vineyard: get-together with friends, sailing or other boating, relaxing on beach--reading, talking, etc.

-exercising: the President and First Lady using White House jogging track; swimming in WH pool, bowling in WH bowling alley; weight-training, horseback riding

-shopping: President, Mrs. Clinton, Chelsea buying Christmas or birthday gifts; buying food at market; window-shopping <sup>10/24/98</sup> <sup>12/24/97</sup>

-the Clintons attending church services (inside views) at Foundry Methodist (perhaps sitting together in pew) <sup>picture w/ minister outside church</sup>

-Mrs. Clinton (or Chelsea) working in the family quarters at their desk; talking/relaxing with friends; any family room pictures (which would be published only 8 weeks before Inaug. 2001)

If it were possible to prepare some picture books which I might be able to leaf through with the understanding that permission for release may not be possible until final approval, that would be a start. I'll be back in action in town on August 19. Many thanks--
