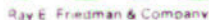

Statement of John Podesta, White House Staff Secretary

The White House is today making available additional records of the First Lady's commodities transactions as documented by her brokerage house, the Ray E. Friedman Corporation (REFCO) as well as records from commodities trading that was conducted through Stephens, Inc. The transactions covered by these records occurred during 1978 through 1980.

At the request of the White House, Mr. Leo Melamed of Chicago, Illinois, an internationally recognized expert on the commodities markets, reviewed the records of the First Lady's commodities transactions. A statement by Mr. Melamed accompanies additional documents being released today at the request of the First Lady.

In his statement, Mr. Melamed says, "What these records show is that Mrs. Clinton was, during 1978 and 1979, a relatively modest trader who traded in a variety of commodities, including cattle, soybeans and hogs. She paid normal, full commissions. She made money on a lot of trades, lost money on some--sometimes those losses were substantial--and, on balance, she did extremely well...(S)he received some valuable market advice and assistance, and violated no rules in the course of these transactions."

Leo Melamed, recognized as the founder of the concept of financial futures, is the former Chairman of the Chicago Mercantile Exchange and former Chairman of its Executive Committee. He was also Chairman of the International Monetary Market. In addition to having served as an Advisor to the Commodities Future Trading Commission, he has lectured and written extensively about the financial futures markets. He was editor of *An Anthology: The Merits of Flexible Exchange Rates* published in 1988, and authored *Leo Melamed on the Markets* published by John Wiley and Sons, Inc., in 1993.

Mr. Melamed is currently Chairman and CEO of Sakura Dellsheer, Inc., a Futures Commission Merchant (FCM). Mr. Melamed is a lifelong futures trader and is fully familiar with the trading rules and practices of the futures industry. He is on the Board of Directors of the National Bureau of Economic Research.

Statement of Leo Melamed

April 11, 1994

At the request of the White House, I have examined the records which reflect Mrs. Clinton's trading activity at Refco. It is my considered opinion that unless there are additional records to indicate otherwise, this is a tempest in a teapot. Nothing in these records appears to reflect any trading violations on the part of Mrs. Clinton.

From these records, it seems true that Mrs. Clinton began the account with a lesser amount than would be normal and this would certainly be nearly impossible today. However, she would not be the first to begin trading with but \$1,000. This has been done time and again in the course of our industry.

Moreover, one must remember that this was 15 years ago during a highly volatile market era. Indeed, that period of time represents perhaps one of the most chaotic periods in the history of agricultural meat prices. The cattle market, in a period of about one year, went from \$.47 per pound to \$.80 per pound, representing a \$13,000 increase in each futures contract. In other words, literally a \$1,200 investment in early 1978 would have produced a \$13,000 profit one year later. Additionally, it was during a time when futures markets were substantially less regulated than they are today.

On the basis of Mrs. Clinton's transactions, there is no evidence of favorable trade allocation. Indeed, the records indicate quite the opposite. Out of some 32 separate transactions that Mrs. Clinton made with Refco, all but about 2 were overnight trades. The distinction between overnight trades and day trades is highly significant. In an overnight trade, the control of profitability is given up to the market. The trade will be profitable or not as a consequence of the next day's market movement and little else. Most of Mrs. Clinton's trades were overnight positions, thus she assumed the market risk.

Mrs. Clinton's records do indicate that her account was, at times, thinly margined and that on occasion she traded with insufficient margin. But in this regard she was in the company of many other customers who were treated similarly during that time frame. On those occasions when Mrs. Clinton was under margined, she generally closed out her position without incurring a deficit in her overall account. Being under-margined is a not a violation of the customer involved but rather a violation of the firm where the customer's account is held. And in fact, her trading firm, without admitting or denying the violations, was substantially fined by the Chicago Mercantile Exchange in 1979 for margin violations, as well as other alleged infractions of Exchange rules.

This was by no means unprecedented at that time.

Mrs. Clinton was clearly receiving very good and well-educated advice, as she had every right to do and as she has herself acknowledged. She may even have had on occasion discretionary trading executed on her behalf. It must be noted that the firm at which she was trading was incredibly correct on the market direction of that day. Refco and its customers literally made hundreds of millions of dollars as a consequence of correctly predicting the movement of market prices during that time frame. Mrs. Clinton's profit, while substantial in every day life, was minuscule when measured against the background of that market era.

Overall, my conclusion from reviewing Mrs. Clinton's futures trading records available to date is that she did extremely well in the markets, received some valuable market advice and assistance, and violated no rules in the course of these transactions.
