I previously discussed with you the releases of these members. For K. Hall and R. Cowell the issue is the prorated educational award for them. I am recommending that they be given their prorated educational award because: a) they were high quality Members, b) they were very positive examples and well respected Members of their team, and c) they left their positions to better themselves.

The draft AmeriCorps Operations Handbook distributed in Kansas City at the Earth Team/AmeriCorps meeting addresses this issue. In Section 8, Page 1121 under compelling circumstances it states that "The project manager/director is in the best position to determine whether a member's personal circumstances are sufficiently compelling to justify release on this basis." In the case of Hall and Cowell, jobs became available that met their career objectives. They were competing for jobs in a very tight job market and were able to be selected because of their AmeriCorps experience. K. Hall got a job as a Naturalist with the Crawford County Conservation Board in western Iowa and B. Cowell got a job in Pennsylvania as an Information Specialist with a dairy cattle AI firm.

I recommend that K. Hall receive a prorated educational award amounting to \$2,126. She worked 768.25 hours or 45 percent of her year. I recommend that B. Cowell receive a prorated educational award amounting to \$2,173.50. She worked 785.25 hours or 46 percent of her year.

For Jeff Frederick the situation is different and I am not recommending prorating his educational award.

Angela Norsworthy is listed as not being enrolled in the trust. On June 28, 1995, a duplicate enrollment form was mailed to your office. Attached is a copy of that form. All members except Robin Torrence have completed their service, and Robin will complete her service on September 8, 1995.

Sobrena Lewis withdrew from the national service program because of personal and financial difficulties. I approved her request for early termination for compelling personal circumstances because I felt her situation warranted this determination. Sobrena was a very hard-working, dedicated member. She completed 902 hours of service and was able to accomplish her project objectives. Sobrena moved to Louisiana from Maryland to accept the AmeriCorps position with our agency. She had no family support available in Louisiana. After several stressful months of trying to make ends meet, Sobrena was faced with the reality that she could not survive on the stipend provided. Her only choice was to return home to Maryland. We have attempted to place Sobrena in other ongoing AmeriCorps programs in Maryland/Virginia/Washington DC in order to complete her term of service, but we have been unsuccessful. ✓

Because of Sobrena's commitment to national service, I strongly recommend you consider awarding Sobrena a pro-rated education award. If this is not possible, please consider converting Sobrena to part-time member status, in order for her to receive a partial education award.

This is to inform you of my withdrawal from the USDA/AmeriCorps program. Tomorrow, June 2, 1995 will be my last day in the AmeriCorps position at Twin Valley RC&D in Natchitoches, Louisiana. I have decided to return home to Maryland due to financial burdens and the stress that accompanied those burdens.
