STATE RURAL DEVELOPMENT COUNCILS

State Rural Development Councils will be established in 42 states, Puerto Rico and the U.S. Virgin Islands by the end of 1992 under the President's Initiative on Rural America. This fact sheet details the formation of these councils and their purpose: to support local economic development in rural areas through a partnership effort by local, state and federal governments and the private sector.

- o In March 1989, the President's Economic Policy Council (EPC) formed the Working Group on Rural Development, comprised of sub-cabinet representatives of nearly every federal department or agency, to explore how the federal government might better address rural America's problems.
- o In January 1990, President Bush ordered the implementation of the recommendations made by the EPC Working Group, which included the formation of State Rural Development Councils to provide a collaborative partnership between the federal, state, and local governments, and the private sector in each state.
- o State Rural Development Councils are collaborative bodies which include representatives from the federal, state, and local governments and the private sector within each state, who collectively assess needs and develop long-term strategies to address those needs.
- o Eight pilot councils were established in 1990/91 in Washington, Oregon, South Dakota, Kansas, Texas, Mississippi, South Carolina, and Maine.
- o In October 1991, President Bush invited the governors of the remaining states and Puerto Rico and the U.S. Virgin Islands to form new state-federal-private partnerships by creating State Rural Development Councils, and 36 governors expressed a desire to create councils.
- o The responses were reviewed by a federal inter-agency task force, which recommended that councils be formed in all responding states by the end of 1992. Based on that recommendation, the EPC Working Group determined to proceed with establishing councils in interested states.
- o The new councils will be established through a memorandum of understanding between each governor and the secretary of agriculture, as chairman of the EPC Working Group on Rural Development.

- o The federal partners will provide 75 percent budget support of the operating cost for the councils, including an executive director to be selected by each council, and the non-federal partners will provide 25 percent of the budget support.
- o The councils do not represent a new grant program, but rather a collaborative use of existing federal, state, local government and private sector resources, based on locally identified needs and strategies.

PRESIDENT'S INITIATIVE ON RURAL AMERICA

*** TALKING POINTS ***

THE INITIATIVE

- o In March 1989, the President's Economic Policy Council formed the Working Group on Rural Development [WGRD] to explore how the federal government might better address rural America's problems. The WGRD was composed of key officials from relevant federal departments and executive agencies and the White House.
- o On January 22, 1990, the President ordered the implementation of the recommendations from the White House Economic Policy Council's WGRD.
- o As a result of the recommendations, Working Group on Rural Development was made a permanent part of the President's Economic Policy Council to provide a Federal Government wide focus on rural development issues, a private sector President's Council on Rural America with the responsibility to advise the President and the Economic Policy Council on how to improve federal rural development policy was established, as were eight pilot State Rural Development Councils to provide a collaborative partnership between the Federal, state, local governments and the private sector in each state. *Ch by Sec - comprised of...*
- o The EPC Working Group on Rural Development is creating a new interdepartmental working relationship at the Federal level and a better understanding of rural development issues as a result of cooperation between Federal departments. *interdepartmental working relationship*

PRESIDENT'S COUNCIL ON RURAL AMERICA

- o The President's Council is focusing its attention on the importance of rural development to the national economy, and will provide advice on how an improved federal rural development policy can be implemented and innovative thinking applied to improve rural America within existing resources.
- o The President's Council has organized into four work groups to examine economic issues, institutional and infrastructure development, Individual development and lifestyle essentials, and implementation factors and funding.
- o The President's Council held seven regional public hearings to gather input on a wide range of questions regarding the delivery of Federal rural development resources to rural areas. The Council is focusing closely on coordination of Federal resources and will make its recommendations to the President in July.

STATE RURAL DEVELOPMENT COUNCILS

- o **State Rural Development Councils are collaborative bodies which represent a working partnership between the Federal, State and local governments and the private sector.** There are representatives from every Federal and State agency with a rural development role, as well as local governments, regional planning organizations, and the private sector serving on the council.
- o **State Rural Development Councils collectively assess needs and develop long-term strategies for addressing those needs in each state.** These may be done based on existing or new information by all of the partners with rural development responsibilities at all levels.
- o **The eight pilot State Rural Development Councils have completed their first year** and have been deemed initially successful both by the participants, and in an independent study by the University of Southern California School of Public Administration which stated that "the initiative assisted states to go beyond narrow definitions of economic development (e.g. recruitment and smokestack chasing) and many moved into a broader conceptualization of rural development that included community development issues, social services and infrastructure."
- o **Successful projects have resulted in the pilot states as a result of the new partnerships** including a consolidated loan application and credit analysis in Kansas [Small Business Administration (SBA), Farmers Home Administration (FmHA), Economic Development Administration (EDA) and the Kansas Department of Commerce], and a regional waste water treatment project in South Carolina [FmHA, EDA, and the State of South Carolina. Many new projects are underway in other pilot states.
- o **The President has invited all of the remaining States and Territories to participate** and 35 responses were received.
- o **New states will be added in February upon completion of the review of those responses** by the EPC/WGRD, with the ultimate goal of partnerships in all States and Territories.
