To the extent it helps, and you do not have standard language, I would offer the following as a possible text:

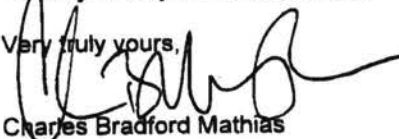
Dear Ranch and Alexa,

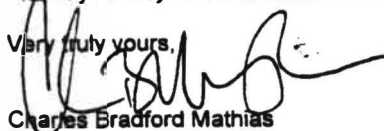
