Además, estaba representado por un abogado? ¿Pagó usted más de \$200. por un abogado? ¿Que hizo él por usted? ¿Qué le prometió? Le dió recibo de todo el dinero que usted le entregó? Por favor mándeme los nombres y direcciones de abogados que no hayan actuado bien. Su nombre será mantenido en estricta confidencia. (Nuestra reputación en el pasado se lo garantiza.)

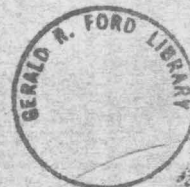
Si usted es un hombre de empresa: Por favor no vacile en decirme si algún Agente de Inmigración ilegalmente le ha amenazado con la cárcel o con una multa - si usted empleó un ilegal? De acuerdo con la Ley: No es ilegal el emplear una persona que no tiene residencia. (Esta situación está siendo revisada actualmente en Washington.)

Proximamente habrá unas Vistas de 5 días en Washington, Miami, Chicago, Los Angeles y Nueva York. Usted puede declarar personalmente. ¡Y TENDRA COMPLETA INMUNIDAD! Por favor confíe en nosotros, porque nosotros decimos la verdad!

Además, recuerde que los Servicios Religiosos Ecuménicos se celebrarán el sábado por la mañana a las 10:30 A.M. en la Capilla de las Naciones Unidas. La Iglesia Protestante se une a los Católicos y respaldan la Amistía para todos.

Este es una apelación final para que ayude a 1,000,000 de familias cruelmente separadas. EN NOMBRE DE DIOS- usted puede ayudarnos AHORA; Este seguro de que usted traduce su carta firmada (O sin firmar) al inglés. Yo personalmente le agradeceré su ayuda.

TRANSLATION FROM SPANISH TO ENGLISH

WILL YOU HELP ME TO PRESENT 500 MORE CASES? NOW IS THE TIME TO SPEAK UP. AMNESTY IS OURS AND WE SHOULD FIGHT TOGETHER NOW!

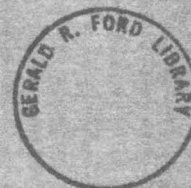
On July 1, 1975, I met with the Hon. Fernando de Baca, Presidential Aide at the White House in Washington, D.C., in a session which lasted two hours. Mr. De Baca informed us that unfortunately the President was not completely informed on all points!

On July 2, 1975, I met with the two principal aides of the Vice-President: Hon. Alexander Aldrich and Mrs. Evelyn Cunningham at 26 Federal Plaza, Room 3400 in New York. They were desirous of obtaining the most important information. It pleased them to receive information from the committee of Concerned Citizens for Immigration Justice.

Formerly I had met with members of the Dept. of Justice in New York and Washington. They were trying to compile more information for the Attorney General. (They had obtained information pertaining to serious cases throughout the nation.) They want more information

Here is what you can do: Write me a letter, addressed to Fred P. Ames, 2440 Amsterdam Ave., New York, N.Y. 10033 and tell me everything. Have you or any acquaintance of yours been apprehended by the U.S. Dept. of Immigration? Were you apprehended at gunpoint? Were you handcuffed? Were you prosecuted? Did you pay any fine? Did you get a fair trial?

Also, were you represented by an attorney? Did you pay more than \$200 for an attorney? What did he do for you? What did he promise you? Did he give you a receipt for all the money that you gave him? Please send me the names and addresses of attorneys who have not acted properly. Your name will be kept in strict confidence. (Our past reputation guarantees it)

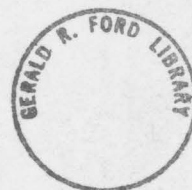
If you are a businessman: Please do not hesitate to tell me if any Immigration Agent has illegally threatened you with jail or with a fine, if you employed an illegal alien. According to the Law: It is not illegal to employ a person who does not have his residence. (This situation is currently being reviewed in Washington.)

And soon, there will be hearings for 5 days in Washington, Miami, Chicago, Los Angeles and New York. You may personally make a statement. **AND YOU WILL HAVE COMPLETE IMMUNITY!** Please trust us because we are telling the truth!

And, remember that the Ecumenical Religious Services will be celebrated Saturday morning at 10:30 A.M. at United Nations Chapel. The Protestant Church joins with the Catholics in supporting amnesty for all.

This is a final appeal to help 1,000,000 families that are cruelly separated. **IN THE NAME OF GOD, you can help us NOW!** Be sure that you translate your signed (or unsigned) letter into English. I personally will thank you for your help.

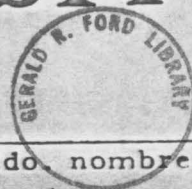

Dear Chairman Rodino:

Ever since Watergate, United States Citizens have become more cognizant of the need of honesty in government. Since we are a nation of the people, by the people and for the people, I am requesting with the greatest of humanitarianism and in the Name of the Almighty to "table" consideration on any and all pending legislation — concerning future Immigration laws.

Yesterday, for the first time, I received a copy of the First Session on H.R. 982 and Related Bills concerning "illegal aliens." I am vitally interested in this situation and it is a matter of public record that I have voluntarily devoted two years of full time and dedicated effort — plus the spending of over \$30,000 in personal funds to ascertain what the Immigration problem is all about and how best it can be solved for the common good. Suffice it to say I have the most sensible, economical, humane answer possible. However, what good is any answer if what is happening through your committee comes to fruition?

In the opening statement of the Chairman of the U.S. Committee on Immigration by the Honorable Joshua Eilberg, as reported in the hearings on Immigration on February 4, 1975, he stated thusly:

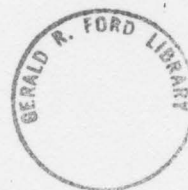
We are here today to receive an update on the facts concerning proposed legislation which should have become law over 2 years ago.

This bill H.R. 982, the so-called illegal alien bill, was passed overwhelmingly by the House of Representatives in the 92d and 93d Congresses. Had the Senate acted and the President signed this measure, it is entirely possible that 1 million Americans would be working today instead of collecting unemployment compensation.

It can be proven that this statement is completely erroneous and will be so illustrated in the next edition of CAROUSEL OF LIFE, a non-profit, crusading newspaper, which will be printed and distributed next week in Washington, D.C., New York City, Miami, Los Angeles, Chicago and other key cities throughout the country. In the next paragraph of his prepared statement, Congressman Eilberg tried to defend his position as being sympathetic to illegal aliens but his words have never seemed to measure up to his own past actions. However, this second statement contradicts the estimates of illegal aliens by General Chapman, Commissioner of INS, the State and Labor Department, as to how many aliens are actually in the United States. This estimate has been publicized time and time again as being near the twelve million figure.

No one can argue that the plight of the aliens who come to this country illegally is not tragic. In many cases these men and women are separated from their families for long periods of time. They are forced to live under the worst conditions and as a result of their precarious status they must accept any form of abuse and mistreatment their employers choose to hand out.

If there are one million aliens working here and it is a recognized fact that over 90% are "loners" or heads of families, working to send money home to their destitute families, then, who in Heaven's name, is supporting the other eleven million aliens in our country? It is a fact that they are not on welfare, they do not qualify as such and the countries from whence they came from never knew what a welfare program was! Our own survey figures made in April and May of 1975 reveal that there are less than 500,000 different job holders in the country and this is one-half [or 50%] of the "unscientific" estimate of Congressman Eilberg. It is also one-fortieth [1/40] of the estimated number of aliens supposedly in the United States today. In contrast there are 530,000 aliens in the small country of Switzerland with only a population of only six million people. THEY HAVE NO CRISIS SITUATION, neither do we have any, nor did we have any until about two years ago when General Chapman took over the INS. He met with his "Gung Ho" comrade the former Attorney General, William Saxbe, and concocted a story which has resulted in the most inhumane actions — instigated by any United States authority in the United States. Ten major lies which have been distributed effectively to a "duped" media has brought about a complete "poisoning" of the minds of the general public so that only a miracle can bring about the TRUTH OF THE MATTER. Carousel for Life has accepted this challenge for it possesses all the truth and it is preparing 1,000 outlets in a thousand different communities within the next six months and the entire American public will be informed accordingly. [75,000,000 readership.]



There has been a good deal of misinformation circulated concerning this legislation. H.R. 982 does not discriminate against ethnic and minority groups. It does not impose penalties on the already victimized illegal aliens.

The obvious "hate" campaign created by Saxbe and Chapman was in itself a complete expression of contempt for Congress. Both men believed that Congress had not been able to do anything for at least seven years and consequently they took the law into their own hands [this will be explained in detail in Carousel's next edition].

It is a fact that 95% of all so-called illegal aliens in this country came here legally [INS statistics]. There is no question in the minds of Concerned Citizens for Immigration Justice that H.R. 982 DOES discriminate against ethnic and minority groups. It does not have to impose penalties on the already victimized illegal aliens. Indirectly, it does relate to the deportability of aliens. The recent illegal actions of INS agents speak for themselves. H.R. 982 encourages discrimination against aliens and it forces the mass deportation of illegal aliens.

As in the case of the Agricultural Department, through their own survey, there has been substantiated the need for migrant workers. There is also a great need for immigrants to work in certain areas which are important to our economy. Not every employer belongs to the "Big Business Establishment of America." It is a known fact that many restaurants, laundries and factories could not stay in business if each employer were to depend on the average U.S. worker who can collect on unemployment up to \$95 a week. These jobs go begging.

To cite an example, a young girl, crippled, was laid off from her factory job recently and tried to collect her unemployment benefits which were only \$43 a week. She was turned down because she had no "green card." She was advised by friends not to pursue the matter with the State Unemployment Benefits Group and the next day she went out and got another job at the minimum wage and this gave her an income of \$80 a week [other situations will be presented in Carousel for Life]. NOT ALL PEOPLE ARE HERE FOR JOBS AND JOBS ALONE!

NOT ALL ALIENS ARE ILLEGAL! Many are awaiting their "Green Card" interview time - like hundreds of thousands of others have done in the past successfully. Some are unfortunate victims of the deliberate "short-changing" via the Western Hemisphere quota system of 1965-68. (This situation has been documented and submitted to the Supreme Court and others.) A good number are actually "political refugees" but their status has been ignored by State Dept. officials in the past. However, the recent CIA scandal has proven that they deserve *asylum* due to the stupid intervention of the CIA in foreign affairs - without approval by the proper authorities. Others are here because of their strong desire to be close to their families. THIS IS NOT A CRIME BUT A BLESSING. The basis of the Immigration Laws is to unite families. Today, according to the U.S. Catholic Conference, there are 1,000,000 cruelly separated families and *this is a CRIME, in itself.*

Hearings were held across the country on this subject. More than 200 witnesses whose testimony fills over 2,000 pages were heard.

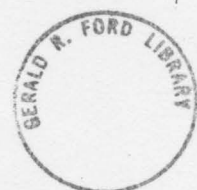
The product of these hearings and countless hours of work by the members of the subcommittee and the staff is the legislation now before us.

Concerning the fact that Hearings were heard across the country on the Immigration subject, I wish to make a public record of the fact that every effort was made to get fair consideration from Mr. Cline's office, House Subcommittee on Immigration, for a presentation. We were treated rather coldly time and again. Yet, on the other hand, we have been warmly treated by Mr. Edward Loughran of the Senate Subcommittee on Immigration — on at least 12 occasions. He has given us valuable advice, answered all questions and has been helpful in specific situations. AT NO TIME HAVE WE HAD TO HAVE A SET APPOINTMENT. On July 1st, Congressman Eilberg sent me a letter, "offering me an opportunity to submit a statement." I wrote back to him, and I told him it was "too little and too late" an offer.

The fact that this legislation presents a workable answer to the problem is borne out by the support it has received in the past. In the 92d Congress it was passed on a voice vote and in the last Congress by a 297-63 margin. On those two occasions the country was in much better shape economically than it is today.

The present laws do not present a workable answer for it to be accepted. It still has to be recognized by the Senate and the President of the United States.

Now we are on the verge of depression and this measure could help to put the Nation back on the road to economic recovery. It would eliminate the drain illegal aliens place on our economy by taking jobs, collecting welfare and unemployment payments, putting their children in our schools, and using all of the other services which citizens and legal residents pay taxes to support. Additionally, illegal aliens send millions of dollars back to their native lands annually, a practice which further damages our economy.



Suffice it to say, the President and his new Domestic Council, the Vice President, the new Attorney General, and even the Supreme Court, have been receiving all the true facts pertaining to this humanitarian situation. Also, we are NOT on the verge of a depression, according to our forthright and honest President. Aliens are not collecting welfare, unemployment payments, replacing our children in schools and using all other services which citizens and legal residents pay taxes to support. ALL ALIENS PAY TAXES. Over 50% do not collect their IRS rebates for fear of being apprehended. For every dollar an alien sends home to his country to support his destitute family, United States big businesses in foreign countries outdo this with a \$100 profit which comes back to the U.S.

I do not advocate a ban on immigration, for this country was built and its greatness assured by the labor of immigrants. It remains essential, however, that we have the orderly and fair entry of immigrants into the United States.

Yes, we are a land of immigrants. If Canada granted amnesty in 1973 because of their own mistakes in creation of the Immigration problem, then the United States can most assuredly do likewise. However, in this instance, certain Congressmen would have their "pride goeth before destruction." "Grimoism" is on the upswing and if these outmoded laws are not changed favorably no Congressman or American tourist will want to venture south of Texas or California. AS THINGS STAND NOW, THOUSANDS OF ALIENS HAVE BEEN DEPORTED ILLEGALLY AND IN THE MOST INHUMANE FASHION. We Concerned Citizens for Immigration Justice are incensed to think that we have the truth, nothing but the truth, so help us God and we are not being heard properly. However, the truth will someday out soon and it is with this warning that we say to Congress - please make a thorough investigation of all the facts before you make another move.

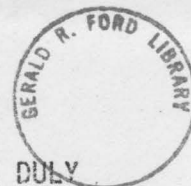

Dear Mr. Ames:

I enclose herewith a copy of the unanimous opinion of the United States Supreme Court in U.S. v. Brignoni-Ponce, 43 LW 5028, holding unconstitutional the practice of immigration officers questioning persons about their citizenship and immigration status, without consent or probable cause, merely because a person or persons to be questioned appear to be of foreign birth.

Section 287[a] [1] of the Immigration and Nationality Act authorizes any officer or employee of the Immigration Service, without a warrant, "to interrogate any alien or person believed to be an alien as to his right to be or to remain in the United States." The Fourth Amendment to the United States Constitution prohibits unreasonable search and seizure. The Court reasoned that whenever an officer accosts an individual and restrains his freedom to walk away, he has seized that person within the meaning of the Fourth Amendment. It held that a person may not be detained for purposes of inquiring into his residence status merely because he appears to be of foreign birth. It established a formula for such inquiries. There must exist articulate facts together with rational inferences therefrom, reasonably warranting suspicions that the persons to be interrogated may be illegally in the country. An apparent foreign ancestry does not furnish reasonable grounds to believe alienage.

I consider this case to be a landmark decision in the area of civil rights of aliens. Considering the present makeup of the Supreme Court, it is a pleasant surprise.

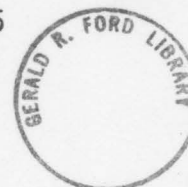

This is a follow-up APPEAL to the letter submitted by Archbishop Gabre Mikael last week.

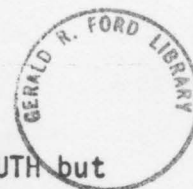

Citizens and Permanent Residents have been harrassed as well. Many are handcuffed and taken in for questioning which can take many hours - in fact, days. Some are deported without full DUE PROCESS! The news media has been silenced so that the general public is misinformed. At the most - INS has been able to "up" their apprehensions from 1% - to possibly 2% - according to their own "estimates" of the number of over-stayed immigrants or unrecognized "political refugees. Their daily actions surpass Moscow or former Berlin "seizures" and we are now No. 1 in the world - as to inhumaneness and stupidity, to say the least.

Last week, 17 agents broke down a factory door, scaled walls with drawn guns - terrorized factory workers by pointing guns on the person of various workers without ascertaining their status whatsoever. Mr. President:

We write of a matter of great concern to all of us; the so called "illegal alien", an issue which up until the present has been a political football. In view of this situation, Mr. President, we petition that this problem be faced as a MORAL and ECONOMIC issue which it more rightly is.

Please be advised that 2,000 "undocumented aliens" have come out of hiding voluntarily during the past year by way of the Carousel for Life, a non-profit humanitarian organization concerned with the needs of these people. Carousel for Life has posted \$50,000 in U.S. Immigration fees and has contributed another \$150,000 in gifts which is now being held in escrow accounts.

Mr. President, we call your attention to the fact that during the past year, the New York Division alone of the Department of Immigration has deported about 1,500 aliens at great expense, running into millions of dollars of our taxpayers' money. Yet only one percent of all scheduled deportations and apprehensions took place during the past year. At this rate, according to INS rates and "estimates", 99 years will be needed to deport all those designated for deportation.

The tragedy of this waste of time, money and effort is that over fifty percent of those deported were illegally apprehended and the guidelines of a recent Supreme Court ruling were flagrantly ignored. This is the source of our first concern.

The second source of concern is this: every employer in the New York area has been illegally harrassed, threatened and intimidated with an illegal notification that they will either be jailed or fined if they continue to hire aliens without "green cards" or identification of permanent residency. There is no existing legal authority for such harrassment. The fact that the Rodino Bill has twice been defeated declares loudly and clearly that the people of the United States reject the idea of our beloved country becoming a police state. The action of the INS is the equivalent of taking the law into one's own hands, Mr. President, and such action IS AN AFFRONT TO THE AMERICAN WAY OF LIFE!

History has recorded the irony of the whole situation. Our problem is the result and effect of the imposed personal will of the late Senator Dirksen on Congress in 1965. There would be no "illegal aliens" problem in the U.S. today if, through his efforts, he had not reduced the immigration quota from 170,000 to 120,000. Over a ten year period, 500,000 immigrants from the Western Hemisphere have been denied legal residency. 95 percent of all "illegal aliens" presently residing here came legally but have had no fair chance of "changing status" due to our present quota system.

Mr. President, Carousel for Life, whose theme is "ask not what your country can do for you, but what you can do for your country", has proven that they can reach "undocumented persons" (we prefer this more humane term) and bring them out of hiding. Its entire program has been accomplished on the basis of TRUTH and TRUST!

Carousel's moral mentor is Fred Ames, a social worker with twenty-one years of experience in that field, and who is a crusading publisher and editor of some eight years experience. Mr. Ames is qualified to counsel and work as a liaison between the Department of Immigration and the "undocumented alien" in a humane way. He attempts to find a viable means of adjusting and changing status which is acceptable to all concerned; a means whereby the "Petitioner" receives a bona fide "green card".

Carousel for Life proposes a "change of status" arrangement similar to that which Canada established successfully in 1973 and which offers to underwrite all costs for such adjustments through funds received from the "undocumented alien". When a justifiable and viable program is inaugurated, Carousel for Life predicts that within a two-month period all persons in the "undocumented alien" category will have come out of hiding. The U.S. Department of Immigration will be the recipient of 50 million dollars in fees and the economic structure of our country will have been strengthened.

Most of all, Mr. President, this sane and very necessary new approach to the current problem would easily revive the "Good Neighbor Policy" which was the balm for all prior to 1965.

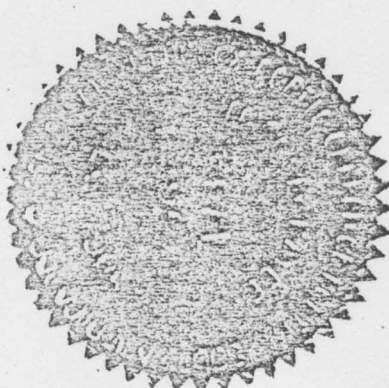

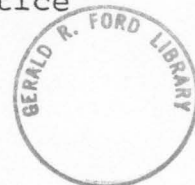

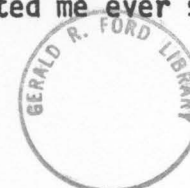

"Illegal Aliens" or An Illegal System?

The cover-up disease retains its epidemic proportions despite the lingering shock waves of Watergate. One would expect an all-out effort by government agencies to prevent a repetition of the scandal which rocked the nation.

And yet another cover-up of major proportions is surfacing in the Federal government's Immigration and Naturalization Service (INS) regarding the status of so-called illegal aliens in this country. The term "so-called" is used advisedly, as the INS official figures show 95% of the illegal aliens in the United States entered the country with legal status. Involved are corruption and irregularities of Congress and government agencies, notably the INS. Only the tip of the proverbial iceberg has been uncovered. It exposes slavery, prostitution, thievery, narcotics, and bribery of government officials.

This reporter's interest was aroused by stories circulating in Washington which hinted at illegalities connected with the INS. Further investigation has uncovered shocking evidence of practices involving members and staff of the Senate and House Judiciary Committees. This and other pertinent information uncovering the irregularities which have permeated all the agencies involved are based on hard evidence and documents and supported by testimony of involved persons.

The scandal touches several agencies connected with the INS—the State Department, the Justice Department, the Customs Service, the FBI and CIA. Hard evidence exists that the FBI has known about parts of this scandal but taken no corrective action.

Certain members of Congress and their staffs are known to have flagrantly misused their offices and powers in obtaining citizenship for aliens through illegal means. Members of the INS have applied selective enforcement of the law—favoring those aliens who cooperate with them and discriminating against those who do not. Race and nationality have created further discrimination.

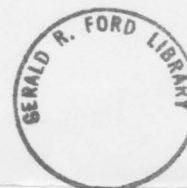
Frequently, illegal aliens enter the United States with the promise of a better life for their families but find the contrary to be true. Some have gained entry

through illegal traffic in the Green Cards indicative of permanent residency. The INS is aware of this situation but applies enforcement selectively, allowing only certain cooperative aliens to remain. A policy commonly used by the INS is the deportation of some aliens for political rather than legal motives, thus depriving these persons of due process under the law.

Aliens are often victimized by unscrupulous employers who knowingly hire them for several days or weeks, and then report them to the authorities without giving compensation for the labor. Other employers pay starvation wages because they know illegal aliens cannot seek aid from the authorities. Young women have been forced into prostitution to support themselves or to protect their families from abuse. Some authorities are known to have sexually abused young women they have caught, before returning them to their countries of origin.

The treatment of aliens is fostering a growing resentment of the United States in neighboring countries, a resentment often felt by American tourists who receive verbal and even physical abuse. These practices have created "Ambassadors of Hate" who return to their countries desirous of vengeance upon all Americans. A scar is left on our country's image—a scar impossible to erase with all the foreign aid and travellers of good will this nation can muster.

This series will give detailed examination of the situation in future installments. It will name those individuals in the Congress and aforementioned government agencies who have used their positions to manipulate the immigration system, sometimes reaping financial rewards in the process. The effects on individual persons will be revealed—persons who trusted others to bring them to the U.S. and now feel only bitterness for our system. The immigration story has all the earmarks of another Watergate scandal in its magnitude of conspiracy and cover-up. And perhaps it will also prove to be an indictment of those members of the press who have chosen that line of least resistance, averting their eyes and accepting establishment stories without investigation.

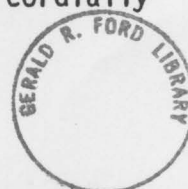
Recently, I made a trip to Switzerland. 535,000 aliens are working in a country of only 6,000,000. the peace and serenity there is unbelievable. We could attain same.

about the INS problems etc.

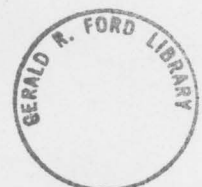
Here is my second attempt:

Dear Mr. Kiley:

On Tuesday, October/another factory raid was carried out - near your Detention Center - 1177 Flushing Avenue, Brooklyn - at Hygiene Co which employs about 200 persons. Again INS has violated the recent Supreme Court landmark decision, pertaining to Section 287 (1) of Immigration and Nationality Act. (Copy attached - Legal opinion - Atty. Leon Rosen, N.Y.)

Your agents tried to cover up their ILLEGAL APPREHENSION raid by first seizing the Time Cards of all the employees. They were seen writing the names of all employed on their own blank paper and in this way they could "claim" that they knew who they were apprehending. (They committed a crime - with the intention of covering up another crime.) IS THIS ETHICAL?

They found only 5 persons who could not produce Green Cards - out of 200. (This figure was supplied to me by the owner of the concern whose main office is at 295 Fifth Ave., N.Y. One person was able(?) to get away. Why?

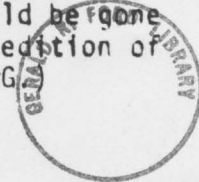
On Wednesday, October 8th, I went to Washington, D.C. to file a formal complaint. The Attorney General's office advised me to file the complaint directly with INS. The Office of the Senate Subcommittee advised me who to make the complaint with. I MADE A STRONG COMPLAINT not only concerning the illegal apprehensions which took place but also a civil rights violation complaint against your office for trying to prevent me from helping people in need.

I also learned that the Attorney General has realigned his relationship with the F.B.I. and it is reasonable to assume that the "criminal negligence" - involving my original complaints might have had a great deal to do with this change of policy. I will re-submit my complaints.

However, I will add another point which has become more evident as a result of this recent raid. I firmly believe that you are discriminating against me in that any or all persons who have registered under the PRE-REGISTRATION (every one from the President on down has received monthly reports for one year and financial statements have been included) are being given the "fast" treatment. The raid occurred on Tuesday and only Fabiola Pena and her husband have been ordered to a hearing - this morning - two days afterwards. Why not the others?

Recently, another one of those whom I am trying to assist was apprehended illegally on one day and had a hearing 5 days later - and then was deported 5 days after that. There have been others. The agents walked into the Apartment - without being invited in. They handcuffed the man. They walked into the room of his sister-in-law who was sleeping. They ordered her out of bed. She would not get up until they left the room so that she could dress. (She was still in her night gown.) This young girl was the mother of a very small baby - recently born. The agents made her take the baby to the woman on the second floor for her to take care of it - until they returned from the Detention Center. (They did not ascertain whatsoever if the lady on the second floor could take care of the baby - especially when they knew that they would be gone for over 12 hours!) When the women of America learn about this story in my first edition of CAROUSEL FOR LIFE to be published next month - they will speak out LOUD AND STRONG.

In your interrogation of Fabiola Pena - one important point was left out in your continued "witch-hunt" investigation of my sincere desire to help people who are worthy of assistance.

Several months ago, she was laid off from work. She went to collect on her benefits. She was turned down because she had no Green Card - even though her employer had paid into this fund in her behalf as an employee. I went the next day to see the Director of this Agency, in the Bronx. He apologized for the law being so discriminatory but his hands were tied. I gave Mrs. Pena 2 weeks' benefits - out of my own pocket - (\$88.00) and advised her to find another job - EVEN THOUGH THERE WERE 8.5 millions out of work. She got another job because the work she could get - no one receiving \$95.00 a week in unemployment wages would want! (Her unemployment benefit would have been only \$44.00 a week - and this with a baby of her own and an unemployed husband.) This is typical of 95% of all over-stayed immigrants who are being treated criminally - by ONLY INS. These people came here LEGALLY from countries where they were considered ABOVE the average. They are no different than the millions who did the same thing - for years - and eventually received their Green Cards. (What a way to run a government operation - involving so many human lives and their own future. If ever there was a solid basis for a "Moratorium on Deportations" - NOW IS THE TIME.

- a. Thousands of illegal apprehensions. Resulting in illegal deportations etc.
- b. Implementing an unpassed law (Rodino Bill)
- c. Enforcing an unenforceable law.
(Only 1 to 2% have been apprehended in the last year.
This means that it will take from 50 to 100 years etc.)
- d. The quota system for the Western Hemisphere as against the Eastern Hemisphere is unfair and biased 100%.

At the suggestion of Atty. Jack Wasserman, the Board Chairman of the National Immigration lawyers, I requested this Moratorium over one year ago. It was turned down - for the INS thought the time was not proper. (As mentioned - was THE TIME - after all were deported?)

6 months or so ago, the same answer was given to the Hon. Nelson Rockefeller who made a volunteer inquiry in our behalf. This was also turned down for the same reason.

Fortunately the Domestic Council will get ALL the facts in our next edition of CAROUSEL FOR LIFE to be published next week - for all to see. (25,000 copies). This will be followed up with a national edition - geared to reach 13,000,000 readers. The next edition will reach 50,000,000 readers. THIS ENDEAVOR WILL BE TEMPORARILY FINANCED BY ALL THE PRE-REGISTRANTS OF THE "CHANGE OF STATUS" endeavor - fully supported by the U.S. Catholic Conference and others.

THESE ALIENS WANT TO HELP AMERICA - HELP ITSELF.) These are the same people - treated as CRIMINALS. On Saturday, October 18th - over 2000 persons are expected to take part in a devout SERVICE TO BE HELD ON THE CAPITOL STEPS. NO speeches will be made - nor will there be any demonstration. OUR CASE IS IN THE HANDS OF THE ALMIGHTY. WE ARE DOING HIS WORK. HE HAS BEEN GUIDING US ALL THE WAY! WE SHALL SUCCEED - JUST AS SOON AS THE "DESTROYERS OF MANKIND" wake up to the fact that HE IS OPPOSED TO BIAS AND STUPIDITY. We are all God's children and WE WERE ALL CREATED EQUALLY.

Am anxious to find out if you will ignore the fact that those involved in this illegal raid will be processed and deported by the "hearing" scheduled for today. If INS does not look into the matter, I have approached the Senate Committee now in session - looking into all irregularities of investigative agencies - to be heard fully. This report will be submitted next week.
