1. PLEASE INFORM LON NOL IN STRICT CONFIDENCE THAT, IN RESPONSE TO GROWING CONGRESSIONAL AND PRESS PRESSURES, WE ARE MAKING PUBLIC THE FOLLOWING SUMMARY OF OUR EFFORTS TO STIMULATE NEGOTIATIONS ON CAMBODIA. YOU SHOULD INFORM LON NOL THIS IS AN ESSENTIAL PART OF OUR EFFORT TO SECURE SUPPLEMENTAL ASSISTANCE FOR CAMBODIA, A MATTER ON WHICH WE ARE PROCEEDING WITH GREAT URGENCY.

2. FOR SAIGON: YOU SHOULD INFORM PRESIDENT THIEU.

3. BEGIN TEXT. SUMMARY OF NEGOTIATING EFFORTS ON CAMBODIA. WE HAVE MADE CONTINUAL AND NUMEROUS PRIVATE ATTEMPTS, IN ADDITION TO OUR NUMEROUS PUBLIC DECLARATIONS, TO DEMONSTRATE IN CONCRETE AND SPECIFIC WAYS OUR READINESS TO SEE AN EARLY COMPROMISE SETTLEMENT IN CAMBODIA.

-- THROUGHOUT THE NEGOTIATIONS THAT LED TO THE PARIS AGREEMENT ON VIET-NAM IN JANUARY 1973, THE UNITED STATES REPEATEDLY INDICATED ITS DESIRE TO SEE A CEASEFIRE AND POLITICAL SETTLEMENT IN CAMBODIA, AS WELL AS IN VIET-NAM

AND LAOS. IN LATER DISCUSSIONS CONCERNING THE IMPLEMENTATION OF THE PARIS AGREEMENT, THE UNITED STATES CONVEYED ITS IDEAS AND ITS DESIRE TO PROMOTE A NEGOTIATED SETTLEMENT BETWEEN THE CAMBODIAN PARTIES.

-- ON MANY OTHER OCCASIONS IN 1971 AND 1972 WE MADE CLEAR OUR INTEREST IN SEEING AN INDEPENDENT AND NEUTRAL CAMBODIA ESTABLISHED THROUGH NEGOTIATIONS AND NOT THROUGH A BATTLEFIELD VICTORY.

-- A NUMBER OF MAJOR EFFORTS TOWARD NEGOTIATION WERE MADE IN 1973, EFFORTS WHICH WERE THWARTED BY THE FORCED BOMBING HALT IN AUGUST OF THAT YEAR.

-- IN OCTOBER 1974, WE BROACHED THE IDEA OF AN INTERNATIONAL CONFERENCE ON CAMBODIA AND WITH TWO COUNTRIES HAVING RELATIONS WITH THE GRUNK. WE ALSO DISCUSSED THE ELEMENTS OF A PEACEFUL SETTLEMENT. WE RECEIVED NO SUBSTANTIVE RESPONSE TO THESE OVERTURES.

-- IN NOVEMBER 1974, WE AGAIN INDICATED WITH SPECIFICITY OUR READINESS TO SEE A COMPROMISE SETTLEMENT IN CAMBODIA IN WHICH ALL ELEMENTS COULD PLAY A ROLE TO A GOVERNMENT WITH RELATIONS WITH THE GRUNK. OUR INTERLOCUTORS SHOWED NO INTEREST IN PURSUING THE SUBJECT.

-- IN DECEMBER 1974, WE TRIED TO FACILITATE A CHANNEL TO REPRESENTATIVES OF THE KHMER COMMUNISTS THROUGH A NEUTRALIST COUNTRY WITH RELATIONS WITH THE GRUNK. NOTHING CAME OF THIS INITIATIVE.

-- IN DECEMBER 1974 AND EARLY JANUARY 1975, WE CONCURRED IN AN INITIATIVE TO OPEN A DIALOGUE WITH SIHANOUK IN PEKING. SIHANOUK AT FIRST AGREED TO RECEIVE AN EMBASSY, BUT LATER REFUSED.

-- IN FEBRUARY 1975, WE TRIED TO ESTABLISH A DIRECT CONTACT WITH SIHANOUK OURSELVES. WE RECEIVED NO RESPONSE.

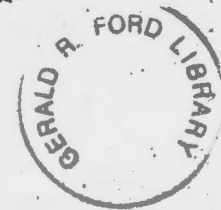
-- ALSO IN FEBRUARY 1975, WE APPRISED CERTAIN FRIENDLY GOVERNMENTS WITH CLEAR INTERESTS AND CONCERNS IN THE REGION, AND WITH ACCESS TO GOVERNMENTS SUPPORTING THE GRUNK, OF OUR EFFORTS TO MOVE THE CONFLICT TOWARD A NEGOTIATED SOLUTION AND OF THE DEGREE OF FLEXIBILITY TO OUR APPROACH. THEY COULD OFFER NO HELP.

UNFORTUNATELY, NONE OF THESE ATTEMPTS HAVE HAD ANY RESULT. THE REACTIONS WE HAVE GOTTEN SO FAR SUGGEST

THAT NEGOTIATING PROSPECTS WILL BE DIM AS LONG AS THE CAMBODIAN GOVERNMENT'S MILITARY POSITION REMAINS PRECARIOUS.

WE ARE CONTINUING TO PURSUE OUR LONG-STATED OBJECTIVE OF AN EARLY COMPROMISE SETTLEMENT IN CAMBODIA. IN THIS PROCESS WE ARE, AND HAVE BEEN, GUIDED BY THE FOLLOWING PRINCIPLES:

1. THE UNITED STATES WILL SUPPORT ANY NEGOTIATIONS THAT THE PARTIES THEMSELVES ARE PREPARED TO SUPPORT.
 2. THE UNITED STATES WILL ACCEPT ANY OUTCOME FROM THE NEGOTIATIONS THAT THE PARTIES THEMSELVES WILL ACCEPT.
 3. AS FAR AS THE UNITED STATES IS CONCERNED, THE PERSONALITIES INVOLVED WILL NOT, THEMSELVES, CONSTITUTE OBSTACLES OF ANY KIND TO A SETTLEMENT.

UNRAVEL THE KHMERS AND THEIR GOVERNMENT. YOU SHOULD THEREFORE TAKE NO ACTION WITH REGARD TO THE SCENARIO PROPOSED BY HANG THUN HAK.

2. U.S. INITIATIVES FOR NEGOTIATIONS ARE TO BE STRICTLY CONTROLLED FROM WASHINGTON. THE SAME IS TRUE FOR ANY EMBASSY INVOLVEMENT IN INITIATIVES BY THE KHMERS THEMSELVES. WE DO NOT WANT TO GET IN THE POSITION OF APPEARING TO BE CONNIVING IN THE OVERTHROW OF THE EXISTING STRUCTURE IN PHNOM PENH. THE MAINTAINANCE OF SOME ORDER AND COHESION IN PHNOM PENH IS ESSENTIAL TO ANY NEGOTIATIONS. THIS PURPOSE WOULD NOT BE SERVED BY

YOUR ALIGNING YOURSELF WITH CAMBODIAN PERSONALITIES BY TAKING THEIR IDEAS TO THE MARSHALL WHO WOULD ONLY READ THEM AS U.S. DESIRES. THEREFORE, YOU ARE NEITHER TO ENCOURAGE NOR DISCOURAGE HANG THUN HAK AND LONG BORET NOR ARE YOU TO SUPPORT THEIR EFFORTS DIRECTLY WITH THE MARSHALL. INGERSOLL

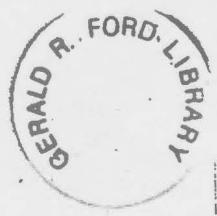

1. YOU WILL BE RECEIVING A CINCPAC MESSAGE REQUESTING YOUR VIEWS AS TO THE FEASIBILITY OF ASSIGNING TO MEDTC THE MILITARY PERSONNEL DESCRIBED REFTEL WHO ARE NOW MAKING DAILY FLIGHTS TO AND FROM THAILAND. SOME CURRENT MEDTC PERSONNEL MIGHT, OF COURSE, HAVE TO LEAVE TO MAKE ROOM FOR THESE PERSONNEL.

1. FULLY APPRECIATE YOUR COMMENTS ON THE EFFECT THAT THE DEBATE ON CAMBODIA HERE MAY BE HAVING ON THE KHMER. WE ARE DOING OUR UTMOST TO PRESERVE A BALANCED PERSPECTIVE IN OUR DISCUSSIONS WITH MEDIA REPRESENTATIVES AND THE HILL. THE MANAGEMENT OF VOA IS IN FULL ACCORD WITH OUR POLICY AND WE CONSULT AT THE WORKING LEVEL VERY CLOSELY. WHILE WE CANNOT CENSOR STORIES, OUR VIEWS ARE CONSIDERED.

2. CONCERNING THE SPECIFIC CASE OF VOA COMMENTARY ON THE HUMPHREY STATEMENT WE HAVE SPOKEN WITH THE VOICE AND BEEN ASSURED THAT A BALANCED STATEMENT WILL BE AIRD CONCERNING CONTINUING SUPPORT BY THE ADMINISTRATION PLUS FANK'S ONGOING EFFORTS TO FIGHT BACK. INGERSOLL

SUBJECT: CAMBODIA: JAPANESE APPROACH

1. IN RESPONSE TO OUR EARLIER DISCUSSION WITH THE JAPANESE, THEY HAVE NOW RESPONDED BY SAYING THAT THEY ARE WILLING TO SPEAK AT THEIR OWN INITIATIVE TO THE NORTH VIETNAMESE, CHINESE, AND THE SOVIETS ABOUT A CAMBODIA SOLUTION. WE HAVE AGREED TO THEIR INITIATIVE AND HAVE PROVIDED THEM WITH SOME TALKING POINTS ALONG THE LINES OF POINTS WE HAVE USED IN OUR EARLIER APPROACHES. THE JAPANESE WILL USE THESE TALKING POINTS AS THEIR OWN.

2. WE WILL KEEP YOU INFORMED BUT DO NOT REPEAT NOT WISH TO MENTION THIS JAPANESE FOLLOW-UP TO LON NOL AT THIS TIME. INGERSOLL

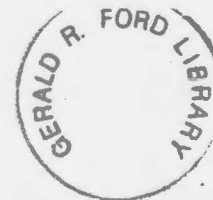

1. IF A DECISIVE CONGRESSIONAL VOTE AGAINST SUPPLEMENTARY MILITARY ASSISTANCE TO CAMBODIA OCCURS, YOU SHOULD TAKE THE FOLLOWING ACTIONS.

2. UPON RECEIPT OF A STATE MESSAGE REFERRING TO THIS ONE AND INFORMING YOU OF THE NEGATIVE VOTE, YOU SHOULD INFORM LON NOL THAT THE VOTE MEANS WE WILL SOON RUN OUT OF FUNDS FOR MILITARY AID. YOU SHOULD STRESS THE FACT THAT THE USG WILL CONTINUE MILITARY AND FOOD AID SHIPMENTS AS LONG AS EXISTING FUNDS LAST AND THAT THE GKR OF COURSE WILL HAVE WEEKS OF FUEL, FOOD AND AMMUNITION LEFT AFTER OUR SHIPMENTS END. THUS, PANK WILL BE ABLE TO DEFEND THE COUNTRY WHILE THE GOVERNMENT MAKES ITS VITAL DECISIONS ABOUT THE FUTURE.

3. YOU SHOULD TELL LON NOL THAT OUR SUPPORT FOR THE GKR WILL CONTINUE. IF LON NOL REQUESTS ADVICE CONCERNING THE SECURITY SITUATION AND POLITICAL STEPS TO BE TAKEN, YOU SHOULD STATE THAT YOU HAVE NO CONCRETE SUGGESTIONS, OTHER THAN TO SUGGEST THAT HE CONSULT HIS COLLEAGUES. IF HE EXPRESSES CONCERN FOR HIS AND HIS FAMILY'S SAFETY, AS WELL AS FOR THE SAFETY OF HIS COLLEAGUES, YOU SHOULD INDICATE CLEARLY THAT THE ACTUAL SITUATION DOES NOT WARRANT SUCH CONCERN AT THIS POINT. YOU SHOULD NOTE THAT THE US MISSION WILL CONTINUE TO FUNCTION NORMALLY TO ADMINISTER THE ONGOING AID SHIPMENTS AND THAT YOU HAVE NO PRESENT PLANS TO EVACUATE OFFICIAL AMERICANS. IN ANY CASE, WE WILL ENSURE HIS SAFETY.

4. FYI: WE RECOGNIZE FROM PHNOM PENH 4558 THAT THE MOOD IN PHNOM PENH AFTER AN AID CUT-OFF MAY NOT PERMIT US TO HOLD TO THIS POSTURE ON EVACUATION FOR VERY LONG. HOWEVER, WE ARE CONCERNED THAT EVEN THE PARTIAL EVACUATION YOU SUGGEST WOULD LIKELY CONTRIBUTE TO PANIC AMONG THE KMMR AND TO AN EARLY COLLAPSE OF THE GKR. THIS WE WISH TO AVOID IF WE POSSIBLY CAN. THEREFORE, YOU SHOULD NOT REPEAT NOT ORDER ANY EVACUATION WITHOUT RECEIVING FINAL AUTHORIZATION FROM WASHINGTON. OF COURSE, IN EXTREMIS, IF IN YOUR CONSIDERED JUDGEMENT AMERICAN LIVES ARE IN IMMEDIATE DANGER, AND YOU ARE UNABLE TO CONTACT WASHINGTON, YOU HAVE THE FINAL DECISION AS TO THE METHOD AND TIMING OF EVACUATION WITHOUT REQUESTING INSTRUCTIONS.

THESE INSTRUCTIONS HAVE BEEN APPROVED BY THE SECRETARY.

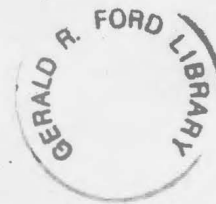

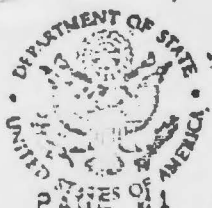
