The President plans to address the nation this Monday at 8 p.m. Eastern Time on two subjects of great importance to the nation: first, the need to stimulate the economy ~~through~~ by lowering the burden of taxation; and secondly, the need to ~~be~~ preserve ~~benefits~~ the integrity of the Social Security ~~System~~.

We have been informed today that two networks -- CBS and NBC -- now plan to carry the address live. We do not know what ABC or others may do, but trust that you can obtain that information from them.

We expect the speech to be about a half hour or less in length. The President will be working on the address this weekend ~~while~~ while at Camp David.
