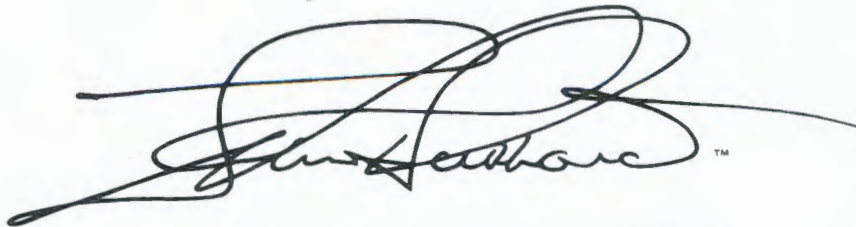

What is an Executive?

By L. Ron Hubbard

What is an executive? Is it someone who is important? Who gets more pay? Who has authority? Perhaps. But these are not the real reasons that such posts exist.

Most successful executives can personally do more work than other people: their output¹, quite usually, is very large. And though this is often necessary, that isn't the reason either.

Let us take up the meaning of the word "executive." It is derived from the word "executor" which means "a person who gets something done or produced." The word comes from the Latin *ex* -completely + *sequi* -to follow and means "to follow through to the end." In other words, to get something DONE!

In any business or production organization, its prosperity depends upon GETTING THINGS DONE!

The executive is there to ensure that the people produce what they are supposed to produce and in viable quantity and with no overt products².

And that is why an executive is there and that is what he is supposed to do.

In these druggie days of super-socialism, people can get other ideas of why an executive is there. And, unfortunately, executives themselves can get other ideas of their role.

It is an unfortunate fact, whether in a capitalism or a communism, that when an individual human being does not produce, he not only, in the short run or long run, cuts his own throat but he also drags the whole team down. A team or organization that does not produce not only loses its morale and pride, it also is committing eventual suicide.

The graveyards of history are full of "leisure classes" that did not produce: the peasants get real tired of seeing the aristocrats loaf and eventually cut off their heads. Modern times are crammed with beautiful experiments of "workers' paradises" where everyone is starving to death.

One sees the TV commercials and reads the paperbacks and they tell him that his goal

is expensively bought leisure and that the ideal is to lie beneath the palm trees and do no work. Whole ideologies get built around this beautiful dream of a world in which no single person ever lifts a finger and sighs away his days in loafing bliss.

Unfortunately, this does not align with the facts. The unhappiest little kids in the world are those who have nothing to do: they whine and mope and quarrel and are quite a burden to their mamas. People on relief or living on social security are the most miserable lot, morale-wise, one ever collided with: they will tell you they would rather have a job. The death rate of men who have retired is startling: cast aside and feeling purposeless, no longer producing anything, they, as insurance companies will tell you, mostly pine away and die. In short, people who don't produce are very unhappy people.

Union agitators, once upon a time, promised all the workers that in a few decades, they would be in clover. Less work and more pay was the slogan. And where, today, is this dream? Failing to produce, union members are out there in their millions, unemployed! And this lack of production is making the cost of living so high that even if they did work, they would have trouble finding enough dollar bills to buy a hamburger.

A certain amount of lying in the sun is a good thing. A laborer should not be worked to death.

But all things are best in moderation. The "leisure class" goes to extremes of purposeless loafing, the working man produces far less than he's paid for and in either case down comes the organization or the country.

A worker-oriented executive is trying to be liked by not requiring work from his organization: What is he actually accomplishing? He is lowering their living standards; he is pushing them into poverty; if he keeps on failing to persuade them to produce, he will kill them off. It categorizes as a suppressive act³. "Go on, Joe, take the day off." "Oh, you poor fellow, you shouldn't work so hard." "Who cares about the stats, let's only

work from eleven a.m. to noon." "Are you all comfortable as you doze? Oh, that's good, snore on." Such a person is surely not an executive: he's an imposter with a pistol leveled at the staffs' head. For surely, surely it is HE who has them drawing such low pay and it is HE who will at last, through their tolerated indolence, get them fired. It is HE who will lose the org⁴. That's a pretty high price to pay for "being a good fellow."

Holding a post on which he is entrusted to get things DONE, he is a traitor to his organization and to his staff.

Of course, there are penalties connected to getting people to produce. They are often green and unhatted and need somebody to show them where to put what when. They are often bewildered and don't understand why these papers have to go in the right folders. And when one tries to get them to do some work, they sometimes snarl back or walk off and won't play pool with one anymore.

But if one thinks that by taking it easy on staff he will make points, an executive is VERY mistaken. Usually such an executive is actually despised. Down deep the staff knows what he SHOULD be doing with them and if he, having the title, doesn't do it, they see him as a fake.

It is interesting that staffs respect competent executives who get the job done. They respect the one that makes them work and they trust him.

It is a maxim that crews, staffs and employees respect only those in power who do their jobs and get them to do theirs. Oh, yes, they will elect people who tell them they don't have to work. But it's interesting that the first ones they blame when things go wrong are these worker-oriented softies: in the chaos of their wake, the next one people will support is a tough strong one who knows his business.

The only executives that staffs and crews really respect are those who get them to produce and get the job done.

Look at Carter, the past unlamented president. Although he talked a lot about leadership, although he was the darling of the working man and all that, in office he was so wishy-washy, soft and incompetent — everybody's pal — that they eventually threw him out with a landslide victory for his opponent, a very tough talking man who was actually anti-socialist.

However one tries to coat the pill, there is no substitute, in an executive, for the ability to get the crew to produce.

The fire-breathing product officer will be followed and supported when the wishy-washy old pal guy will be stepped all over in the rush to follow a real leader.

Across the world, looking at organizations, one can spot every company and org which has executives who do not get their crews to produce. Such areas loom up like danger flags of trouble. Although their executives might think they are being good fellows, loafingly cheered by all, the fact is that their crews, behind their backs, despise them, the public regards them with contempt and the upper management echelons look at those loafing stats and put the names of those executives in a little black book for soonest firing.

It is not hard to detect a happy, cheerful org: its stats are up. And it is not hard to detect executives who are NOT making their crews produce: there's lots of conflict and trouble in the place and their stats are down.

Management looks everywhere for executives who can get their crews to really produce. And oddly enough, so do the crews. If you don't believe it, try it.

¹OUTPUT: The amount of work accomplished or the quantity of something produced by an employee, machine, plant, company, etc.

²OVERT PRODUCT: A bad one that will not be accepted or cannot be traded or exchanged and has more waste and liability connected with it than it has value.

³OVERT: We have the word "overt", meaning a bad deed.

⁴SUPPRESSIVE ACTS: Actions or omissions undertaken to knowingly suppress, reduce or impede Scientology or Scientologists.

⁵ORG: slang abbreviation for "organization".

Prudence, indeed, will dictate that governments long established should not be changed for light and transient causes; and accordingly all experience hath shown that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same object, evinces a design to reduce them under absolute despotism, it is their right, it is their duty, to throw off such government, and to provide new guards for their future security.

ON BEHALF OF OURSELVES AND OUR POSTERITY, we now declare that for the past seventy years the American people have patiently suffered similar grievances as those suffered by our forefathers; and such is now the necessity which constrains us to call upon the President of the United States and all members of the House of Representatives of the United States and all members of the Senate of the United States and all Governors and Legislators of the Fifty States to immediately return America to the original purpose of this great nation as envisioned and structured by the founding fathers in the Constitution of the United States and the Bill of Rights.

The history of the present government—including the Executive, Legislative, Judicial, and the unelected and unconstitutional fourth branch of government, the bureaucracy—for the past seventy years is a history of repeated injuries and usurpations, all having in direct

object the establishment of an absolute tyranny over the citizens. To prove this, let facts be submitted to all citizens of these United States.

1. The Constitution of the United States and the Bill of Rights as envisioned and structured by the founding fathers have been declared null and void by Acts of Congress, the bureaucracy, and the courts. Many courts have banned the reading of or any reference to the Constitution and the Bill of Rights in courtroom litigation.

2. The courts are endorsing and supporting the unelected bureaucracies at virtually every level in investigating, approving or disapproving, licensing and controlling religion, churches, and their God-ordained ministries. This, among many other abuses, has resulted in the jailing of pastors (some for refusing to surrender church records to unelected bureaucracies and the courts, and others for conducting church ministries of preaching and teaching the Gospel), the padlocking of a church, and worshipers being dragged from a church building by law enforcement officers.

3. The courts have returned to the Star Chamber and have assumed a role of self-appointed sovereign supremacy and thus have become tyrannical and despotic in their actions by ignoring the Constitution of the United States and the Bill of Rights while protecting themselves with a self-imposed cloak of so-called sovereign immunity.

4. The courts have assumed a legislative role and are imposing upon the citizens "judicial legislation" based upon so-called "public policy" and "overriding government interest" that violates the very Constitution they have sworn to uphold.

5. The Supreme Court of the United States has decreed that justice will be meted out in light of current public sentiment and without regard to Divine absolutes.

6. The Supreme Court of the United States has assumed a self-imposed role of deity and authorized the murder of over twelve million babies by way of abortion since 1973.

7. Citizens are forced to pay for the murder of babies by way of tax-funded abortion in violation of their religious convictions.

8. Citizens are forced to pay for the funding of sodomite organizations through taxation in violation of their religious convictions.

9. Citizens are forced to pay for the funding of slothfulness, fornication, adultery, illegitimacy, and a multitude of other wicked sins through taxation in violation of their religious convictions.

10. Citizens are forced to pay for a humanistic public educational system that is anti-God, anti-Christ, anti-Bible, anti-Family, anti-American, and anti-Constitutional through taxation in violation of their religious convictions.

11. Congress, legislatures, and the courts have combined with the bureaucracies to subject the citizens to a jurisdiction foreign to our Constitution and the Bill of Rights and unacknowledged by the founding fathers.

12. Our government has formed a multitude of new bureaucratic offices that send swarms of officers across America to harass the citizens and eat out their substance.

13. The bureaucrats have become a standing army that wages war against the citizens and invades the privacy and security of the citizens in their persons, houses, papers, effects, businesses, families, and religion.

14. The coinage of gold and silver has been unlawfully suspended in violation of Article 1, Section 8, Clause 5, and Article 1, Section 10, Clause 1 of the Constitution of the United States by Executive Order, Acts of Congress, and Judicial Rulings; and the circulating medium of

exchange has been replaced with irredeemable paper currency called Federal Reserve Notes.

15. The monetary policy of America is controlled by a privately-owned and secretly-operated corporation—the Federal Reserve System.

16. Government contrived and controlled inflation is destroying America and the hopes of our children and grandchildren of ever owning homes or lands of their own.

17. Taxes are imposed upon us without our consent.

18. The oppressive boot of the communist-designed graduated income tax grinds more and more heavily on our necks and is destroying the producers of America.

19. The Internal Revenue Service is enforcing social and public policy rules and regulations of its own design and formulation in violation of the Constitutional principle of separation of powers.

20. The Internal Revenue Service regularly resorts to Gestapo-like tactics in the collection of "taxes"; this strategy has reduced the majority of our citizens to the fearful and whimpering state of common slaves.

21. Churches have been unlawfully brought under the jurisdiction and control of government by Congress, the President, the Supreme Court of the United States, State Legislatures, and the unelected bureaucracies.

22. Churches are required to have federal tax identification numbers and to collect and pay social security taxes in violation of their religious convictions.

23. Congress, with few exceptions, has abdicated its Constitutional function by failing to guard against the erosion and destruction of the rights, privileges, and liberties of the citizens and by passing legislation that violates the letter and the spirit of the Constitution of the United States and the Bill of Rights.

IN EVERY STAGE OF THESE OPPRESSIONS, we have warned time and time again of the unwarranted jurisdiction which these acts extend over us and have petitioned for redress in the most humble terms; our petitions have been answered only by a deaf ear and repeated injury. A government whose character is thus marked by every act which may define tyranny is unfit to be the government of a free people.

WE, THEREFORE, the undersigned, now humbly petition the President of the United States, the House of Representatives of the United States, the Senate of the United States, and the Governors and Legislatures of the Fifty States for a redress of grievances and for immediate relief and freedom from these tyrannical and despotic acts and oppressions of a government which is foreign to the republic envisioned and structured by the founding fathers and which has usurped the rights, privileges, and liberties of the American people as guaranteed and protected by the Constitution of the United States and the Bill of Rights.

AS DID THE FOUNDING FATHERS, we place as a priority the restoration of our God-given rights and liberties as protected by the First Amendment to the Constitution of the United States, to wit, that by virtue of Divine Authority from God, existing before the United States became a nation, the church has rights and responsibilities over and above the limitations handed down by men's constantly changing opinions, philosophies, and laws which too often seek to prevail against the church and her mission on earth through time.

THEREFORE, BY VIRTUE OF THE FIRST AMENDMENT to the Constitution of the United States, it shall be recognized by all branches and at all levels of government, including the courts, that all religions, churches, and their ministries cannot and must not come under the jurisdiction of federal, state, or local governments or any of their agencies, except, when a

religion or church or their ministries choose to voluntarily:

1. Accept said jurisdiction
2. Accept direct public tax funds
3. Commit acts to a person against the will of the person or his legal guardian, which result in a crime against said person's life, liberty, or property.

NOTICE IS HEREBY GIVEN to the President and all Congressmen, Senators, Judges, and Magistrates of the United States; Governors, Legislators, Judges, and Magistrates of the Fifty States, and all others in governmental positions: if our demand for Redress of Grievances is met with deaf ears and repeated injuries, we will use whatever Biblical and Constitutional means are necessary to protect and defend our God-ordained families, homes, religious liberties, churches, and the Constitution and the Bill of Rights of the United States.

WE THE UNDERSIGNED, humbly affix our signatures to this petition with the purest of motives and the belief that this nation, under God, must once again be brought under the restrictions of Constitutional mandates. Our purpose is to rebuild, not to destroy. We appeal to our elected officials not to again answer us with deaf ears and repeated injuries.

FINALLY, FOR THE SUPPORT OF THIS DECLARATION, with a firm reliance on the Divine Protection of our Sovereign Lord and Saviour Jesus Christ, we mutually pledge to our God, to each other, and to our posterity: our lives, our fortunes, and our sacred honor.

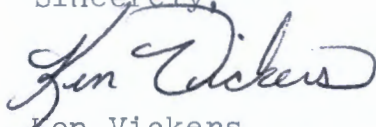

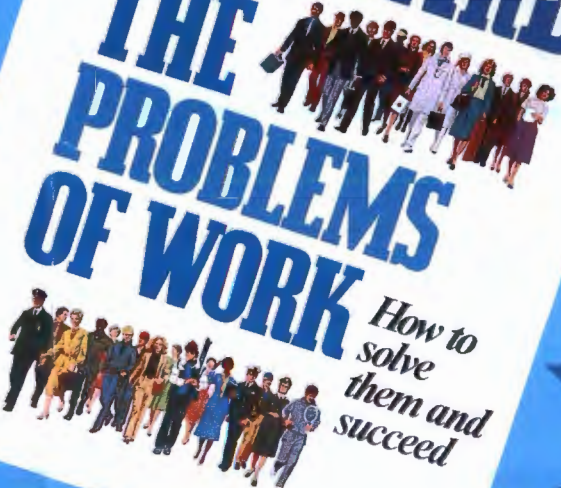

dangerous darkness that some true light had to appear to drive it out. As I am currently in Washington, D.C., you will know that I am here to give a dramatic push forward to those who must encourage our President to seek re-election.

While some of my writings and letters have circulated widely in governmental circles during the past year, you have never received any material from me so I am unknown to you and your staff in the White House.

In order to introduce myself I am attaching some information to appraise you of my background.

Currently I am one of the American citizens who has stepped forward as a result of the President's call for volunteers. I have been organizing a group of local people to encourage the President to seek re-election. These people are not involved in the wing of the Republican party that I call the Internationalist wing. They are in the wing of the Republican party led by the President which I call the Americanist wing.

In the past several days I have received several reports that this nucleus of Reagan supporters from the very grass roots of America have been subject to harassment, surveillance and following by members of the sheriff's department in Gallatin County, Montana. These observations have been made by several witnesses and have been verified by a source in the Courthouse in the area. Apparently a massive effort to discredit Reagan supporters forming in Gallatin Gateway, Montana and Four-Corners, Montana was under-way complete with illegal drugs ready for planting in their homes, apartments and offices in a large scale "drug bust".

As an American who has had it with such treachery as the enclosed material will clearly demonstrate, I am looking to you since you run the drug squad under special assignment for the FBI. Judge Webster has a copy of a letter of protest I wrote in 1981 informing him not to send FBI agents to interview me without writing me regarding all arrangements in advance as a result of being hassled by the FBI in my home in Fargo, North Dakota at the very moment President Reagan was taking the oath of office on national television in January of 1981. I continue to resent their use of the illusion that President Reagan would condone such an insulting tactic. I am informing you to notify me in writing and wait for my written reply before proceeding with evidence in this treachery against the President and his grass roots supporters.

When I challenged the illegal behavior of a large company back in North Dakota twelve years ago, I came to be targeted for defamation, harassment, economic undermining and even various acts of terrorism. As the years went on, it emerged that the FBI was the agent of all the trouble. The enclosed material will outline the background of these events. Since I have forgiven everyone involved, I am sending you the material only to give you the information necessary to form the conclusion that this letter comes to you from an expert on the subject of the FBI and its illegal use by the Internationalists as their secret police. As an aside, I might add that American history will disclose that at various intervals since 1947 the CIA has been in the hands of the Internationalists and in those eras it has a bloody record. One of the reasons I support President Reagan so strongly is that I have personal knowledge that the CIA under his administration is the cleanest operation in many years. It is for this reason -- the unavailability of the American CIA for "hit" work by the Internationalists -- that Mr. Casey, its current director, is so frequently "taken on" in the press which is owned by the group I call the Internationalists. They simply cannot advance their secret plans with taxpayers money under the new CIA.

It is now time for a "new FBI". The legacy of J. Edgar Hoover remains throughout that organization and it is a seamy operation.

As the years have gone on, I have been set-up for a bullet wound on my right side, ashes for a home, terrified children at times for memories of their childhood, dead animals on the door-step, undermining of reputation and finances by the FBI when I refused a bribe from a grain company given "licence" to ravage the farmers through illegal Internationalist power. The latest attacks include attempts to frame me in a number of ways. (Apparently the "options" discussed have become so numerous that someone on the edge of the matter has become so revolted as to commence a rebellion. Since an FBI agent from Fargo, North Dakota named Karl Nyberg once resigned in protest over the bugging of my house by FBI agents from the east, when he knew I was acting with integrity, further outbursts from decent men who have had enough of illegal hatchet work for desperately crooked enormous interests, can also be expected to step forward. Their Libyan agitator against me at Montana State University got a slight mosquito bite in public last week as an attempt to show "impartiality" in the strategy.)

Currently, a matter dropped a year and a half ago in North Dakota has been revived. For 18 years I was a member of the Bar Association in North Dakota, from 1964 to 1981. My performance was such that Judge Ronald N. Davies appointed me counsel for Joseph Andrews Wakaksan in a federal manslaughter trial. My performance before the 8th Circuit court of appeals in St. Louis on his behalf got me an appointment from Chief Judge Charles Vogel in the William Edward Love appeal, according to Judge Vogel's statements to the senior partner of the firm with which I practiced. After 17 years of being a member of the Bar without the slightest ethical complaint, I wrote the attached book-review and shortly thereafter I had five complaints filed against me with the ethics committee. One was for embezzlement of funds and since it was a patent fabrication, the charge was quickly dismissed. The second charge was that I would

not return a file to a client. Since the file had burned along with my house, I could not return it so the ethics committee dismissed the charge. The other three were from women clients, each regarding fees they had payed me. All fees had been discussed in advance and substantial services had been rendered. One of the women had filed ethical complaints against her two previous North Dakota attorneys. It was on a matter against one of the two lawyers that I was assisting her when I discovered she did not have a case for damages against this lawyer, told her so after much investigation and then was myself "turned in." Her case does not bother me at all because she was always involved in such complaints at the Bar Association. It is the fourth and the fifth charges that came to concern me and which led to my going to war with the ethics committee. The fourth person came to my office in tears one day before I was driven out of town with other tactics and asked me to file an ethical complaint for her against the lawyer who talked her into filing charges against me. I told her I would have nothing to do with such tactics. The fifth woman later wrote me an apologetic letter stating who had gotten her to do this to me. Anyway, I simply resigned from the North Dakota Bar and finally heard no more from them. However, in December of 1981, after I wrote some material about the Middle East that infuriated the Internationalists since it sided with the moderate Askenazy Jewish position and they side with the Sephardic Jews, I was hiding in a tent over Christmas up by Drummond, Montana. I made my way to Washington in January of 1982, and I spent over half of that month there making the necessary contacts to assure my physical survival. A few weeks later, the Reagan administration got directly to the heart of the problem.

Since I have begun putting my writing abilities and endless energy at the service of a volunteer effort to get Mr. Reagan to run again in 1984, I have encountered the strategies referred to earlier and others aiding me have had similar threats. These threats are directly tied to the illegal drug ring according to sources.

I spent the month of June of 1983 traveling around the country making various contacts and acquiring various research. Since it is well known that I hate drug rings and how they can be so easily orchestrated by massive corrupt forces to do dirty work for them, I am always analytical of which fronts are used to interfere with my work. When I returned to Bozeman, I wanted a few days of privacy to complete work on one of the Dead Sea Scrolls that I had started at the Harvard Divinity School, and I checked into a motel and worked long hours on the first English translation of the Temple Scroll. One night I was followed by a Libyan whom the FBI had hired to be a constant source of harassment to me for over a year. Since no one knew I was back yet, when the two deputies were at the motel door the next morning with five pounds of ethics complaints against me from North Dakota, I knew what was going on. The papers had been dated over a year and a half ago -- during the very week I was hiding from assassin's bullets in a tent by Drummond! Hence, as I lift my head for the President, an old plan of discrediting me, once dropped, has now been dusted off. It is so stale and so far out that all it did was expose the desperation of the opposition.

After several years of warfare and serious defamation, I came to have some severe depressions. I sought a good deal of help and on two occasions I was unable to sleep for several days and spent four days in the hospital on two separate occasions. As a result the national computer network of the Internationalists has been stuffed with "facts" regarding psychotic "episodes" -- even though they do not exist. However, it is an effective technique for keeping a man out of the credit system of the country. Another strategy is to drive a man out of town often enough so that he cannot make enough of a living to maintain his credit rating.

Three years ago, I was seated in the YMCA in Fargo, North Dakota talking to three friends and my three sons when a whole bevy of law enforcement people appeared. I was arrested for being dangerous to myself and others. The three friends who saw this atrocity are a hospital administrator, a Roman Catholic nun and a young man now finishing his seminary training in Rome. When the judge began to sweat after the facts revealed who was behind the charade, I was out of jail within 24 hours. Now it is true in a sense that I am a danger -- but only to those who offer bribes, sell drugs, defame honest people, terrorize women and children and assassinate the character and persons of Presidents. However, in every other respect I try my best to respect the rights of others and live according to the laws of God. Since man's laws now exceed in number and complexity any person's ability to know them all, I will simply say that I also try my best to obey God's laws.

What I am placing before you in your capacity as head of the special drug force in the FBI is that there is a connection between a campaign of attempted set-ups, frame-ups, defamation and threats against a grass roots campaign for the President and the illegal drug ring out here. Now that you are aware of this matter, please recall that I want inquiries made by mail until law enforcement officials uninvolved in these tactics can be made available for the remainder of the investigation and the arrests.

Book Review

"The Bureau: My Thirty Years in Hoover's FBI"

By William G. Sullivan

W.W. Norton & Company, 1979, 286 Pages, \$12.95.

When William Sullivan was completing thirty years of service in the Federal Bureau of Investigation, many of those years in positions very close to J. Edgar Hoover, he challenged the Director directly and was shortly out of the FBI. This book tells the inside workings of Hoover's FBI like few publications can do because Sullivan was, for a time, the number three man in the Bureau.

Sullivan tells of a Director more interested in image and politicking than in genuine law enforcement. He tells about the FBI's training school focusing heavily on propaganda instead of basic techniques of good criminal investigations in order to build Hoover's image along with his FBI's image. The young agents were told in Hoover's day that the FBI's motto ("We never close a case") was better than the motto of the Canadian Mounties ("We always get our man"). No one dared even challenge such teachings or inspect them for fear of being ousted from the Bureau.

Mr. Sullivan shows Hoover's constant interest in politics and his persistence in going around channels to deal directly with the President of the United States. In 1942 an electronic bug on the telephone of a Scandinavian beauty suspected of espionage recorded the voice of Lieutenant John F. Kennedy. Without his knowing the slightest thing about it, young Kennedy was shunted away to the South Pacific through Hoover's connections. (Ironically it was on this mission arranged by Hoover that young Kennedy gained heroic standing with his PT boat.)

The author tells about how Hoover refused to acknowledge the existence of the American Mafia until he was forced to do so by overwhelming documentary evidence.

The former Director spent much of his time arranging to frame, follow or set-up political leaders he did not feel he had in his pocket. Sullivan's barrage of disclosures in this area will alert the public to the fact that not a single Senator or Congressman in Washington in Hoover's era was safe from harassment until he had comfortably submitted to Hoover.

This excellent book shows how the man who fought bank robbers and interstate car thieves in front of press cameras (sometimes the press would wait hours for Hoover to arrive where FBI agents had detained a suspect so Hoover could be photographed personally making the arrest) actually turned his head while Big Crime came to dominate America's heart and spirit.

Mr. Hoover faced his biggest crisis in 1964, the year when John Kennedy planned to replace him as head of the FBI if he won re-election.

Hoover's hold on the political process was broken with his death in the early 1970's, but the legacy he left America remains to be brought into the open air. William Sullivan's contribution to the process of starting that airing is exceptional.

WASHINGTON, Aug. 20 — President Reagan has ordered an end to export controls on the sale of a type of pipeline equipment to the Soviet Union, the Commerce Department announced today.

removal of the curtailment of grain sales and the conclusion of a long-term grain agreement. In addition, Washington has agreed to discuss a rescheduling of the Polish debt with other creditors as well as with the Polish Government, while continuing to resist any agreement at this time.

Weinberger Fought Decision

The decision resolves an intense struggle in the Administration in favor of Secretary of State George P. Shultz and Commerce Secretary Malcolm Baldrige, according to officials.

Secretary of Defense Caspar W. Weinberger was the leading opponent of the action, they said.

The decision was made Friday by the President while on vacation at his California ranch, said B. Jay Cooper, spokesman for Mr. Baldrige. It involves a type of equipment called pipelayers. They are heavy tractors with powerful hoists that place large-diameter pipe in trenches for oil and gas transmission systems.

'A Major Policy Shift'

The principal maker in the United States is the Caterpillar Tractor Company of Peoria, Ill., which said it welcomed the move.

One Administration source who aggressively fought the change said it represented "a major policy shift by the Administration because pipelayers have become the touchstone of East-West trade policy."

Mr. Weinberger was unavailable for comment.

ZIONISM RULES THE WORLD

When Theodor Herzl convened the first zionist congress in Basle, Switzerland, in 1897, it was believed that a plan for world colonization of Jews was intended. It was not learned until years later that the meeting discussed a plan for world conquest. That plan is outlined in the Protocols of the Learned Elders of Zion; and it has been fully carried out.

The world is ruled by zionism. The United Nations is the symbol of its authority. It is the super government outlined in the Protocols.

to Russian and British subjects, previously given by Turkey.

Once established in Russia, bolshevism spread to other countries. Trotsky wanted world revolution. Lenin wanted America bankrupt. The first step towards bolshevizing the United States, was the organization of a communist cell in Michigan which was raided by the FBI in 1922. Frankfurter and his cohorts filed charges against the FBI and Hoover.

Another manifestation of zionist power occurred when Putnams wanted to publish the Protocols which were published in England, in 1920. They were firmly told by Louis Marshall, attorney for Kuhn, Loeb & Co. and head of the American Jewish Committee, they should not do it. They junked the plates which were later published by others.

In 1932, the Lindbergh baby was kidnapped. Lindbergh was against Roosevelt for president. Frankfurter and his gang were promoting FDR's nomination. Hauptman was a German communist.

Roosevelt recognized the communist government in Russia in November, 1933, in spite of vigorous opposition. Some of those who opposed, died suddenly. "They'll never get me out of the White House," said FDR.

Communists began to overrun the United States after the recognition. Frankfurter shoved many of them into key positions in the government. Frankfurter

and Baruch ran FDR. Baruch declared he was a zionist.

"We must have anti-semitism even if we sacrifice some of our own people," say the Protocols. Zionism has been sacrificing Jews for years and is still doing it. Leading Jews financed Stalin besides Trotsky and Lenin.

Leading Jews also helped finance the prosecution of native American Christians who were against communism and Roosevelt, in 1944. I defended one of them in Washington D.C. Frankfurter was behind Rogge, the prosecutor. One of the newspapers which they started to publicize the prosecution, was PM, a New York City daily, of which Julius Rosenwald and Chester Bowles were among the principal owners.

When the paper failed, Louis Styx Weiss, a zionist lawyer, continued it as the Star, with the money of Marshall Field. Joe Barnes was editor and Bartley Crum, publisher, both left wingers. Barnes is credited with having written or edited Eisenhower's book "Crusade in Europe." Crum recently renounced communism.

The Weiss family has been active in zionist-communist matters. Weiss's sister Carol Weiss King, was a leading communist lawyer. The Weiss law firm defended Marshall Field and the defunct PM in my libel suit. Of course, I couldn't win. The zionists used a Catholic judge from upstate New York, a Catholic cardinal in New York

City, and my own Jewish lawyer, to defeat me.

One member of Weiss's firm is a trustee of the Institute of Advanced Study at Princeton, headed by Albert Einstein and J. Robert Oppenheimer. One of the trustees of that institute testified as the only character witness for Carlo Marzanni of the State Department and OSS, convicted of perjury in denying he was a communist.

Zionists actively oppose investigations of communists in government, like the late FDR did, and they own newspapers and control radio and television commentators. Baruch has many press agents; so has Frankfurter. All of which winds up in the answer given by Waldo Frank in the February, 1944, issue of the Contemporary Jewish Record published by the American Jewish Committee, leading Jewish authority, where he says there is a "great Jew conspiracy." Based on the "dream for messianic world power" and that "Political Zionism is the instrument for its fulfillment."

The protocols have been fulfilled. Zionism rules the world. The Threat

The following is a copy of a letter received by me in Judge Eicher's court, Washington, D.C., during the so-called sedition trial, on May 26, 1944. The letter is written in long hand in ink. I have the original:—

Henry H. Klein:

Your remarks at the sedition trial were quite enlightening. Your address was a masterpiece. Such a masterpiece as could only be born in the mind of a renegade of the lowest scum of the earth.

You have done the Jewish people such harm as Hitler in his wildest mental ravings could not have conceived.

The writer knows you personally, having met you socially and I assure you without making any wild threats that you are being provided for.

No matter how low a man (?) may fall, there is always a small spark of decency in him. That small spark, if in you, will some day flame up and consume you in a fire worse than hell's hottest.

Remember, your conscience is

always with you, even in your sleep, and you do not deserve a moment's peace, having allowed yourself to fall to such depths as to plead for the Bundists and in the same foul breath discredit your parents and people of your own faith.

S. Goldsmith

Postmarked New York, N.Y., May 25, 1944—1:30 P.M. Mailed in envelope of the Waldorf Astoria, Park and Lexington Avenues, 49th and 50th Streets, New York. On reverse side of envelope, "If not delivered, etc., return to S. Goldsmith."

The writer was the wife, or other close relative of Arthur J. Goldsmith, head of the Jewish Gestapo. A copy of this letter was filed with the court in Washington and with the District Attorney in New York.

The Fulfillment

Following receipt of the above threat, I received many other threats by mail and telephone because of the vicious propaganda against the defendants in the crooked sedition case. Attempts were made to poison me in Washington, D.C., and to knock me off otherwise, in New York City. My telephone wires have been tapped most of ten years and my mail stolen. Clients and friends were warned to keep away from me and word was sent out by the Jewish caballa to starve Klein.

After the sedition trial which was finally thrown out of court, I sued the N.Y. Post, Marshal

Field and his pro-communist newspaper PM, the American Hebrew, Congress Weekly and Jewish Examiner. I was told in advance I would not be permitted to win a libel suit. I defeated the American Hebrew up to and including the Court of Appeals. The suit against the Post was for my client, Colonel Sanctuary. After the first trial in which the jury disagreed, Justice Church told me great pressure was exerted on him against us. In the second trial before Justice Pecora, we had no chance, the judge himself virtually acting for the defense, without a jury.

In my suit against Marshall Field as owner of PM, a Catholic judge was brought down from Plattsburg, N.Y., and Cardinal Spellman's engineer was put into the jury box where he misguided the judge and jury. My own Jewish lawyer worked against me while the shadow of Joe Proskauer, Cardinal Spellman's lawyer, hovered over the court room. Of course, I lost.

My suit against Rabbi Wise's Congress Weekly, was heard by an honest judge—Carrol G. Walter. Had I not foolishly waived his objection to a pamphlet I wrote long after the libel was published, offered by the defendant, I would have received a substantial verdict. I was anxious to speed the trial because I was ill. The suit was re-tried before Justice Denis Cohan, who tried hard to get me to demand a mistrial, but I was too sick to care. He went far

out of his way to encompass my defeat. I dropped the suit against the Jewish Examiner as not worth while.

The Jewish gestapo made good its threat in the courts. I have been the target of Jewish animosity since 1944, when I dared to defend a Christian, without fee or retainer, who was being framed by zionists and communists because he exposed communists and Roosevelt.

Zionism is Treason

It is a program for the political conquest of the world, including the United States. The United Nations is its instrument. It is the super government mentioned many times in the Protocols of the Learned Elders of Zion, promulgated at zionist congresses between 1897 and 1905.

Zionist leaders defy Congress. Einstein's advice to communists and Oppenheimer's betrayal are marks of insolence and treachery. Both of them were redesignated as heads of the so-called Institute of Advanced Study at Princeton, N.J.

What do they teach in this institute? The Protocols say we will teach our own rule. Is the institute affiliated with the Hillel Foundations in colleges? Is it affiliated with the zionist-communist New School of Social Research in New York City, or with the zionist-Fabian school of economics in London?

The institute is run by a board of trustees including Lewis L. Strauss, head of the Atomic Energy Commission which

controls the A & H bombs, and Edward S. Greenbaum, who testified as the only character witness for Carlo Marzani of the OSS, who was convicted of perjury in denying that he was a communist. Greenbaum was executive director in the office of Secretary of War Robert P. Paterson, who made him a brigadier general. Lessing Rosenwald who ostensibly fights communism but not zionism, is also a trustee as is Senator Lehman.

The zionist plan of government is outlined in the protocols. It is totalitarianism and slavery. Israel Is Quietly Expanding Links With Nations Throughout Africa

JERUSALEM, Aug. 20 — Gradually and quietly, Israel is expanding its economic, military and diplomatic relationships with Africa.

Israeli Army officers are reportedly advising, training and reorganizing armies in several African countries.

New military equipment is being sold. Outmoded Israeli weapons, as well as arms captured from the Palestine Liberation Organization during the war in Lebanon, have been given free of charge to Zaire, which re-established diplomatic ties with Israel in May 1982.

Agricultural experts have set up farms supported by Israeli investment,

and Israeli construction companies building projects across the continent.

These activities, undertaken with little publicity as possible, now link Israel and 22 black African countries, according to one Israeli expert. In the two or three years, officials say, sale of expertise and technology grown enough to make Africa as important a clandestine market for Israeli exports as Iran was before S. Mohammed Riza Pahlevi was overthrown.

4,000 Israelis in Africa

About 4,000 Israelis are at work in Africa, he said, so many that in some countries, Israeli schools have been set up to accommodate the children of technicians, engineers and advisers.

An official listed the only African countries with which Israel has no contact whatever as Angola, Mozambique, Tanzania, Madagascar, Benin, Mali, the Congo and Uganda.

In deference to the political sensitivities of most of the Africans, the Israeli Government and Israeli

It is important to note that almost all the above are members as well of the "Council on Foreign Relations," a private body which is supported with vast funds from different "foundations" and which has been described as the "Secret Government of the United States."

is hard to get is, first to get an idea of how the relationship between the U.S., Russia, China and the other powers are likely to evolve in the years ahead."

At this point in the interview, Kissinger went off-the-record. The author, Pat Anderson, explains: "Kissinger calls for a new world order. . . . The old order is gone he says, and the challenge is to achieve a new world order, to evoke the creativity of a pluralistic world! Kissinger's goal, as he once wrote of Metternich and Castlereagh, is 'stability, not perfection'."

These must have been reassuring words to the devoted liberal readers of the N.Y. Times—since many of them were dubious because of Kissinger's hawklike attitude on the Vietnam War. However, the hard-core Communists and Zionists have no need of assurances about Kissinger's true attitude. Like his predecessor in the White House, Walt Rostow, he frequently participated in the notorious East-West Pugwash meetings organized by industrialist Cyrus Eaton. At these meetings top American political scientists and their Soviet opposite-numbers freely exchange planning ideas on the projected one-world government. Kissinger is a prominent figure in the super-secret, mysterious Bilderberger organization founded in 1908 by the Rothschilds, Kuhns, Loeb's, Schiffs, Warburgs and other international financiers. Later Bernard M. Baruch became prominent in the Bilderbergers. He was study director for the Council on Foreign Relations and in 1956-57 was director of a special studies project for the Rockefeller Brothers Fund, beginning his long association with Nelson Rockefeller. In 1961 he became a consultant to Kennedy's National Security Council.

Kissinger has been a top-level consultant to the Eisenhower, Kennedy and Johnson Administrations. And Kissinger boasts that had the late Bobby Kennedy lived and been elected President he would have been his top foreign affairs adviser! Kissinger is indeed a man of all seasons. "Seen one President, you've seen 'em all," Kissinger wisecracks.

Kissinger's relationship with his colleague Art Burns is somewhat analogous to the duumvirs of the duumvirates of ancient Rome (like Marius and Sulla or Julius Caesar and Marc Anthony). Kissinger presides over U.S. foreign affairs and the Pentagon.

Dr. Burns presides over the national economy as chairman of the Federal Reserve Board and topmost economic adviser to President Nixon. He is the successor of Bernard M. Baruch as the unofficial spokesman for the Jewish international bankers. This is his power basis. He enjoys a public image as a "conservative." Actually he has long been affiliated with Zionists and well known Communist Jews. He is a trustee of the left-wing
