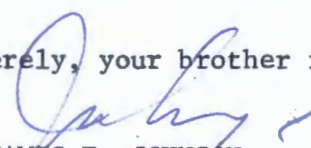

Dear Morton:

Pursuant to our telephone conversation concerning the explanation of the Prayer Amendment and the White House position on the issue, it is respectfully requested that a forthcoming list of religious leaders, many of whom have expressed a lack of knowledge and understanding of the White House position on the Amendment, be allowed to meet with you on the morning of the 4th of June 1982 at 10:00 o'clock for a possible one-hour briefing.

I feel certain that a visit with you would clear up all of the rumors concerning the President's stand on the Prayer Amendment, particularly among some of the Southern Baptists, of which group I am a member.

Pursuant to your instructions I will invite those who have expressed a desire to attend such a meeting. I plan to invite up to 30 concerned leaders if this will meet with your approval. Names and addresses will be furnished, and any other information that you may feel is required, prior to the meeting.

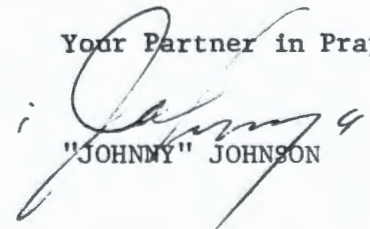

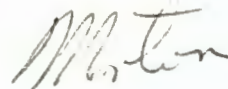

It is respectfully requested that a special or private tour be granted for the Capitol Hill Intercessors of the Nation (Prayer CHAIN) sponsored by the World Fellowship Ministry Foundation, a National Heritage Foundation, on June 4, 1982.

It is our desire to have a tour in the morning, beginning at 8:30, or in the afternoon of June 4. This is the occasion of the organization's Annual 2-day Conference which will be held at the Quality Inn, Pentagon, Crystal City. The Conference will begin Thursday with Registration--Praise and Prayer. Friday daytime we would like to schedule the White House Tour either at 8:30 a.m. or 2:30 p.m., whichever is more convenient for the White House staff.

Please be advised that the participants of this Annual Conference will be traveling from all parts of the United States. The hours requested are the only free periods this group will have to visit the White House while here for the Conference. Five hundred people will be representing all of the States, from the West Coast as far as Hawaii and Alaska. Because of the far distances travelled those who will participate cannot return at any time in the near future to visit the White House. This group is without doubt a most firm and committed group in its Commitment to God and in its support of President Ronald Reagan and the Administration. They are very strong Christians, loving and patriotic people.

We respectfully request that we be allowed to tour the White House on Friday, June 4, 1982, with our entire group of 500 beginning at 8:30--or if that is not possible, at the convenience of the White House staff. Many of these people are those who have been attending annual conferences for many years under the sponsorship of the Full Gospel Business Man's International with no time free to visit "their House" in the Nation's Capital, occupied by its most loved and loving First Couple.
