Dear Mr. President:-

I have asked my publishers, Viking Press, Inc., to send you a copy of my new book "The Hidden Lincoln". I know it is unfair to burden you with asking you to read the book but I do hope that in your spare moments, if you have any, you will be able to turn the pages and let me hear from you in reference to the contents of it. This book is partially based on the unpublished collection of Herndon material of which the late Senator Theodore D. Robinson spoke to you a few months before he passed away, and as I was informed, you told him you were in favor of publishing the entire collection because nothing therein contained could injure the name and fame of Abraham Lincoln.

May I at this time congratulate you on your fine talk at the Jackson dinner and particularly for a paragraph contained in it about Abraham Lincoln and what he would have done with Reconstruction had he lived? Your opinion seems to be the only one which backs up and confirms my opinion that he would have solved the problems of Reconstruction as he did those of the Civil War which were by far the greater. Practically every historian or biographer of any account holds to the other view that he would have failed as Johnson had failed. The last chapter of the first volume of my book "Abraham Lincoln, A New Portrait" demonstrates the fallacy of that position.

Under the form of a commentary on the Pentateuch, it contains a "complete cabalistic theosophy, treating of God, the cosmogony and cosmology of the universe, the soul, sin, redemption, etc."

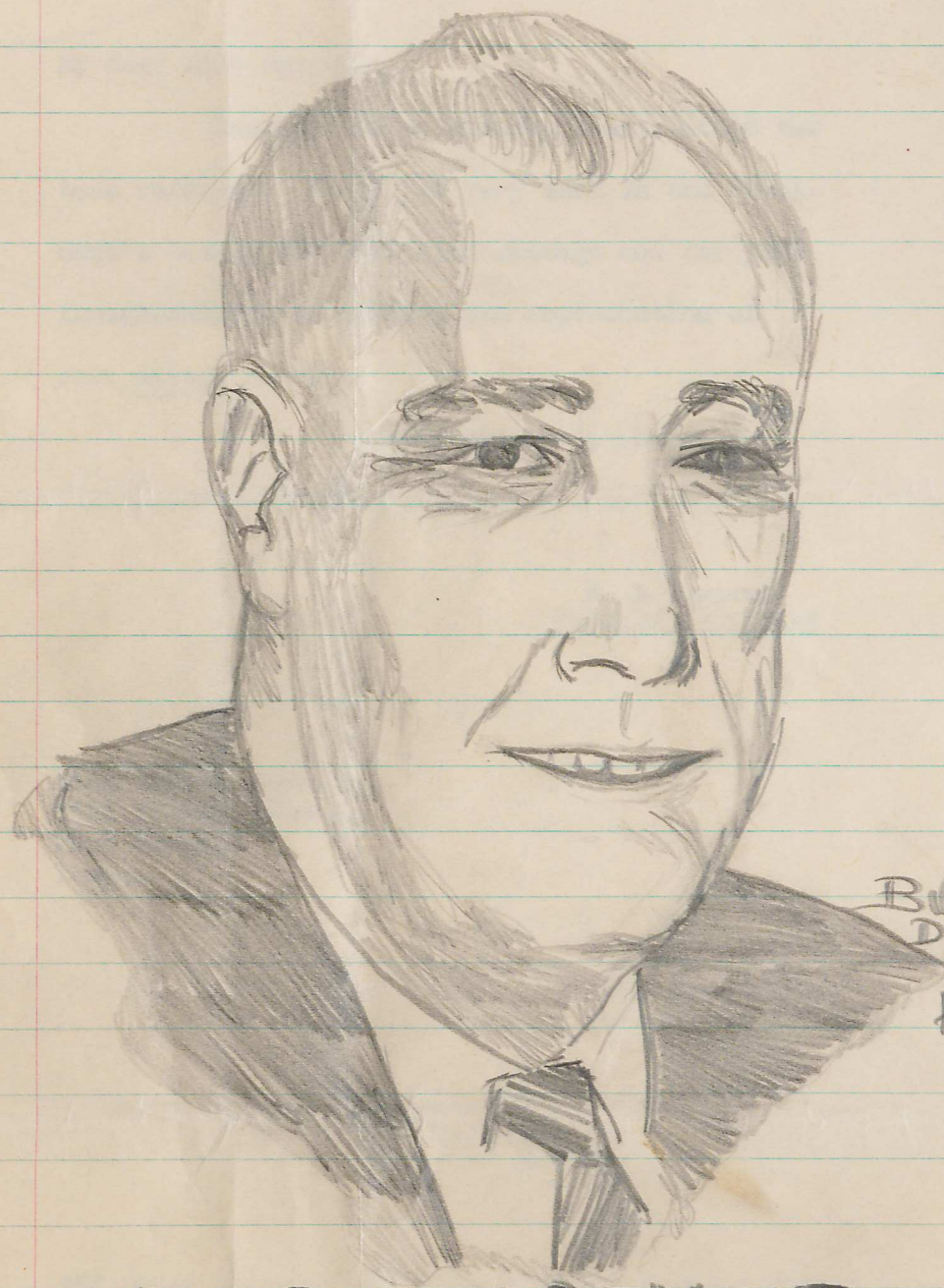

# New Deal Six Years Old Today

(Special to The TIMES)  
Washington, March 4.—President Roosevelt began his sixth year in office today. Notable was the administration atmosphere of unhurried calm as contrasted with the turmoil of national emergencies the President faced at his inauguration in 1933.

Gone were the banking crisis and industrial chaos, which called for speedy enactment of remedial legislation and taxed the energies of congress. Today the senate and house were working steadily on only four major measures: tax revision, naval expansion, wage-hour standards and reorganization of government agencies.

### OBSERVES ANNIVERSARY

The President observed the anniversary by arranging a special service at historic St. John's Episcopal church. He invited cabinet members to join him, just as they did on that bleak morning five years ago, to "humbly ask the blessing of God" in arduous days ahead.

The state department, its eyes anxiously on Europe and the Far East, recognized the anniversary in a memorandum declaring, "Peace is the cornerstone of the foreign policy of the U. S."

### BROUGHT SECURITY

The President looked back on social security laws, farm legislation, bank deposit insurance, Tennessee Valley Authority and other acts written into the records since troublesome days of 1933.

Commenting on proposed legislation to regulate wages and hours, he declared last night at the Labor Department's 25th anniversary dinner:

"Today there is general recognition that there should be a floor to wages and a ceiling to wages."

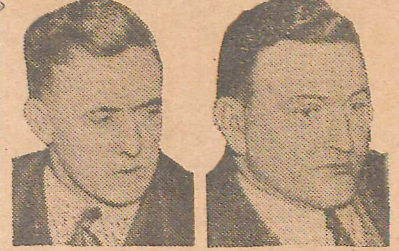

# Continue Detective Thriller, 'The Escape'

Further revelations in the "Annie Oakley arrest" case were expected today with return to Felony court of two Town Hall detectives, accused of turning loose two prisoners accused of robbery.

The detectives, Frank McKune and Earl Flannery, are charged with "giving a pass" to Kenneth Peters and another man known only as "Tip," after the latter pair had been arrested by other policemen for an alleged stickup.

McKune and Flannery, with Peters, were in Felony court yesterday and, over loud protests of their attorneys, heard testimony on the incident made part of the court record.

The detectives' accusers — two brother officers, Harold H. Thompson and Peter Frank—were at the hearing. So was James J. Burke, 69, chauffeur for an alleged bookie, who said he was being detained at gun point by Peter and "Tip" when Thompson and Frank drove up in their squad car.

### FORCED FROM AUTO

After telling how he had been forced from his auto at gun point by two men, one of whom he identified as Peters, Burke said:

"They were frisking me when two uniformed policemen came up with pistols in their hands."

The policemen were Thompson and Frank, he said, and told how they took pistols from the robbers. At this point, Burke testified, two detectives approached on foot. He said the uniformed men, the detectives and the prisoners departed.

Patrolman Thompson took up the story at this point, telling how he

had been hurt stepping from his squad car to make the arrests.

### HAD GUNS, HE SAYS

When the detectives appeared, he said, he turned over his prisoners so he could get medical attention. McKune, he said, asked him:

"Tommy, I know this fellow. How about giving him a pass?" I said," the witness continued, "they had guns and both would have to go to the station."

The detectives left with the prisoners, Thompson said—and that was the last he saw of the two men that night. When he and Frank complained, the detectives were arrested and stripped of their badges.

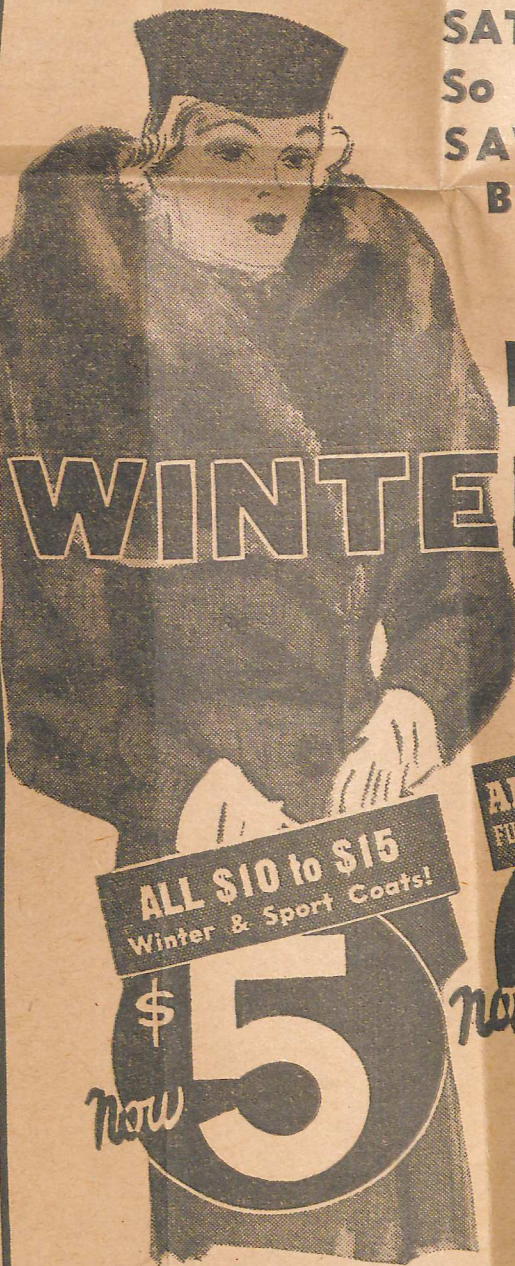
The accused detectives have denied the prisoners had pistols, and no trace of the supposed guns have been seen. Thompson testified, however, he gave two pistols, taken from the arrested men, to McKune and Flannery when they left the scene.

# Death, Privation in Flood Wake; Toll Set at 169

By KAY CAMPBELL  
(TIMES Staff Correspondent)

Los Angeles, March 4.—Down from the bare hills that rise a few miles back from the sea coast, swept today the Four Horsemen of Flood—death, destruction, distress and deprivation.

Flood waters began slowly to ebb, uncovering gradually the full evidence of tragedy and leaving the threat of more woe to come. Toll of dead and missing is estimated at 169.

Worst of the flood seemed to be over today—but millions of persons who occupy the 30,000 square miles of affected land still faced the aftermath. Choked sewers, contaminated water systems, food shortage, power failures all carried threats of worse things to come. Rain which poured down on sunny California steadily for four days and four nights had abated. Waters began to recede, revealing damage which runs into untold millions.

### 20,000 ARE HOMELESS

Life in Los Angeles returned somewhat to normal. There were 20,000 homeless in the state, about

was certain that many of those reported "missing" were dead. Many bodies were swept out to sea on the swirling waters.

### FILM RESORTS HIT

At the swank film stars' resort, Malibu, rain was being served for drinking water. In another famous Hollywood hideout, Palm Springs, there was no electricity and candles were going for \$1 each. Homes there were reported without heat and food supplies were running low. In an effort to get food

stroying more than 20 homes and sweeping several persons to death. The flood wave went on across country from here to join other waters roaring down Carbon canyon. The two streams converged again north of Anaheim, wrecked another settlement. Ten were known dead and many missing here.

### FOOD SALES RESTRICTED

Food sales were restricted in San Bernardino, 60 miles east of Los Angeles. In the town of Indio, a form of martial law was clamped down to conserve food. The chief of police blocked all roads into the town to keep refugees out, explaining there was barely enough food and water to go around.

San Bernardino county—largest in area in the country—was without a bridge today and every road in the county had been washed out or blocked by slides.

A cloudburst in the mile high mountains back of San Bernardino sent a 40-foot wave of water raging down Lytle creek, flooding city streets.

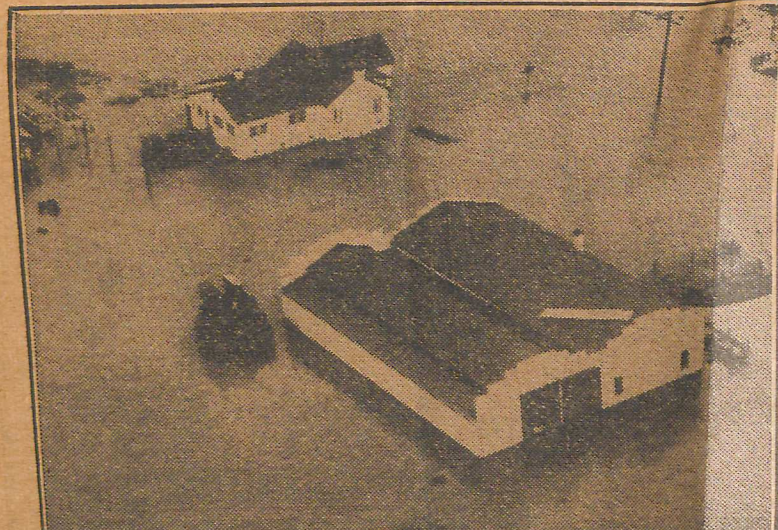

2,00 of whom were in this city area. Red Cross authorities said they would need no outside aid.

Citizens learned today what had caused what officials called the "greatest disaster in Los Angeles' history."

A low pressure area, abnormal here, had caused heavy inundation—11 inches in a few days, the weather bureau reported. This water, sweeping down from mountains 6,000 feet high, rushed through dry, narrow river beds which could not carry the load. The mountains are only 30 miles back from the flooded plain.

Flood waters were affecting alike the lives of poor squatters through the valley and of wealthy luminaries of the film industry.

### DEATH, DISTRESS TOLD

Hour after hour, reports of distress and death poured in. Many communities maintained contact with the outside world only through short wave radio.

The ordinarily dry, sandy country from Ventura on the north to Capistrano on the south, was slowly struggling out from under the muddy waters. Today, in many sections, the sun broke through for the first time in days.

A score of towns were without electricity, some were still half submerged; food was running short; water—for drinking—was scarce.

Through the mass of muck, water, and wreckage, rescue workers struggled, searching for bodies. It

through to Palm Springs, American Airlines readied a plane for flight today.

Ironically, the rivers causing most of the damage are ordinarily dry during most of the year. The raging Los Angeles river—now spread out over an area as wide as a city block is long—seldom carries much water.

But it was rampaging today, carrying before it bridges, roads, and railroad tracks, paralyzing transportation in and out of Los Angeles. Part of this city was in the dark last night when a power plant failed. For several hours yesterday, the city was cut off from the outside world.

### RIVERS RUN BERSERK

The other usually dry river that went berserk was the Santa Ana, which barged wildly through agricultural districts and was responsible for the greatest single tragedy yet reported—drowning of a score of persons in towns of Anaheim and Atwood.

At Atwood, the river broke suddenly through its dikes, crashed down on a Mexican settlement, de-

heavy damage and many stars were stranded on their estates outside the film capital.

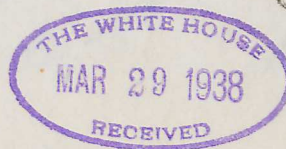

Attached hereto is a book from the pages of which - if you will read it carefully and with an unbiased viewpoint - you will glean some interesting facts; facts which may be helpful to you in the carrying out of your plan "The Greatest Good for the Greatest Number."

"The Right To Live" was written by Mr. Joseph A. Culbert, a Philadelphia attorney, who, unfortunately, passed on just before the book went to press.
