7. Security Bank will not send notifications regarding the expiry of earned electronic vouchers. It is the cardholder's responsibility to track their rewards' expiry dates. Electronic voucher codes can be redeemed within sixty (60) calendar days from the date the SMS is received from Giftaway.
8. All unredeemed electronic vouchers will expire and be deactivated sixty (60) calendar days after you receive the SMS with the code from Giftaway. REDEEM
